Overview:

This project is intended to provide Integrated Natural Resource Management Plan (INRMP) implementation support to U.S. Army Garrison Alaska (USAG Alaska) Directorate of Public Works (DPW) Environmental Division / Planning Branch / Natural Resources Management Section. The Recipient will provide soil, water and vegetation protection and repair, erosion control, vegetation and soil rehabilitation, sensitive area protection and habitat management, forest management, and trail improvements to the impacted military training areas. The improvements will provide optimal management of training lands, to minimize restrictions to the military mission due to natural resource related constraints. The project area is within the Fort Greely and Fort Wainwright, Alaska training lands to include the Donnelly Training Area and Yukon Training Area.

This project implements the installation's INRMP with the objective of providing healthy and resilient environments that are sustainable settings for military training while protecting and enhancing biological diversity and ecological health on all USAG Alaska lands, and to ensure compliance with all environmental laws and regulations. Some of the benefits to the natural resources include ensuring access improvements will not adversely impact existing hydrological connectivity, wetland protection, fish and wildlife habitat enhancement, and prevent damage and rehabilitate soils.

This project will support recreational and forest management activities on USAG-AK managed lands. The intent of this project is to improve recreational trail access, signage, and trail brushing along Donnelly Dome and Birch Hill trails as well as improve access, enhance forest production, and provide forest products to commercial and personal use firewood cutters.

1.0 INTRODUCTION

The purpose of this Statement of Work (SOW) is to provide Integrated Natural Resource Management Plan (INRMP) implementation support details to be performed by the Recipient in support of the U.S. Army Garrison Alaska (USAG-AK) Directorate of Public Works (DPW) Environmental Division / Planning Branch / Natural Resources Management Section through a cooperative agreement between the Recipient and U.S. Army Corps of Engineers (USACE) Alaska District.

1.2 Background

The Sikes Act of 1960 requires that each Department of Defense (DoD) installation create and maintain their own INRMP providing for "natural resource protection, enhancement, and restoration, where necessary for support of fish, wildlife, or plants". *This project meets the requirements of the INRMP and fulfills agency responsibilities for natural resource stewardship.* Additionally, the described project is listed in the 5-year implementation plan of the 2020 USAG Alaska INRMP.

2.0 OBJECTIVES

The primary objective of this project is to assist the USAG-AK with the optimal management of training lands, to minimize restrictions to the military mission due to natural resource related constraints, to protect and enhance biological diversity and ecological health on all USAG-AK lands, and to ensure compliance with all environmental laws and regulations.

Specific objectives that apply to these projects include:

- Protect and enhance wetlands and watersheds
- Repair, revegetate, and enhance training areas
- Protect soil, water, and vegetative resources by preventing or mitigating soil erosion through conservation practices
- Improve water quality and increase long and short-term effectiveness of land use for military training purposes
- Maintain/manage perennial vegetation to support mission requirements and enhance stewardship

- Protect and enhance wildlife habitat
- Improve and enhance natural resource outreach and recreational utilization
- Provide natural resource technical assistance

3.0 MAJOR REQUIREMENTS

Tasks include:

Task 1 – Training Area (TA) 531 Recreational Trail Access Improvement

Task 2 – Donnelly Dome Recreational Trail Access Improvement

Task 3 – Yukon Training Area Forest Products and Production

Optional Task 4 – Forest Health Protection and Timber Stand Improvement

3.1 Task 1 TA 531 Recreational Trail Access Improvement

3.1.1 Project Description

This project shall support recreational management activities on USAG-AK managed lands. The intent of this task is to improve recreational trail access, signage, and trail brushing along Donnelly Training Area TA 531 and Fort Wainwright Main Post Birch Hill trails. This task will only be executed in the base year.

3.1.2 Objective

The objective of this project is to implement best management practices on trails managed for recreational use and military mission support as identified in USAG-AK INRMP. Trail management practices require continued maintenance support on actions conducted during previous years. The USAG-AK Garrison Commander has approved Sikes Act funding to be used for recreational trail improvements at Donnelly Training Area TA 531 and Fort Wainwright Main Post Birch Hill. The trail systems at TA 531 and Birch Hill require vegetation management and signage.

3.1.3 Project Area

The project area is defined as USAG-AK training lands to include the Donnelly Training Area TA 531 and Fort Wainwright Main Post.

3.1.4 Treatment

Vegetation

This project shall conduct general vegetation management using mechanical clearing, hand clearing, chipping, and firewood processing for trail clearing and general improvements. Vegetation management efforts will be focused on approximately two (2) acres of targeted clearing in areas impacted by trail improvement projects as identified by USAG-AK Natural Resource staff.

Signs

This project shall establish up to three (3) informational four (4) foot by four (4) foot signs with associated protective bollards using standard USAG-AK recreational access information. Informational signs shall be in areas identified by USAG-AK Natural Resource staff.

Report

The final report shall map trail areas treated for vegetation management and state the locations of recreational access signs.

3.2 Task 2 Donnelly Dome Recreational Trail Access Improvement 3.2.1 Project Description

This project shall support recreational management activities on USAG-AK managed lands. The intent of this task is to improve recreational trail access, signage, and trail footing along Donnelly Training Area Donnelly Dome and Fort Wainwright Main Post Birch Hill trails.

3.2.2 Objective

The objective of this project is to implement best management practices on trails managed for recreational use and military mission support as identified in USAG-AK INRMP. Trail management practices require continued maintenance support on actions conducted during previous years. The USAG Alaska Garrison Commander has approved Sikes Act funding to be used for recreational trail improvements at Donnelly Training Area TA 531 and Fort Wainwright Main Post Birch Hill. The trail systems at TA 531 and Birch Hill require erosion management and signage.

3.2.3 Project Area

The project area is defined as USAG-AK training lands to include the Donnelly Training Area and Fort Wainwright Main Post.

3.2.4 Treatment

Trail Footing

This project shall conduct general erosion management using mechanical grubbing and hand grubbing for trail clearing and rerouting improvements. Total project trail footing efforts shall be focused on approximately 25,000 linear feet with approximately 5,000 linear feet annually of eroded trails in areas with unstable soils as identified by USAG-AK Natural Resource staff. This is a multi-year project covering approximately 25,000 linear feet total, work will be accomplished in annual increments of approximately 5,000 linear feet.

Signs

This project shall establish up to three (3) informational four (4) foot by four (4) foot signs with associated protective bollards using standard USAG-AK recreational access information. Informational signs will be in areas identified by USAG-AK Natural Resource staff. This is a multi-year project covering up to fifteen (15) informational signs total, work will be accomplished in annual increments of up to three (3) signs.

Report

The final report shall map trail areas treated for erosion control and state the locations of recreational access signs.

3.3 Task 3 Yukon Training Area Forest Products and Production 3.3.1 Project Description

This project shall support forest management activities on USAG-AK managed lands. The intent of this project is to improve access, enhance forest production and provide forest products to commercial and personal use firewood cutters.

3.3.2 Objective

The objective of this project is to implement forest management practices on timber stands managed for firewood production and military mission support as identified in USAG-AK INRMP. Forest management practices require continued maintenance support on actions conducted during previous years. Forest management activities require continued maintenance support on actions conducted during previous years.

3.3.3 Project Area

The project area is defined as USAG-AK training lands to include the Yukon Training Area and Fort Wainwright Main Post.

3.3.4 Treatment

Vegetation

This project shall conduct general vegetation management using mechanical clearing, hand clearing, chipping, and firewood processing for commercial and personal use firewood cutters. Vegetation Management efforts shall be focused on approximately one (1) acre of targeted clearing in areas identified by USAG-AK Natural Resource staff to improvement access to firewood areas. This is a multi-year project covering approximately five (5) acres total, work will be accomplished in annual increments of approximately one (1) acre.

Report

The final report shall map areas treated for vegetation management and document equipment use with before and after treatment photos.

3.4 Optional Task 4 Forest Health Protection and Timber Stand Improvement 3.4.1 Project Description

This project shall support forest management activities on USAG-AK managed lands used by the community and the Army. The intent of this project is to improve and protect the health of the forests on USAG-AK training lands.

3.4.2 Objective

The objective of this project is to protect and improve forest health by implementing forest management practices that reduce the occurrence of insect, disease, invasive species, fire, erosion, and physical damage to forested lands that support forest products production and military mission support as identified in USAG-AK INRMP. Forest health improvement practices require continued maintenance support on actions conducted during previous years.

3.4.3 Project Area

The project area is defined as USAG-AK lands to include Main Post, Yukon, Tanana Flats, Donnelly, Gerstle, and Black Rapids Training Areas.

3.4.4 Treatment

Vegetation

This project shall conduct timber management actions to support forest health utilizing mechanical and chemical vegetation management techniques standardized by the forestry industry. This project will utilize best management practices to protect forested lands as outlined in the State of Alaska's Forest Practices Act and the USAG-AK INRMP.

Timber management efforts shall be focused on approximately two (2) acres of targeted clearing and access improvement in areas identified by USAG-AK Natural Resource staff to improvement forest health. This is a multi-year project covering approximately ten (10) acres total, work will be accomplished in annual increments of approximately two (2) acres.

Report

The final report shall map areas treated for forest health improvement and document equipment use with before and after treatment photos.

Exercise of Optional Task 4 is contingent upon the following: (1) subject to availability of current Fiscal Year funds at the time the option is awarded; and (2) if exercised, must be completed within the performance period stated in paragraph 10.0 Period of Performance. Any option may be exercised within the Period of Performance, at the discretion of the Grants Officer. Inclusion of options does not commit the Government to consider the options or obligate the Government to exercise any such right. If any options are awarded by the Grants Officer, they become a part of the work required by the CA.

4.0 GENERAL REQUIREMENTS

The following requirements are common to all tasks listed in Section 3.0.

4.1 Services

The Recipient shall provide services required for the professional preparation, editing, and printing of reports presenting findings for future USAG-AK planning and consultation purposes. The Recipient shall ensure personnel have developed working relationships with range management personnel and other garrison staff regarding the aspects of this project and in support of the USAG-AK Environmental Office.

4.2 Equipment, Supplies, and Materials

The Recipient shall provide supplies and materials as necessary to accomplish tasks in field and office settings as defined in Section 3.0 to include but not limited to project-specific software, computers / laptops, global positioning system (GPS) units, other field-related technical equipment, and field camp equipment and supplies. Required equipment includes that necessary for safety and communication with Army Range Control—cellular phones, satellite phones, and SPOT or like devices.

4.3 Transportation

The Recipient shall provide vehicles—4x4 trucks/cars, all-terrain vehicles (ATVs), boats, and aircraft (rotary or fixed wing)—as necessary to access remote areas and complete tasks in back country, remote, or other installation settings.

4.4 Travel

The Recipient shall facilitate necessary travel within and outside of Alaska as required to accomplish task requirements and meet with consulting agencies and stakeholders. Recipient personnel shall be required to maintain an agile work schedule as travel to and work in remote training areas may be rescheduled as needed for range management and mission training.

Recipient personnel may be required to travel on government-provided fixed or rotary wing aircraft during the execution of tasks on Fort Wainwright-managed lands. Recipient personnel may utilize General Services Administration (GSA) government or military vehicles, after acquiring the proper training, and if available.

5.0 GOVERNMENT FURNISHED MATERIAL

The Government shall supply access to Army-managed lands as necessary to complete this project. The Government may supply use of GSA government or military vehicles to accomplish tasks defined in Section 3.0, when available and deemed appropriate and after Recipient personnel acquire proper training. The Government may supply use of government-provided fixed or rotary wing aircraft to tasks defined in Section 3.0, when available and deemed appropriate and after Recipient personnel acquire proper training. The Government may provide office space, as available, for accomplishment of tasks and to facilitate on-site work, including providing access to the Government computer system via software and hardware to accomplish this project in the office setting.

6.0 REPORTS, DELIVERABLES, AND SCHEDULE

The Government will review, evaluate, and compare the technical approach documentation received from each applicant to determine the applicant most likely to be successful in delivering results.

Factor 3 Cost

The applicant shall provide a narrative of proposed cost to the Government during the Period of Performance, to include optional periods, as this data must be reviewed and evaluated to aid in determining fairness and reasonableness.
