The Administration for Children and Families (ACF), Family and Youth Services Bureau (FYSB), Family Violence Prevention and Services (FVPSA) Program seeks to award three cooperative agreements under the Family Violence Prevention and Services Act, to establish and maintain three Culturally-Specific Special Interest Resource Centers (CSSIRC) that will enhance intervention and prevention efforts for victims of domestic violence for members of racial and ethnic minority groups: African American, Asian American/Pacific Islander, and Latino/Latina.

The CSSIRC grantees are part of a network of National, Special Issue, Culturally Specific, and Capacity Building Resource Centers providing leadership, training, technical assistance, resources, and support to programs and systems serving victims of domestic violence and their children.

The awards will be cooperative agreements, which is an award instrument used when substantial involvement is anticipated between the awarding office and the grantee during performance of the contemplated project. FYSB will collaborate with the grantee throughout the project period.

I. Program Description

Statutory Authority

The statutory authority for this funding opportunity announcement is Section 310 of the Family Violence Prevention and Services Act, as amended. See 42 U.S.C. § 10410(a)(2)(A)(ii), (b)(2)(E), and (c)(3).

Description

History and Purpose of FVPSA

FVPSA provides the primary federal funding stream dedicated to the support of emergency shelter and supportive services for victims of family violence, domestic violence and dating violence (also known as intimate partner violence or IPV), as well as their dependents.

First authorized as part of the Child Abuse Amendments of 1984 (Pub.L. 98–457), FVPSA became the first federal commitment to creating a pathway to safety for survivors of domestic violence and their children. FVPSA has been amended eight times and was most recently reauthorized in December 2010 for 5 years by the CAPTA Reauthorization Act of 2010 (42 U.S.C. 10401 - 10414).

Since 1984, Congress has continued to make its intent clear that FVPSA funds be used to raise awareness of domestic violence, prevent its occurrence, provide services to victims and their children, and support domestic violence providers to enhance their responses through training and technical assistance.

Specifically, FVPSA's statutory purposes are to:

1. Assist states and Indian tribes in efforts to increase public awareness about and primary and secondary prevention of family violence, domestic violence, and dating violence;
2. Assist states and Indian tribes in efforts to provide immediate shelter and supportive services for victims of family violence, domestic violence, dating violence, and their dependents;
3. Provide for a national domestic violence hotline; and
4. Provide for technical assistance and training relating to family violence, domestic violence, and dating violence programs to states and Indian tribes, local public agencies (including law enforcement agencies; courts, and legal, social service, and health care professionals), nonprofit private organizations (including faith-based and charitable organizations, community-based organizations, and voluntary associations), tribal organizations, and other persons seeking such assistance and training.

FVPSA is administered by the FVPSA program, located in FYSB, a division of the Administration on Children, Youth and Families (ACYF). FYSB administers mandatory FVPSA formula grants to the following: 1) states and territories, 2) tribes, and 3) state domestic violence coalitions. FVPSA grants are awarded to every state and territory, and over 200 tribes. Funds awarded to states, territories, and tribes reach more than 1,600 local public, private, nonprofit, and faith-based organizations and programs demonstrating outcomes in the field of domestic violence services and prevention. These domestic violence programs provide victims of family, domestic, and dating violence, and their children with shelter, safety planning, crisis counseling, information and referral, legal advocacy, and additional support services.

CSSIRC's will be a part of FYSB's Domestic Violence Resource Network (DVRN), a nationwide network composed of National Resource Centers, Special Issues Resource Centers, Culturally Specific Special Issue Resource Centers, and Emerging Issue Capacity Building Centers focused

on the intervention and prevention of family violence, domestic violence, and dating violence. The DVRN will provide information, resources, training, and technical assistance to improve the capacity of individuals, organizations, governmental agencies, local communities, Tribes, and tribal organizations, to prevent family violence, domestic violence, and dating violence, and to provide evidence-based and evidence-informed intervention services. As part of the DVRN, the culturally specific special issue resource centers will work collaboratively to share their national expertise and deliver domestic violence and dating violence related training and technical assistance. While FYSB's culturally specific special issue resource center grant recipients are members of the DVRN, they will maintain independent governance of their own organizations, but will be required to share their expertise with other DVRN members, actively participate in the coordination of technical assistance, attend semi-annual DVRN meetings, and work collaboratively to develop resources as needed.

All DVRN resource centers are expected to conduct their activities in an accessible, linguistically appropriate, culturally responsive, and trauma informed manner and to proactively focus their activities to address racial inequities that exist for survivors of domestic violence, both within victim services and other systems related to the issue areas of the specific resource center.

DVRN resource centers actively work to ensure access to services for Lesbian, Gay, Bisexual, Transgender, Questioning (LGBTQ) and Two-Spirit survivors and their children, and to ensure that no person shall on the basis of actual or perceived gender identity or sexual orientation be excluded from participation in, be denied the benefits of, or be subject to discrimination under, any program or activity funded in whole or in part through FVPSA, in accordance with FVPSA regulations at 45 CFR part 1370 (a) and (c).

Culturally Specific Special Issue Resource Center (CSSIRC) Program Requirements

Through this FOA and in accordance with FVPSA, U.S.C. 10410(a)(2)(A)(ii), (b)(2)(E), and (c)(3), the Secretary shall award grants to eligible entities for three CSSIRCS focused on the prevention and intervention of domestic violence and dating violence in three culturally specific racial/ethnic communities: African American, Asian American/Pacific Islander, and Latino/Latina. Applicants may demonstrate expertise in addressing domestic and dating violence within one of the three aforementioned culturally specific racial/ethnic communities listed. The three grant recipients will be required to provide national leadership on engaging underserved communities and will be required to share their expertise to provide a specific context for domestic violence as it relates to the ethnic, racial, cultural, faith-based, and linguistic diversity of victims of domestic violence and dating violence from traditionally underserved communities.

The three CSSIRCS will be required to pursue the following goals and objectives and to demonstrate their ability to achieve the same in their grant applications and work plans:

1. Deliver state-of-the-art nationwide training and technical assistance to enhance organizational capacity of domestic violence programs; state domestic violence coalitions; FVPSA state administrators; Indian tribal governments; tribal organizations, federal, state and local government agencies; national, statewide, and local community-based organizations; allied professionals; and other key stakeholders to provide culturally relevant, linguistically appropriate and accessible, trauma-informed, survivor-centered domestic violence and dating violence intervention and prevention services accessible to all victims and their children, including services that address lifetime exposure to violence; survivors from Lesbian, Gay, Bisexual, Transgender, Queer/Questioning (LGBTQ) communities; and other historically marginalized and underserved populations;

2. Raise and enhance the visibility of culturally specific domestic violence and dating violence intervention and prevention strategies, prevalence statistics, emerging issues, and special topics through the development and distribution of innovative resources and multi-media and multi-platform public awareness, social media, and marketing campaigns;

Prevention Definitions:

- *Primary Prevention:* Strategies, policies, and programs to stop both first-time perpetration and first-time victimization. Primary prevention is stopping domestic and dating violence before they occur. Primary prevention includes, but is not limited to school-based violence prevention curricula, programs aimed at mitigating the effects on children witnessing domestic or dating violence, community campaigns designed to alter norms and values conducive to domestic or dating violence, worksite prevention programs, and training and education in parenting skills and self-esteem enhancement.
- *Secondary Prevention:* Identifying risk factors or problems that may lead to future family, domestic, or dating violence, and taking the necessary actions to eliminate the risk factors and the potential problem, which may include, but are not limited to, healing services for children and youth who have been exposed to domestic or dating violence, home visiting programs for high-risk families, and screening programs in health care settings.

3. Support service innovation by identifying culturally specific evidence-based and evidence-informed practices for the prevention and intervention of domestic violence and dating violence and assist with the dissemination, promotion, adoption, and adaptation of such practices in the field;

4. Develop and enhance family violence, domestic violence, and dating violence intervention and prevention strategies by fostering culturally specific promising practices development and adaptation throughout the domestic violence field that includes nationwide training and technical assistance and the creation, collection, and dissemination of guidelines, materials, and other relevant resources, such as sample policies, protocols, forms and related procedures;

5. Engage public and private systems and institutions through policy development to create national, statewide, tribal, or local improvements in systemic responses to family violence, domestic violence, and dating violence, such as integrating culturally specific domestic violence policies and practices into home visitation and public housing programs; public health care clinics; school-based dating violence prevention programs; work force development initiatives; and other public welfare programs to enhance accessibility for all victims and their families;

6. Address current and emerging issues related to family violence, domestic violence, and dating violence through the provision of training and technical assistance that is comprehensive and national in scope. This includes service needs of girls/women of color; services for male victims; engaging faith communities; needs of elder victims; needs of LGBTQ victims; the co-occurrence of HIV and domestic violence; human trafficking; family/youth homelessness; family self-sufficiency; social capital; child support; needs of children of all ages who witness violence; maternal health and maternal mortality; trauma-informed support for formerly incarcerated survivors; meeting the needs of survivors with substance use histories; the intersection of intimate partner violence, gun violence, and community violence prevention; and other topics identified as priorities by the program office;

7. Conduct or contribute to research related to family violence, domestic violence, and dating violence prevention or intervention for culturally specific, traditionally underserved victims of domestic violence and dating violence and children exposed to domestic violence;

8. Work collaboratively with national, statewide, and local community-based domestic violence programs; state domestic violence coalitions; FVPSA state administrators, federal, state, and local government agencies; Indian tribal governments; tribal organizations; national, statewide, and local culturally specific organizations; LGBTQ organizations; and other entities involved in assisting survivors of domestic violence and dating violence to identify and respond to emerging issues, technical assistance requests, the adaptation of promising practices, and increasing service demands;

9. Implement periodic needs assessments of the domestic violence field and the culturally specific community to identify unmet training and technical assistance needs, including the identification of unaddressed or under-addressed topic areas and audience;

10. Participate actively in the coordination of nationwide technical assistance and training with the members of the DVRN and work collaboratively to develop resources as needed for the field;

11. Plan conferences, webinars, topical meetings, or major project meetings in consultation with FYSB to ensure participation of FYSB staff and facilitate at least two FYSB-sponsored webinars each budget period;

12. Provide virtual training to a range of audiences and audience sizes, including, but not limited to, securing the necessary technical tools/platforms and ensuring staff or consultant subject matter expertise on adult learning, instructional design, and learning management systems best practices;

13. Assist FYSB with technical and logistical support of grantee meetings and conferences, including providing insight from first-hand knowledge and experience that can inform planning, analysis, and implementation as related to identified training and technical assistance topics; identifying meeting/conference venues; subcontracting with quality presenters; facilitators and consultants; working with stakeholders to develop an agenda, arranging travel; providing onsite support; and following up on conference evaluations; and

14. Plan travel expenses for at least one representative from each CSSIRC grantee organization to participate in two DVRN meetings and one FYSB-sponsored meeting each budget period.

CSSIRC grantees are expected to use their expertise to provide a specific context for domestic violence as it relates to the ethnic, racial, cultural, and linguistic diversity of victims of domestic violence and dating violence from traditionally underserved, culturally specific communities.

CSSIRC grantees are further expected to offer a comprehensive and national scope of training and technical assistance that is trauma-informed, culturally specific, linguistically relevant and responsive to family violence, domestic violence, and dating violence intervention and prevention services.

This technical assistance is also required to include experts and advisors from culturally specific communities, programs and research related to adult and youth victims of domestic violence and dating violence and children who are exposed to domestic violence.

CSSIRC grantees are expected to provide evidence-based and evidence-informed strategies and information that enhance the capacity of individuals, organizations, governmental agencies, and communities to intervene and prevent family violence, domestic violence, and dating violence.

Each CSSIRC grantee has statutory programmatic components and expectations that are required by 42 U.S.C. 10410. These statutory requirements are detailed throughout this announcement and must be addressed by all applicants.

CSSIRC grantees are expected to focus on enhancing the cultural and linguistic relevancy of service delivery; resource use; policy, research, and technical assistance; public awareness and community education; intervention; and prevention initiatives. CSSIRC grantees are expected to enhance prevention and intervention efforts for victims of family violence, domestic violence,

and dating violence who are members of culturally specific, and underserved racial and ethnic communities by building the capacity of domestic violence prevention and intervention programs to provide culturally relevant and linguistically appropriate services and coordinate outreach efforts to diverse communities.

By the end of the grant period, FVPSA-funded grantees are expected to have provided an array of training, expertise, problem-solving strategies and other forms of technical assistance to federal, state, and local governmental agencies; Indian tribes and tribal organizations; state domestic violence service coalitions; FVPSA state administrators; national, statewide, and local community-based organizations including culturally specific organizations and other key stakeholders related to family violence, domestic violence, and dating violence intervention and prevention services for victims of dating violence, domestic violence and their children.

The CSSIRC grantees are expected to offer educational opportunities, conferences, peer-to-peer consultations, webinars, webcasts, e-learning modules, podcasts, and other forms of technical assistance that allow domestic violence programs, state domestic violence coalitions, tribes and tribal organizations, culturally specific community-based organizations, health, and social service agencies to learn from the CSSIRC grantees' expertise regarding family violence, domestic violence, and dating violence intervention and prevention.

Grantees are expected to share their expertise to lead practice improvements as well as organizational capacity building. Grantees are further expected to foster partnerships between organizations that have not traditionally worked together to address family violence, domestic violence, and dating violence, such as public institutions, faith-based organizations, culturally specific organizations, LGBTQ organizations, and community-based organizations. Grantees will lead or contribute to family violence, domestic violence, and dating violence intervention and prevention-related research that could include program evaluation, national research projects, drafting applied research papers, holding focus groups, conducting community assessments, and collaborating with a wide range of individuals and organizations leading domestic violence and dating violence-related research or evaluation.

Grantees are expected to have a communication plan and national dissemination strategy for sharing promising practices, research findings, project outcomes, and resources nationwide. Grant products will be disseminated broadly, including posting on the grantee's website, the FYSB website, the National Resource Center on Domestic Violence (NRC DV) clearinghouse, and other platforms to reach a broad audience of individuals and communities addressing family violence, domestic violence, and dating violence prevention and intervention. CSSIRC grantees are expected to maintain the organizational capacity to implement the project, including relevant subject matter expertise (domestic violence and as needed for proposed projects); research and evaluation capacity; administrative capacity; project management capacity; national resource center leadership; and sufficient staffing to meet project goals and deliverables. Grantees shall maintain clear plans for maintaining organizational capacity and continuity of services during an emergency, disaster, and/or pandemic situations and transition of key project staff.

CSSIRC grantees must ensure that the grant approach, workplans, and deliverables are consistent with a comprehensive approach to advancing equity for all, including people of color and others who have been historically underserved, marginalized, and adversely affected by persistent poverty and inequality. Grantee will provide a comprehensive community equity plan (or other similar documentation within the application) that demonstrates the processes and policies the grantee has in place to ensure the proactive identification of systemic barriers to opportunities and benefits for people of color and other underserved populations and strategic incorporation of

activities to redress such barriers in ongoing workplans. This plan (or other similar documentation within the application) will also address policies and practices that are in place to ensure that the grant staffing plan supports the capacity to address those disparities in an ongoing, strategic, and culturally responsive manner, especially for particular underserved populations with documented history of long-standing significant disparities related to the topic of the grant.

- “Underserved” definition: For purposes of this FOA, “underserved population”, “underserved communities” or “people who have been historically underserved” should be read to be consistent with FVPSA statutory and regulatory definitions (at 42 U.S. Code § 10402 (14) and 45 CFR part 1370.2). For reference, the definition at 45 CFR part 1370.2 is given here: “Underserved populations means populations who face barriers in accessing and using victim services, and includes populations underserved because of geographic location, religion, sexual orientation, gender identity, underserved racial and ethnic populations, and populations underserved because of special needs including language barriers, disabilities, immigration status, and age. Individuals with criminal histories due to victimization and individuals with substance use disorders and mental health issues are also included in this definition. The reference to racial and ethnic populations is primarily directed toward racial and ethnic minority groups (as defined in section 1707(g) of the Public Health Service Act (42 U.S.C. 300(u-6)(g)), which means American Indians (including Alaska Natives, Eskimos, and Aleuts); Asian American; Native Hawaiians and other Pacific Islanders; Blacks and Hispanics. The term “Hispanic” or “Latino” means individuals whose origin is Mexican, Puerto Rican, Cuban, Central or South American, or any other Spanish speaking country. This underserved populations’ definition also includes other population categories determined by the Secretary [of Health and Human Services] or the Secretary’s designee to be underserved.

Grantees must ensure that the grant approach, workplans, and deliverables are consistent with prohibitions on discrimination on the basis of gender identity or sexual orientation and proactively support access and redress barriers for Lesbian, Gay, Bisexual, Transgender, Questioning (LGBTQ) and Two-Spirit survivors and their children and that technical assistance and training is conducted in alignment with FVPSA regulations at 45 CFR part 1370 (a) and (c) requiring ensuring that no person shall on the basis of actual or perceived gender identity or sexual orientation be excluded from participation in, be denied the benefits of, or be subject to discrimination under, any program or activity funded in whole or in part through FVPSA. Grantees must maintain up-to-date expertise on the needs of victims of domestic and dating violence within the identified culturally specific community, including conducting periodic needs assessments of the domestic violence field and special issue area systems in order to identify unmet training and technical assistance needs, including the identification of unaddressed or under-addressed topic areas and audiences. This shall include, but not be limited to, completion of a national needs assessment in the first 6 months of project year 1 and year 4. Finally, as this is a cooperative agreement that will include substantial involvement from the FVPSA Program in FYSB, the applicants must actively partner with the FVPSA program officers in implementing the resource centers' deliverables. Grantees shall plan conferences, meetings, or major project meetings in conjunction with FYSB to allow participation of FYSB staff. Grantees shall plan to develop, review, and discuss a detailed plan for project implementation, a work-plan, a trainings/events schedule, an evaluation schedule, and a plan for

reporting on the outcomes of the project. Applicants will need to plan to partner with FVPSA program officers in the planning, coordination, and implementation of meetings for FVPSA grantees. More information on how FYSB will be involved is included in *Section II. Federal Award Information: Description of ACF's Anticipated Substantial Involvement Under the Cooperative Agreement*.

Applicants must plan travel to participate in at least one FVPSA Program/FYSB meeting per budget period. Grantees must plan to assist FYSB with technical and logistical support of grantee meetings and conferences, including providing insight from first-hand knowledge and experience that can inform planning, analysis, and implementation as related to identified training and technical assistance topics; identifying meeting/conference venues; subcontracting with quality presenters; facilitators and consultants; working with stakeholders to develop an agenda; arranging travel; providing onsite support; and following up on conference evaluations.

Description of ACF's Anticipated Substantial Involvement Under the Cooperative Agreement Award

Applications for continuation grants funded under these awards beyond the 1-year period will be considered in subsequent years on a non-competitive basis, subject to the availability of funds, satisfactory progress of the grantee, review and approval of the project plan submitted in year one, and a determination that continued funding would be in the best interest of the Federal Government.

The grant award will be a cooperative agreement. A cooperative agreement is an award instrument used when substantial involvement is anticipated between the awarding office and the grantee during performance of the contemplated project. FYSB will collaborate with the grantee throughout the project period.

FYSB will provide consultation and will review and approve the work plan for the project, as well as the structure and integrity of the approved project as needed. FYSB will also approve any revisions to the work plan or structure of the approved project during each budget period. Additionally, FYSB will approve significant project activities and changes to project plans.

FYSB will review and approve final drafts of all new or updated materials, articles, major publications, and research reports that are developed or distributed with resources made available under the cooperative agreement.

FYSB will be involved in the development of long-term strategies for the implementation of the project and will participate in major project activities, such as conferences, topical meetings, or major project meetings. As FYSB determines appropriate, FYSB will make changes to the grantee's detailed plan for project implementation including its work plan, trainings/events schedule, and evaluation schedule, in consultation with the grantee.

FYSB will organize periodic consultations, meetings, briefings, teleconferences, webinars, and other forums necessary to review current and planned activities, to share information, and to promote coordination. FYSB will keep the grantee informed about expectations for performance, current FYSB policy, and FYSB's vision for addressing domestic violence and dating violence.

FYSB does not anticipate substantial involvement in the grantee's creation of data collection activities, such as those related to needs assessments, evaluations, and requests for feedback, and grantees are not expected to submit such data collection instruments for program office review and approval. In cases where FYSB is directly involved in the creation of data collection activities under this FOA, data collection will be conducted consistent with the Paperwork Reduction Act (PRA) of 1995, (44 U.S.C. 3501-3521) and display a valid Office of Management and Budget (OMB) control number.

III.1. Eligible Applicants

Faith-based organizations may apply for this award on the same basis as any other organization, as set forth at and, subject to the protections and requirements of this part and 42 U.S.C. 2000bb et seq., the Department will not, in the selection of recipients, discriminate against an organization on the basis of the organization's religious character, affiliation, or exercise.

Applications from individuals (including sole proprietorships) and foreign entities are not eligible and will be disqualified from competitive review and from funding under this announcement. See *Section III.3. Other, Application Disqualification Factors*.

Faith-based and community organizations that meet the eligibility requirements are eligible to receive awards under this funding opportunity announcement.

Point of Contact

In addition to the AOR, a point of contact on matters involving the application must also be identified. The point of contact, known as the Project Director or Principal Investigator, should not be identical to the person identified as the AOR. The point of contact must be available to

answer any questions pertaining to the application.

Application Checklist

Accepted Font Style

Applications must be in Times New Roman (TNR), 12-point font, except for footnotes, which may be TNR 10-point font. Pages that contain blurred text, or text that is too small to read comfortably, will be removed.

English Language

Applications must be submitted in the English language and must be in the terms of United States (U.S.) dollars. Page Limitations

Adherence to FOA Formatting, Font, and Page Limitation Requirements

Applications that fail to adhere to ACF's FOA formatting, font, and page limitation requirements will be adjusted by the removal of page(s) from the application. Pages will be removed before the objective review. The removed page(s) will not be made available to reviewers.

Applications that have more than one scanned page of a document on a single page will have the page(s) removed from the review.

3. Financial Statements (as applicable)
4. Third-Party Agreements/Memoranda of Understanding (MOUs) (as applicable)
5. Letters of Support
6. Required Forms, Certifications, and Assurances
7. Proof of Legal Status
8. Indirect Cost Rate Letter (as applicable)
9. Other Eligibility Documents (as applicable)

Please note again that SFs and OMB-approved forms are not to be count toward the page limit. To the extent possible, please limit the appendix file to one 50-page PDF submission.

Please remember that shorter applications are often easier for reviewers to fully understand and evaluate. FYSB suggests that applicants use headings, subheadings, bullet points, extra spaces, and formatting such as bold or underline to help grant reviewers easily locate each aspect of the grant application and determine that each point has been addressed in the application.

ELECTRONIC APPLICATION SUBMISSION INSTRUCTIONS

Applicants are required to submit their applications electronically unless they have requested and received an exemption that will allow submission in paper format. See *Section IV.2. Application Submission Options* for information about requesting an exemption.

Electronic applications will only be accepted via www.Grants.gov. **ACF will not accept applications submitted via email or via facsimile.**

Approach

Outline a plan of action that describes the scope and detail of how the proposed project will be accomplished. Applicants must account for all functions or activities identified in the application.

Cite potential obstacles and challenges to accomplishing project goals and explain strategies that will be used to address these challenges.

Public Awareness and Resource Development Activities - The plan for required public awareness and resource development activities must include:

1. Creation, collection, and distribution of resources, including promising practices, guidelines, and information clearinghouse materials to the domestic violence field;
2. Development and distribution of comprehensive statistics, fact sheets, and specialized resources addressing a range of family violence, domestic violence, and dating violence intervention and prevention issues, including emerging topics;

3. Development and distribution of materials to support the adaptation of model programs, evidence-based practices, promising practices, and exemplary projects;
4. Development of a national dissemination strategy to share promising practices, outcomes, and resources nationwide using tools that will enhance the accessibility of statistics, fact sheets, and specialized domestic violence and dating violence resources, including content management systems, communities of practice, electronic lists, websites, webinars, and other multi-media multi-platform social media message campaigns;
5. Development of a communication plan for distributing information, products, reports, and other project outputs to the domestic violence and dating violence field, allied partners, and to the public, including a description of the method, volume, and timing of distribution, and;
6. Dissemination of information on FYSB-funded domestic violence hotlines (The Hotline, Strong Hearts Native Hotline, Love is Respect) on materials.

Training and Technical Assistance Activities - Trainings and presentations are pre-scheduled and provide in-depth information on a particular topic or topics; they can be in person, in a targeted geographic area, over the phone, or online. Technical assistance is specific, detailed guidance, and consultative problem solving and can include the following: phone calls or emails on a specific topic; provision of written materials; referrals; review and feedback/comments/advice on materials prepared by individuals or organizations; on-site visits involving intensive assistance, and an exchange of information and resources. The plan for required training and technical assistance activities must include:

1. Delivery of a comprehensive array of nationwide technical assistance and training to expand the capacity of domestic violence programs, state domestic violence coalitions; FVPSA state administrators; Indian tribes; tribal organizations; federal, state, and local government agencies, and national, statewide, and local community-based organizations to provide domestic violence intervention and prevention services that are accessible to all victims of domestic violence, including persons from traditionally underserved, historically marginalized, and LGBTQ communities;
2. Enhancement of domestic violence programs' organizational capacity and accessibility through the provision of innovative and comprehensive educational opportunities, conferences, and peer-to-peer consultations that allow community-based programs to learn from the CSSIRC's expertise;
3. Identification of training and technical assistance needs within the applicant's area of expertise and provision of targeted technical assistance to the domestic violence field based on those needs;
4. Leadership on advocacy, service practice improvements, and capacity building through the provision of comprehensive technical assistance and solution-based strategies to address existing needs, challenges, or emerging issues;
5. Development of emerging training and technical assistance strategies such as organizational capacity building, programmatic accessibility, trauma-informed services, and survivor-centered advocacy that will sustain or enhance existing domestic violence intervention and prevention services, including those that respond to specialized issues, current advocacy challenges, service barriers, and emerging trends;

6. Creation and implementation of evidence-based, evidence-informed, or promising strategies that regularly incorporate input and feedback from people with lived experience as survivors of domestic violence and their children into grant activities at multiple points in the development process; and

7. Coordination of broader technical assistance efforts with the NRCDV, National Indigenous Resource Center (NIRC), SIRC, and others CSSIRCs whenever appropriate and feasible.

Policy Development and System Engagement Activities - The plan for required policy development and system engagement activities must include:

1. Engagement of public and private systems to create national, statewide, tribal, and local improvements in systemic responses to family violence, domestic violence, and dating violence intervention and prevention to minimize barriers for victims of domestic violence and their children who need to access these systems safely;

2. Engagement of public and private systems in conducting needs assessments to address emerging trends, gaps, and accessibility barriers that domestic violence and dating violence victims may encounter when accessing services; and

3. Collaboration with public and private systems to strengthen policies and institutionalize training to improve accessibility and service effectiveness for victims of dating violence, domestic violence and their children.

Research and Evaluation Activities - The plan for required research and evaluation activities must be broad in scope, specifically related to the CSSIRC's area of focus, and must include:

1. Review of available research and national standards to identify gaps and key questions for future research opportunities or projects. The scope of this review may be limited to the specific expertise of the applicant and may include literature reviews, research papers, published reports, and focus groups. Applicants must discuss how they will assess the rigor of research identified (e.g., how will "effectiveness" be operationally defined), and how they will highlight limitations and call attention to future directions for research. Applicants must discuss the state of the research, and the specific research and knowledge areas to which the cooperative agreement's research and knowledge development activities will contribute. Grantees are expected to integrate the results of research into their training and technical assistance and other activities on an ongoing basis.

2. Collaboration with the domestic violence field and other NRCDV, NIRC, SIRC, or CSSIRC applicants to review and understand domestic violence-related lessons learned, evidence-based and promising practices, national standards, and promising practices for addressing emerging issues, needs, gaps, or accessibility challenges;

3. Case studies to assess multidisciplinary partnerships between domestic violence programs and culturally specific, community-based organizations to meet the needs of domestic violence survivors and their children or to improve service accessibility and the documentation of scope of the collaborations, successes, challenges, and outcomes achieved;

4. Collaboration with the domestic violence field and other NRCDV, NIRC, SIRC, or CSSIRC grantees to assess evidence-based practices for their applicability for dating violence and domestic violence victims and their children. Applicants are required to work with the domestic

violence field to assist with the adoption and implementation of evidence-based practices within domestic violence settings; and

5. Development of a plan for national distribution of research or findings that integrates the applicant's area of expertise and shares those findings with the domestic violence field as well as with the general public.

Additionally, each applicant's detailed plan must address its participation in the following activities as they pertain to the proposed CSSIRC:

DVRN Participation and Coordination

1. The NRCDV will serve as the coordinator of the DVRN's technical assistance meetings;
2. DVRN members will work collaboratively to share their national expertise and deliver domestic violence and dating violence related training and technical assistance; and
3. While the NRCDV, NIRC, SIRC, and CSSIRC applicants are members of the DVRN, they will maintain independent governance of their own organizations, but will be required to share their expertise with other DVRN members, actively participate in the coordination of technical assistance, attend semi-annual DVRN meetings, and work collaboratively to develop resources as needed.

Culturally Specific Special Issue Resource Centers

1. Identification of the underserved or diverse community that will be served, the needs to be addressed within the diverse or underserved community, and the culturally relevant/linguistically appropriate programmatic activities that will address those needs;
2. Demonstration of extensive expertise in analyzing the dynamics of domestic violence, culture, victimization, and healing experienced by racial and ethnic minority groups;
3. Development of new technical assistance resources where gaps have been identified to enhance domestic violence and dating violence intervention and prevention efforts for victims of domestic violence and dating violence who are members of racial and ethnic minority groups;
4. Collaboration with community-based activists, domestic violence service providers, domestic violence survivors, practitioners, and researchers to support coordinated outreach efforts to underserved and diverse communities and to examine the lived cultural and linguistic experiences and dynamics of domestic violence, culture, trauma, victimization and healing experienced by racial and ethnic minority groups;
5. Development of a community engagement, education, and outreach strategy to involve traditionally underserved and historically marginalized communities in the creation and implementation of services relevant to the ethnic, racial, cultural, and linguistic diversity, geographic isolation, or oppression of victims of domestic violence and dating violence;
6. Provision of training, technical assistance, policy analysis, and resource development to enhance traditionally underserved and historically marginalized communities' involvement with coordinating community responses to domestic violence and dating violence; and
7. Support for the capacity building of community-based, culturally specific service providers to respond to the diverse and often complex needs of dating violence and domestic violence victims and their children, which include culturally relevant and linguistically appropriate awareness and outreach events.

Project Timeline and Milestones

Provide quantitative monthly or quarterly projections (for the entire project period) of the

accomplishments to be achieved for each function or activity, in such terms as the number of people to be served and the number of activities accomplished. Data may be organized and presented as project tasks and subtasks with their corresponding timelines during the project period. When accomplishments cannot be quantified by activity or function, list them in chronological order to show the schedule of accomplishments and their target dates.

Organizational Capacity

Provide the following information on the applicant organization and, if applicable, on any cooperating partners:

Program Performance Evaluation Plan

Applicants must describe a plan for the program performance evaluation that will contribute to continuous quality improvement. The program performance evaluation must monitor ongoing activities and the progress towards the goals and objectives of the project. Include descriptions of the inputs (e.g., organizational profile, collaborative partners, key staff, budget, and other resources), key activities, and expected outcomes of the funded activities. The plan must explain how the inputs, activities, and outcomes will be measured; how the resulting information will be used to inform improvement of funded activities; and any processes that support the overall data quality of the performance outcomes.

Applicants must describe the organizational systems and processes that will effectively track performance outcomes, including a description of how the organization will collect and manage data (e.g., assign skilled staff, data management software, data integrity, etc.) in a way that allows for accurate and timely reporting of performance outcomes. Applicants must describe any potential obstacles for implementing the program performance evaluation and how those obstacles will be addressed. Applicants must include a timeline for how information from the quality improvement evaluation will be reviewed and applied to the ongoing project.

Logic Model

Applicants must submit a logic model for designing and managing their projects. A logic model is a diagram that presents the conceptual framework for a proposed project and explains the links among program elements. Logic models must target the identified objectives and goals of the grant program. While there are many versions of logic models, for the purposes of this announcement, the logic model may include connections between the following items:

- Inputs (e.g., additional resources, organizational profile, collaborative partner(s), key staff, budget);
- Target population (e.g., the individuals to be served, identified needs);
- Activities, Mechanisms, Processes (e.g., evidence-based practices, best practices, approach, key intervention and evaluation components, continuous quality improvement efforts);
- Outputs (i.e., the immediate and direct results of program activities);
- Outcomes (i.e., the expected short and long-term results the project is designed to achieve, typically described as changes in people or systems), and
- Goals of the project (e.g., overarching objectives, reasons for proposing the project).

Project Sustainability Plan

Applicants must propose a plan for project sustainability after the period of federal funding ends. Recipients are expected to sustain key elements of their grant projects, e.g., strategies or services

and interventions, which have been effective in improving practices and outcomes.

Describe the approach to project sustainability that will be most effective and feasible. Provide a description of key individuals and/or organizations whose support will be required. Address the types of alternative support that will be required to maintain the program. If the proposed project involves key project partners, describe how their cooperation and/or collaboration will be maintained after the end of federal funding.

Protection of Sensitive and/or Confidential Information

Provide a description of how protected personally identifiable information and other information that is considered sensitive, consistent with applicable federal, state, local and tribal laws regarding privacy and obligations of confidentiality, will be collected and safeguarded. The applicant must provide the methods and/or systems that will be used to ensure that confidential and/or sensitive information is properly handled and if applicable, address the process for subrecipient(s) and/or contractors. Also, provide a plan for the disposition of such information at the end of the project period.

Dissemination Plan

Applicants must propose a plan to disseminate reports, products, and/or grant project outputs so that project information is provided to key target audiences. Dissemination plans must include:

- Dissemination goals and objectives;
- Strategies to identify and engage with target audiences;
- Allocation of sufficient staff time and budget for dissemination purposes;
- A preliminary plan to evaluate the extent to which target audiences have received project information and have used it as intended, and
- The timeline for dissemination.

Third-Party Agreements

Third-party agreements include Memoranda of Understanding (MOU) and Letters of Commitment. Letters of Commitment and MOUs must both clearly describe the roles and responsibilities for project activities and the support and/or resources that the third-party (i.e., subrecipient, contractor, or other cooperating entity) is committing. The Letters of Commitment and MOUs must be signed by the person in the third-party organization with the authority to make such commitments on behalf of their organization. General letters of support are **not** considered to be third-party agreements.

Letters of Support

Provide statements from community, public, and/or commercial leaders that support the project proposed for funding. All submissions must be included in the application package. At minimum, each letter of support must identify the individual writing the letter, the organization they represent, the date, and reason(s) for supporting the project.

The Project Budget and Budget Justification

All applicants are required to submit a project budget and budget justification with their application. The project budget is entered on the Budget Information Standard Form, either SF-424A or SF-424C. Applicants are encouraged to review the form instructions in addition to the

guidance in this section. The budget justification consists of a budget narrative and a line-item budget detail that includes detailed calculations for "object class categories" identified on the Budget Information Standard Form. Applicants must indicate the method they are selecting for their indirect cost rate. See Indirect Charges for further information.

Project budget calculations must include estimation methods, quantities, unit costs, and other similar quantitative detail sufficient for the calculation to be duplicated. If cost sharing or matching is a requirement, applicants must include a detailed listing of any funding sources identified in Block 18 of the SF-424 (Application for Federal Assistance). See the table in *Section IV.2*.

Required Forms, Assurances, and Certifications listing the appropriate budget forms to use in this application.

Special Note: *The Departments of Labor, Health and Human Services, and Education, and Related Agencies Appropriations Act, 2021 and Consolidated Appropriations Act, 2021, (Division H, Title II, Sec. 202), limits the salary amount that may be awarded and charged to ACF grants and cooperative agreements. Award funds issued under this announcement may not be used to pay the salary of an individual at a rate in excess of Executive Level II. The Executive Level II salary of the "Rates of Pay for the Executive Schedule" is \$199,300. This amount reflects an individual's base salary exclusive of fringe benefits and any income that an individual may be permitted to earn outside of the duties of the applicant organization. This salary limitation also applies to subawards and subcontracts under an ACF grant or cooperative agreement.*

Provide a budget using the SF-424A and/or SF-424C, as applicable, for each year of the proposed project.

Provide a budget justification, which includes a budget narrative and a line-item detail, for each year of the proposed project. The budget narrative should describe how the categorical costs are derived. Discuss the necessity, reasonableness, and allocation of the proposed costs.

General

Use the following guidelines for preparing the project budget and budget justification. The budget justification includes a budget narrative and a line-item detail. Applications should only include allowable costs in accordance with 45 CFR Part 75 Subpart E.

Personnel

Description: Costs of employee salaries and wages. See 45 CFR § 75.430 for more information on allowable personnel costs. Do not include the personnel costs of consultants, contractors and subrecipients under this category.

Justification: For each position, provide: the name of the individual (if known), their title; time commitment to the project in months; time commitment to the project as a percentage or full-time equivalent; annual salary; grant salary; wage rates; etc. Identify the project director or principal investigator, if known at the time of application.

Fringe Benefits

Description: Costs of employee fringe benefits are allowances and services provided by employers to their employees in addition to regular salaries and wages. For more information on Fringe Benefits please refer to 45 CFR § 75.431. Do not include the fringe benefits of consultants, contractors, and subrecipients.

Typically, fringe benefit amounts are determined by applying a calculated rate for a particular class of employee (full-time or part-time) to the salary and wages requested. Fringe rates are often specified in the approved indirect cost rate agreement. Fringe benefits may be treated as a direct cost or indirect cost in accordance with the applicant's accounting practices. Only fringe benefits as a direct cost should be entered under this category.

Travel

Justification: For each trip show: the total number of travelers; travel destination; duration of trip; per diem; mileage allowances, if privately owned vehicles will be used to travel out of town; and other transportation costs and subsistence allowances. If appropriate for this project, travel costs for key project staff to attend ACF-sponsored workshops/conferences/grantee orientations should be detailed in the budget justification.

Equipment

Description: "Equipment" means an article of nonexpendable, tangible personal property (including information technology systems) having a useful life of more than one year and a per unit acquisition cost that equals or exceeds the lesser of: (a) the capitalization level established by the organization for the financial statement purposes, or (b) \$5,000. (Note: Acquisition cost means the net invoice unit price of an item of equipment, including the cost of any modifications, attachments, accessories, or auxiliary apparatus necessary to make it usable for the purpose for which it is acquired. Ancillary charges, such as taxes, duty, protective in-transit insurance, freight, and installation, shall be included in, or excluded from, acquisition cost in accordance with the organization's regular written accounting practices.) See 45 CFR §75.439 for more information.

Justification: For each type of equipment requested provide: a description of the equipment; the cost per unit; the number of units; the total cost; and a plan for use on the project; as well as use and/or disposition of the equipment after the project ends.

Supplies

Description: Costs of all tangible personal property, other than included under the Equipment category. This includes office and other consumable supplies with a per-unit cost of less than \$5,000. See 45 CFR § 75.453 for more information.

Justification: Specify general categories of supplies and their costs. Show computations and provide other information that supports the amount requested.

Contractual

Description: Cost of all contracts and subawards except for those that belong under other categories such as equipment, supplies, construction, etc. Include third-party evaluation contracts, if applicable, and contract or subawards with secondary recipient organizations (with budget detail), including delegate agencies and specific project(s) and/or businesses to be financed by the applicant. Costs related to individual consultants should be listed on the Other line. Recipients are required to use 45 CFR §§ 75.326-.340 procurement procedures, and subawards are subject to the requirements at 45 CFR §§ 75.351-.353.

Justification: Demonstrate that all procurement transactions will be conducted in a manner to provide, to the maximum extent practical, open, and free competition. Applicants must justify any anticipated procurement action that is expected to be awarded without competition and exceeds the simplified acquisition threshold stated in 48 CFR Subpart 2.1 (when amended accordingly). Recipients may be required to make pre-award review and procurement documents, such as requests for proposals or invitations for bids, independent cost estimates, etc., available to ACF.

Indicate whether the proposed agreement qualifies as a subaward or contract in accordance with 45 CFR § 75.351. Provide the name of the contractor/subrecipient (if known), a description of anticipated services, a justification for why they are necessary, a breakdown of estimated costs, and an explanation of the selection process. Justification: Provide a breakdown of costs, computations, a narrative description, and a justification for each cost under this category.

Indirect Charges

Description: Total amount of indirect costs. This category has one of two methods that an applicant can select. An applicant may only select one.

1. The applicant currently has an indirect cost rate approved by the Department of Health and Human Services (HHS) or another cognizant federal agency.

Justification: An applicant must enclose a copy of the current approved rate agreement. If the applicant is requesting a rate that is less than what is allowed under the program, the authorized representative of the applicant organization must submit a signed acknowledgement that the applicant is accepting a lower rate than allowed. Choosing to charge a lower rate will not be considered during the objective review or award selection process.

2. Per 45 CFR § 75.414(f) Indirect (F&A) costs, "any non-Federal entity [i.e., applicant] that has never received a negotiated indirect cost rate, ... may elect to charge a *de minimis* rate of 10% of modified total direct costs (MTDC) which may be used indefinitely. As described in Section 75.403, costs must be consistently charged as either indirect or direct costs, but may not be double charged or inconsistently charged as both. If chosen, this methodology once elected must be used consistently for all Federal awards until such time as the non-Federal entity chooses to negotiate for a rate, which the non-Federal entity may apply to do at any time."

Justification: This method only applies to applicants that have never received an approved negotiated indirect cost rate from HHS or another cognizant federal agency. Applicants awaiting approval of their indirect cost proposal may request the 10 percent *de minimis* rate. When the applicant chooses this method, costs included in the indirect cost pool must not be charged as direct costs to the grant.

Commitment of Non-Federal Resources

Description: Amounts of non-federal resources that will be used to support the project as identified in Block 18 of the SF-424. This line should be used to indicate required and/or voluntary committed cost sharing or matching, if applicable.

For all federal awards, any shared costs or matching funds and all contributions, including cash and third-party in-kind contributions, must be accepted as part of the recipient's cost sharing or matching when such contributions meet all of the criteria listed in 45 CFR § 75.306.

For awards that require matching or cost sharing by statute, recipients will be held accountable for projected commitments of non-federal resources (at or above the statutory requirement) in their application budgets and budget justifications by budget period, or by project period for fully funded awards. **A recipient's failure to provide the statutorily required matching or cost sharing amount (and any voluntary committed amount in excess) may result in the disallowance of federal funds. For awards that do not require matching or cost sharing by statute, recipients are not expected to provide cost sharing or matching. If an applicant decides to voluntarily contribute non-federal resources towards project costs and the costs are accepted by ACF, the non-federal resources will be included in the approved project budget. The applicant will be held accountable

for all proposed non-federal resources as shown in the Notice of Award (NOA). **A recipient's failure to meet the voluntary amount of non-federal resources that was accepted by ACF as part of the approved project costs and that was identified in the approved budget in the NOA, may result in the disallowance of federal funds. Recipients will be required to report these funds in the Federal Financial Reports.**

Justification: If an applicant is relying on cost share or match from a third-party, then a firm commitment of these resources (letter(s) or other documentation) is required to be submitted with the application. Detailed budget information must be provided for every funding source identified in Item 18. "Estimated Funding (\$)" on the SF-424.

Applicants are required to fully identify and document in their applications the specific costs or contributions they propose in order to meet a matching requirement. Applicants are also required to provide documentation in their applications on the sources of funding or contribution(s). In-kind contributions must be accompanied by a justification of how the stated valuation was determined. Matching or cost sharing must be documented by budget period (or by project period for fully funded awards).

Applications that lack the required supporting documentation will not be disqualified from competitive review; however, it may impact an application's scoring under the evaluation criteria in *Section V.1. Criteria* of this announcement.

The EBiz POC will then log in to Grants.gov and authorize the appropriate roles, which may include the AOR role, thereby giving you permission to complete and submit applications on behalf of your organization. You will be able to submit your application online any time after you have been approved as an AOR.

2. The extent to which the application provides documentation on the state(s), tribe(s), organizations, and/or communities to be impacted and served.
3. The extent to which the applicant supplies a plan for addressing the scope of the problem or problems identified and the types of assistance that are needed, and an assessment of how the proposed project objectives will address the identified areas of need.
4. The extent to which the application demonstrates a clear commitment to expanding the capacity of the domestic violence field and engaging communities as discussed throughout *Section 1. Program Description* and *Section IV.2. The Project Description*.

2. The extent to which the application responds to each aspect of the Approach, including the activities detailed under the Public Awareness and Resource Development Activities, Training and Technical Assistance Activities, Policy Development and Systems Engagement Activities, Research and Evaluation Activities, and Additional Considerations sections as they relate to the CSSIRC and as described in *Section I. Program Description and Section IV.2. The Project Description, Approach*.
3. The extent to which the application describes a plan for how the applicant will ensure that products and activities are appropriately survivor-centered by regularly incorporating input and feedback from people with lived experience as survivors of domestic violence and their children into grant activities at multiple points in the development process.
4. The extent to which the application describes how the proposed project will shape the awareness of the domestic violence field, the general public, and public/private entities with regards to emerging issues and promising family violence, domestic violence, and dating violence prevention and intervention approaches in the culturally specific community to be served as described in *Section I. Program Description and Section IV.2. The Project Description, Approach*.
5. The extent to which the application provides a comprehensive equity plan (or other similar documentation within the application) that demonstrates the processes and policies the grantee will have in place to ensure the proactive identification of systemic barriers to opportunities and benefits for people of color and other underserved populations and strategic incorporation of activities to redress such barriers in ongoing workplans.

2. The extent to which the application responds to each aspect of the expected outcomes as described in *Section I. Program Description*.
3. The extent to which the application demonstrates a sound relationship between planned project activities and intended quantitative and qualitative outcomes and outputs.

EVALUATION

Maximum Points: 10

Applications will be scored according to the following criteria:

1. The extent to which the application describes the frequency of data collection and utilization of needs assessments and program data to make program adjustments. The application should include a description of how the organization will continue to make ongoing program adjustments that will improve performance and a description of data analysis.
2. The extent to which the application describes a feasible plan to evaluate success in achieving the goals set forth in the application.
3. The extent to which the applicant demonstrates a sound plan for conducting internal evaluations related to service provision and programmatic outcomes.
4. The extent to which the applicant demonstrates a sound plan for measuring the effectiveness of any practice change strategies shared with the domestic violence field, as well as measuring how service practices change overtime.

5. The extent to which the applicant demonstrates a sound plan for measuring the broad base of organizations reached or impacted by services, programming, and technical assistance.
6. The extent to which the applicant appropriately discusses how to assess the rigor of research identified (e.g., how will "effectiveness" be operationally defined), and how to highlight limitations and call attention to future directions for research.
7. The extent to which the application accurately discusses the state of the research, and the specific research and knowledge areas to which the cooperative agreement's research and knowledge development activities will contribute.

ORGANIZATIONAL PROFILES

Maximum Points: 30

Applications will be scored according to the following criteria:

1. The extent to which the application demonstrates documented experience in the areas of domestic violence and dating violence prevention and services specifically relevant to racial or ethnic populations and historically marginalized communities as described in *Section I. Program Description and Section IV.2. The Project Description*.
2. The extent to which the applicant's organizational executive leadership and staffing structure is representative of the specific racial, ethnic, underserved, or historically marginalized community the applicant proposes to serve, which also includes having a steering committee that includes representatives from culturally specific communities, community-based organizations, and domestic violence programs that are geographically and culturally diverse as described in *Section I. Program Description and Section IV.2. The Project Description*.
3. The extent to which the application provides a staffing plan that demonstrates sufficient capacity to address, in an ongoing, strategic, and culturally responsive manner, the identified disparities for people of color and others who have been historically underserved, marginalized, and adversely affected by persistent poverty and inequality in an ongoing, strategic, and culturally responsive manner.
4. The extent to which the application provides a staffing plan that describes the educational and professional experience of the proposed staff and consultants, and demonstrates sufficient subject matter expertise for proposed activities.
5. The extent to which the application describes the administrative and organizational structure of the applicant organization, including the management plan, and demonstrates sufficient organizational capacity and staffing for grant administration, program management, national resource center leadership, and research/evaluation.
6. 10. The extent to which the application provides a staffing plan that demonstrates a sound relationship between the proposed responsibilities of program staff and the educational and professional experience required for staff positions through a discussion of position descriptions and resumes or biographical sketches of key staff, including consultants. "Key Staff" are defined as those staff members responsible for direct oversight, management, or implementation of the proposed project.

11. BUDGET AND BUDGET JUSTIFICATION

Maximum Points: 10

For all priority areas, applications will be scored according to the following criteria:

1. The extent to which a detailed line item budget of project costs is included and demonstrates how cost estimates were derived. Detailed calculations must include estimation of methods, quantities, unit costs, and other similar quantitative detail sufficient for the calculation to be duplicated. The budget must include all the information required and described in *Section IV.2. Content and Form of Application Submission*.

2. The extent to which the proposed budget and budget justification are feasible, logical, reasonable, and appropriate for the proposed approach.
3. The extent to which the proposed budget and budget justification are free of errors.
4. The extent to which the application demonstrates how the funds requested are necessary and essential to accomplish the program requirements and expectations as described in *Section I. Program Description*.
5. The extent to which the budget delineates reasonable compensation for project partners.

V.2. Review and Selection Process

No grant award will be made under this announcement on the basis of an incomplete application. No grant award will be made to an applicant or subrecipient that does not have a DUNS number (<http://fedgov.dnb.com/webform>) and an active registration at SAM (www.sam.gov). See *Section IV.3. Initial ACF Screening

Each application will be screened to determine whether it meets any of the disqualification factors described in *Section III.3. Other, Application Disqualification Factors*.

Disqualified applications are considered to be “non-responsive” and are excluded from the competitive review process. Applicants will be notified of a disqualification determination by email or by USPS postal mail within 30 federal business days from the closing date of this FOA.

Objective Review and Results

Applications competing for financial assistance will be reviewed and evaluated by objective review panels using only the criteria described in *Section V.1. Criteria* of this announcement. Each panel is composed of experts with knowledge and experience in the area under review. Generally, review panels include three reviewers and one chairperson.

Results of the competitive objective review are taken into consideration by ACF in the selection of projects for funding; however, objective review scores and rankings are not binding. Scores and rankings are only one element used in the award decision-making process. ACF reserves the right to evaluate applications in the larger context of the overall portfolio by considering geographic distribution of federal funds (e.g., ensuring coverage of states, counties, or service areas) in its pre-award decisions.

ACF may elect not to fund applicants with management or financial problems that would indicate an inability to successfully complete the proposed project. In addition, ACF may elect to not allow a prime recipient to subaward if there is any indication that they are unable to properly monitor and manage subrecipients.

Applications may be funded in whole or in part. Successful applicants may be funded at an amount lower than that requested.
