APS Title: Colombia Alliance Program (CAP)

DESCRIPTION OF AMENDMENT:

The purpose of this amendment is to incorporate a series of cut-off dates in which Concept Papers will be evaluated, to make a correction regarding the page limit of concept papers, and to correct the total amount in sections I D.1 and II A. Changes are made as follows:

1. Under Table of Contents, after **SECTION IV – CONCEPT PAPER PREPARATION GUIDELINES, C. CONCEPT PAPER EVALUATION CRITERIA**, insert, **“D. EVALUATION CUT-OFF DATES FOR CONCEPT PAPERS”**.
2. On Page 15, after **SECTION IV – CONCEPT PAPER PREPARATION GUIDELINES, C. CONCEPT PAPER EVALUATION CRITERIA**, insert:

“D. EVALUATION CUT-OFF DATES FOR CONCEPT PAPERS

The following dates have been established as cut-off dates for rounds of evaluations of concept papers. All concept papers received in each round will be evaluated shortly after the cut-off date and offerors will be notified in writing thereafter if their concept paper/s passed the evaluation. Those that most highly rated will receive instructions on how to submit a full application.

- Round 1: Concept papers received through March 15, 2011.
- Round 2: Concept papers received between March 16 and April 15, 2011.
- Round 3: Concept papers received between April 16 and May 15, 2011.
- Round 4: Concept papers received between May 16 and June 15, 2011.
- Round 5: Concept papers received between June 16 and July 15, 2011.
- Round 6: Concept papers received between July 16 and August 15, 2011.
- Round 7: Concept papers received between August 16 and Sept. 15, 2011.
- Round 8: Concept papers received between Sept. 16 and October 15, 2011.
- Round 9: Concept papers received between Oct. 16 and Nov. 15, 2011
- Round 10: Concept papers received between Nov. 16 and Dec. 15, 2011.

3. On Page 14, under **B. CONCEPT PAPER INSTRUCTIONS**, replace “Concept papers that are not written in English and/or that exceed six pages will not be considered” with “Concept papers that are not written in English and/or that exceed five pages will not be considered.”

4. On Page 8, under **SECTION I – PROGRAM DESCRIPTION , D. AWARD ADMINISTRATION, D.1. Estimate of Funds Available**, replace “\$8,000,000” with “8,500,000.”
5. On Page 10, under **SECTION II: AWARD INFORMATION, A. ESTIMATED FUNDING LEVEL**, replace “\$8,000,000” with “8,500,000.”

Except as provided herein, all terms and conditions of the APS remain unchanged and in full force and effect.
