Overview

The [U.S. Department of Justice](#) (DOJ), [Office of Justice Programs](#) (OJP), [Office for Victims of Crime](#) (OVC) is seeking applications for funding for the Building State Technology Capacity program. This program furthers the Department's mission by awarding funds to Victims of Crime Act (VOCA) Formula Assistance and Compensation Program State Administering Agencies (SAAs) to enhance states' use of technology for the purpose of providing improved service to crime victims.

This solicitation incorporates the [OJP Grant Application Resource Guide](#) by reference. The OJP Grant Application Resource Guide provides guidance to applicants for the preparation and submission to OJP of applications for funding. **If this solicitation expressly modifies any provision in the OJP Grant Application Resource Guide, the applicant is to follow the guidelines in this solicitation as to that provision.**

Other organizations are also eligible to apply for funding when such an application is in partnership with the SAA for the applicant's state.

For purposes of this solicitation, "state" means any state of the United States, the District of Columbia, the Commonwealth of Puerto Rico, the Virgin Islands, Guam, American Samoa, and the Commonwealth of the Northern Mariana Islands.

To advance Executive Order 13929 Safe Policing for Safe Communities, as of October 28, 2020, the Attorney General determined that all state, local, and university or college law enforcement agencies must be certified by an approved independent credentialing body or have started the certification process to be allocated FY 2021 DOJ discretionary grant funding, as either a recipient or a subrecipient. All recipients and subrecipients (including any for-profit organization) must forgo any profit or management fee.

OVC may elect to fund applications submitted under this FY 2021 solicitation in future fiscal years, dependent on, among other considerations, the merit of the applications and on the availability of appropriations.

OVC will consider applications under which two or more entities would carry out the federal award; however, only one

entity may be the applicant. Any others must be proposed as subrecipients (subgrantees). For additional information on subawards, see the [OJP Grant Application Resource Guide](#).

Program Description

Overview

The Department of Justice is committed to advancing work that promotes civil rights, increases access to justice, supports crime victims, protects the public from crime and evolving threats, and builds trust between law enforcement and the community.

This solicitation is seeking applications from Victims of Crime Act (VOCA) Formula Assistance and Compensation Program State Administering Agencies (SAA) to implement statewide technology programs to enhance victims' access to services, foster innovation and efficiency in the provision of services, improve the quality of services, and improve the accessibility and responsiveness of victim service organizations.

Statutory Authority

34 U.S.C. § 20103(c)(1)(A)

Specific Information

The Building State Technology Capacity program serves victims by allowing SAAs to leverage and enhance technology. Victim service providers and VOCA State Administering Agencies need to develop organizational capacity to support their organizations' data collection needs, and support victims of crime in new and innovative ways that protect victims' rights, and enhance their safety and confidentiality.

Goals, Objectives, Deliverables, and Timeline

Goals

The primary goal of this program is to implement statewide technology programs to enhance victims' access to services, foster innovation and efficiency in the provision of services, improve the quality of services, and improve the accessibility and responsiveness of victim service organizations.

Objectives

Successful applicants will achieve this goal through the following objectives:

1. Conduct strategic planning to identify gaps in technology and implement the strategic plan to enhance statewide technological capacities.
2. Implement technological enhancements to improve the state's technological capacity as relevant to victim services.
3. Collaborate with community stakeholders, victim service providers, subrecipient organizations, and other allied professionals on the technology needs of the state.
4. Conduct a comprehensive assessment to evaluate the effectiveness of the program.
5. Perform data collection and participate in evaluation activities to determine if the program is meeting stated goals and objectives.
6. Other objectives as identified by OVC.

Deliverables

The project will produce the following deliverables:

1. Strategic planning that should include, but is not limited to, the following:
 - a. Preparing a statewide needs assessment, which includes stakeholder collaboration, unless the applicant conducted a statewide needs assessment in 2019 or later;
 - b. Developing criteria to best determine strategies and effective collaborative models for planning, implementing, and evaluating the proposed innovations in the state and/or communities;
 - c. Preparing a plan to implement the proposed technological innovations;
 - d. Preparing an assessment plan to measure project effectiveness in achieving the identified outcomes;and
 - e. Letters of intent or Memoranda of Understanding (MOU) with key implementation partners.

- f. Summary report of all strategic planning committee meetings and strategic planning sessions with community stakeholders.
2. A final implementation plan based on the strategic planning process.
3. Execution of the implementation plan, including technological innovations that will improve administration of VOCA programs and victim access to services.
4. Comprehensive assessment of the project, which should include, but is not limited to, an analysis of outputs.
5. Detailed final report that: (1) describes the project goals, challenges, successes, and strategies; (2) includes the implementation plan, any needs assessments, surveys, or other assessment devices completed during the project; and (3) discusses the comprehensive assessment of the project, including output analysis.
6. Other deliverables as identified by OVC.

The Goals, Objectives, and Deliverables are directly related to the performance measures that demonstrate the results of the work completed, as discussed under Application and Submission Information.

In FY 2021, OJP will give priority consideration in award decisions to applications that demonstrate ways in which their projects will advance one or more of these areas.

To receive priority consideration for advancing one or more of the Department's priorities, the applicant must provide a sufficient narrative explanation as an attachment, that specifies how the project will advance the promotion of civil rights, access to justice, support to crime victims, protecting the public from crime and evolving threats, or building trust between law enforcement and the community.

In addition, OJP will give priority consideration, if applicable, to applicants that demonstrate that the individuals who are intended to benefit from the requested grant reside in high-poverty areas or persistent-poverty counties.

To receive priority consideration under the poverty priority, the applicant must provide information to demonstrate that the individuals who are intended to benefit from the requested grant reside in high-poverty areas or persistent poverty counties. For purposes of this priority consideration, the term "high-poverty area" means any census tract with a poverty rate of at least 20 percent as measured by the 2013–2017 5-year data series available from the American Community Survey of the Census Bureau (applicants may search by census tract at <https://www.census.gov/acs/www/data/data-tables-and-tools/narrative-profiles/2017/>) and the term "persistent poverty counties" means any county that has had 20 percent or more of its population living in poverty over the past 30 years, as measured by the 1990 and 2000 decennial censuses and the most recent Small Area Income and Poverty Estimates (applicants may search by county at <https://www.census.gov/data/tables/time-series/dec/census-poverty.html> and at <https://www.census.gov/programs-surveys/saipe.html>).

Priority consideration is one of many factors that OJP considers in making funding decisions and is not a guarantee of an award.

Proposal Abstract

A proposal abstract (no more than 400 words) summarizing the proposed project including primary activities, products and deliverables, the service area, and who will benefit from the proposed project, will be completed in the JustGrants Web-based form.

Proposal Narrative

The proposal narrative should be submitted as an attachment in JustGrants. The attached document should be double-spaced, using a standard 12-point Times New Roman font; have no less than 1-inch margins; and should not exceed 20 pages. Pages should be numbered and submitted as an attachment. If the program narrative fails to comply with these length restrictions, OVC may negatively consider such noncompliance in peer review and in final award decisions.

The following sections must be included as part of the proposal narrative:

a. Description of the Issue

1. Describe the problem to be addressed.
2. Describe the current services and gaps.
3. Describe how funding will alleviate the problem.
4. Describe the technological innovations to be implemented that will address the problem.

b. Project Design and Implementation

The application must provide a clear link between the proposed activities and the need identified in the “Description of the Issue” section above.

This section must:

1. Describe in detail specific activities necessary for accomplishing each goal and objective of the proposed project.

2. Describe the project strategy and discuss how the strategy will address the identified problems and support the goals and objectives. The applicant's strategy or design must include a description of project phases (e.g. strategic planning, implementation, and program assessment), tasks, activities, and staff responsibilities; clear descriptions of interim deliverables and final products. This should include a description of the strategy for developing and implementing a needs assessment to assess technology gaps unless a needs assessment was conducted in 2019 or thereafter.
3. Describe how the applicant will collaborate with subrecipients, victim service providers, survivors, and other stakeholders.
4. Include a time-task plan that clearly identifies objectives, major activities, and products. The time-task plan presented in chart form will not be included as part of the 20-page program narrative limitation. The time task-plan should include the following:
 - a. The strategy, tasks, and timeline for developing technology-based projects that enhance services to victims of crime for the duration of the project period.
 - b. Schedule for completion of activities.
 - c. The submission of quarterly financial and semiannual progress reports. All awardees are required to submit semiannual progress reports and quarterly financial reports.
5. For those states that have already conducted a needs assessment or gap analysis (2019 to present), the application should describe that process and the need for the technology initiative.
6. Describe the development and implementation process over the course of the grant period, which can be from 1 to 3 years.

- a. Capabilities and Competencies

This section must:

1. Identify the key individuals and organizations involved in the proposed project;
2. Demonstrate that the individuals and organizations identified have the capacity to address the stated need, including the expertise necessary to conduct the strategic planning process, collaboration with stakeholders, develop and execute an implementation plan, and successfully implement the proposed project activities;
3. Describe specific roles and responsibilities of all project partners and key staff;
4. Demonstrate the capacity and expertise of the lead applicant and all project partners to implement the project and launch technology innovations;
5. Demonstrate that the applicant and/or its partners have expertise in using technology to implement the project; and
6. Clearly describe who will implement activities as described in the Project Design and Implementation section; and
7. Include descriptions and copies of resumes for proposed key staff positions.

- a. Plan for Collecting the Data Required for this Solicitation's Performance Measures

This section must include the following information:

1. A plan for collecting all of the performance measures data required by this solicitation.

2. A description of the qualifications of the key staff who will be responsible for collecting data and reporting performance measures in JustGrants.

OJP will require each successful applicant to submit regular performance data that demonstrate the results of the work carried out under the award. The performance data directly relate to the goals, objectives, and deliverables identified under “Goals, Objectives, and Deliverables” in the Program Description.

Award recipients will be required to submit performance measure data in the Performance Measurement Tool (PMT) and/or JustGrants. 5. Budget (10%) - evaluate for completeness, cost effectiveness, and allowability (e.g., reasonable, allocable, and necessary for project activities).

b. Other Criteria/Factors
