I. FUNDING OPPORTUNITY DESCRIPTION

A. AGENCY OVERVIEW

The Advanced Research Projects Agency – Energy (ARPA-E), an organization within the Department of Energy (DOE), is chartered by Congress in the America COMPETES Act of 2007 (P.L. 110-69), as amended by the America COMPETES Reauthorization Act of 2010 (P.L. 111-358), as further amended by the Energy Act of 2020 (P.L. 116-260):

- “(A) to enhance the economic and energy security of the United States through the development of energy technologies that—
- (i) reduce imports of energy from foreign sources;
 - (ii) reduce energy-related emissions, including greenhouse gases;
 - (iii) improve the energy efficiency of all economic sectors;
 - (iv) provide transformative solutions to improve the management, clean-up, and disposal of radioactive waste and spent nuclear fuel; and
 - (v) improve the resilience, reliability, and security of infrastructure to produce, deliver, and store energy; and
- (B) to ensure that the United States maintains a technological lead in developing and deploying advanced energy technologies.”

ARPA-E issues this Funding Opportunity Announcement (FOA) under its authorizing statute codified at 42 U.S.C. § 16538. The FOA and any cooperative agreements or grants made under this FOA are subject to 2 C.F.R. Part 200 as supplemented by 2 C.F.R. Part 910.

ARPA-E funds research on, and the development of, transformative science and technology solutions to address the energy and environmental missions of the Department. The agency focuses on technologies that can be meaningfully advanced with a modest investment over a defined period of time in order to catalyze the translation from scientific discovery to early-stage technology. ARPA-E funds transformational research. Existing energy technologies generally progress on established “learning curves” where refinements to a technology and the economies of scale that accrue as manufacturing and distribution develop drive improvements to the cost/performance metric in a gradual fashion. This continual improvement of a technology is important to its increased commercial deployment and is appropriately the focus of the private sector or the applied technology offices within DOE. In contrast, ARPA-E supports transformative research that has the potential to create fundamentally new learning curves. ARPA-E technology projects typically start with cost/performance estimates well above the level of an incumbent technology. Given the high risk inherent in these projects, many will fail to progress, but some may succeed in generating a new learning curve with a projected cost/performance metric that is significantly better than that of the incumbent technology.

ARPA-E funds technology with the potential to be disruptive in the marketplace. The mere creation of a new learning curve does not ensure market penetration. Rather, the ultimate value of a technology is determined by the marketplace, and impactful technologies ultimately become disruptive – that is, they are widely adopted and displace existing technologies from the marketplace or create entirely new markets. ARPA-E understands that definitive proof of market disruption takes time, particularly for energy technologies. Therefore, ARPA-E funds the development of technologies that, if technically successful, have clear disruptive potential, e.g., by demonstrating capability for manufacturing at competitive cost and deployment at scale.

ARPA-E funds applied research and development. The Office of Management and Budget defines “applied research” as an “original investigation undertaken in order to acquire new knowledge...directed primarily towards a specific practical aim or objective” and defines “experimental development” as “creative and systematic work, drawing on knowledge gained from research and practical experience, which is directed at producing new products or processes or improving existing products or processes.”¹ Applicants interested in receiving financial assistance for basic research (defined by the Office of Management and Budget as “experimental or theoretical work undertaken primarily to acquire new knowledge of the underlying foundations of phenomena and observable facts”)² should contact the DOE’s Office of Science (<http://science.energy.gov/>). Office of Science national scientific user facilities (<http://science.energy.gov/user-facilities/>) are open to all researchers, including ARPA-E Applicants and awardees. These facilities provide advanced tools of modern science including accelerators, colliders, supercomputers, light sources and neutron sources, as well as facilities for studying the nanoworld, the environment, and the atmosphere. Projects focused on early-stage R&D for the improvement of technology along defined roadmaps may be more appropriate for support through the DOE applied energy offices including: the Office of Energy Efficiency and Renewable Energy (<http://www.eere.energy.gov/>), the Office of Fossil Energy and Carbon Management (<https://www.energy.gov/fecm/office-fossil-energy-and-carbon-management>), the Office of Nuclear Energy (<http://www.energy.gov/ne/office-nuclear-energy>), and the Office of Electricity (<https://www.energy.gov/oe/office-electricity>).

B. SBIR/STTR PROGRAM OVERVIEW

The Small Business Innovation Research (SBIR) and Small Business Technology Transfer (STTR) programs are Government-wide programs authorized under Section 9 of the Small Business Act (15 U.S.C. § 638). The objectives of the SBIR program are to (1) stimulate technological innovation in the private sector, (2) strengthen the role of Small Business Concerns in meeting Federal R&D needs, (3) increase private sector commercialization of innovations derived from Federal R&D activities, (4) foster and encourage participation by socially and economically

disadvantaged and women-owned Small Business Concerns, and (5) improve the return on investment from Federally funded research and economic benefits to the Nation. The objective of the STTR program is to stimulate cooperative partnerships of ideas and technologies between Small Business Concerns and partnering Research Institutions through Federally funded R&D activities.³

ARPA-E administers a joint SBIR/STTR program in accordance with the Small Business Act and the SBIR and STTR Policy Directive issued by the U.S. Small Business Administration (SBA).⁴ ARPA-E provides SBIR/STTR funding in three phases (Phase I, Phase II, and Phase IIS).

C. PROGRAM OVERVIEW AND BACKGROUND

The Technologies to Emend and Obviate SYnthetic Nitrogen's Toll on Emissions (TEOSYNTE) program aims to lower nitrous oxide (N₂O) emissions from the cultivation of corn and sorghum used for United States ethanol production by 50%. The program will emphasize plant and microbial bio-design strategies that lower the application of synthetic nitrogen (N) fertilizer on corn and sorghum fields while maintaining crop yields and reducing 50% of N₂O emissions. Lowering the requirements of synthetic N fertilizer will also lower costs to farmers, as the cost of fertilizer is a significant portion of the operating expenses of a farm. This program will enable technologies to reduce N fertilizer consumption and N₂O emissions. These technologies will transform agriculture and lower the N₂O contribution to the carbon intensity (CI) of ethanol produced today for light duty vehicles and in the future for sustainable aviation fuel.

Technologies developed under the TEOSYNTE program must achieve specific targets as outlined in Section I.E. in order to meet the program's objectives to reduce greenhouse gas (GHG) emissions and N fertilizer usage over multiple seasons while maintaining crop yields.

1. AGRICULTURE AND GREENHOUSE GAS EMISSIONS

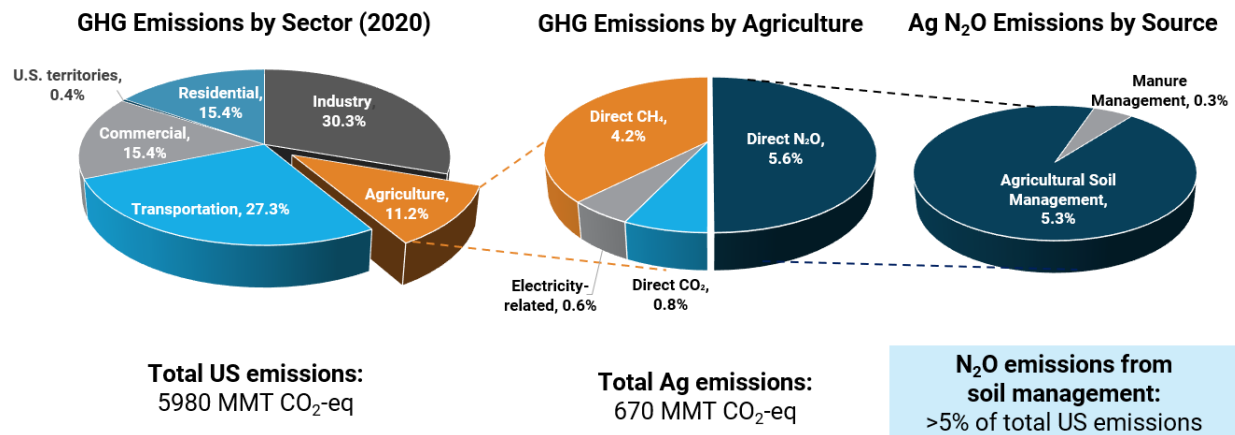


Figure 1. Greenhouse gas emissions (in million metric tons of carbon dioxide equivalent (MMT CO₂-eq)) by agricultural sector and source.^{11,12,13}

Agriculture accounts for 11.2% of total U.S. GHG emissions annually (Figure 1).⁵ Of these emissions, N₂O and methane (CH₄) are the two main contributors, equivalent to 5.6% and 4.2% of total GHG emissions, respectively.^{6,7} N₂O has a greenhouse warming potential 273 times that

of carbon dioxide (CO₂) and persists in the atmosphere for close to 120 years.⁸ Approximately 80% of agricultural emissions of N₂O arise from agricultural soil management (Figure 1), largely attributed to the application of synthetic nitrogen fertilizers, which are converted to N₂O during the microbial soil processes of nitrification and denitrification.⁹ In the U.S., the majority of N₂O emissions arise from the Corn Belt in the Midwest because of the application of N fertilizer.¹⁰

2. NITROGEN FERTILIZER AND BIOETHANOL

Corn and grain sorghum are the two primary feedstocks for ethanol production in the U.S., supporting 95% and 5% of total ethanol production, respectively.^{14,15} The passing of the Energy Policy Act in 2005 and the Energy Independence and Security Act of 2007 established the Renewable Fuel Standard, which mandated that most gasoline be blended with 10-15% ethanol. These changes led to significant expansion of ethanol production, reaching up to 15

billion gallons in 2022.^{16,17} Consequently, ethanol now comprises 75% of total biofuels produced in the U.S., corresponding to 1.1 quads of energy.¹⁸ On the other hand, the cultivation of these two crops consumes approximately 52% of total N fertilizer in the U.S.^{19,20,21} Fertilizer production for corn accounts for 27 MMT CO₂-eq, and fertilizer-driven agricultural soil transformation accounts for 42 MMT to 123 MMT CO₂-eq from direct and indirect N₂O emissions.^{22,23,24,25} Furthermore, internal calculations based on the U.S. Department of Agriculture's (USDA) forecast of cost-of-production showed that the application of N fertilizer to corn and sorghum accounts for 25% of input cost to the grower, or \$11.4 billion in 2022.²⁶

Electrification of the transportation sector may reduce ethanol demand for light-duty vehicles. Despite this, ethanol production may grow, as it is an important intermediate to produce sustainable aviation fuel (SAF). Ethanol-to-jet (ETJ) is the conversion of ethanol to SAF through dehydration to ethylene and catalytic oligomerization.²⁷ ETJ is an important technology to achieve the goals of the SAF Grand Challenge, a presidential call to produce 3 billion gallons of SAF by 2030 and 35 billion gallons of SAF by 2050. The SAF Grand Challenge may enable the removal of the current cap on ethanol production, allowing U.S. farmers to double ethanol

capacity.²⁸ This increase in ethanol demand will result in doubling of N fertilizer application, which can double the current agricultural-based N₂O emissions to between 84 MMT to 246 MMT CO₂-eq, based on the estimate described above.

3. NITROGEN FERTILIZER, N₂O EMISSIONS, AND SOIL NITROGEN CYCLE

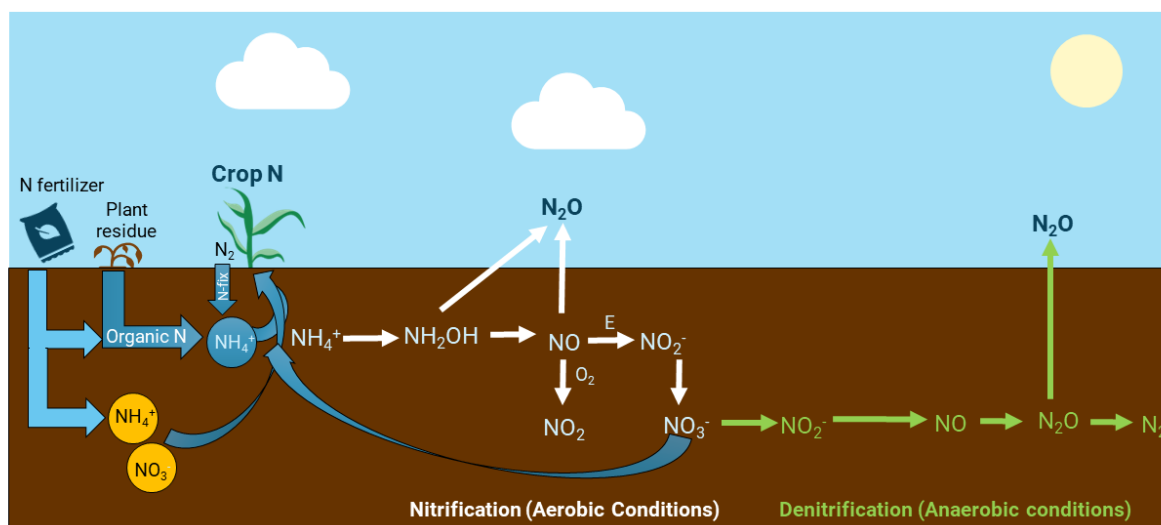


Figure 2. The N cycle for agriculture, which includes natural and anthropogenic inputs of fixed-N. The production of N_2O occurs during nitrification of NH_4^+ and denitrification of NO_3^- .

In the natural nitrogen cycle, the amount of fixed N that enters the soil is in balance with the transformation of N species that return N back to N₂ via the nitrification and denitrification process carried out by the soil microbiome (Figure 2). To meet the high yield demand to support ethanol crop production, synthetic N fertilizer is overapplied to account for plant uptake and loss of N to the environment in the forms of ammonia (NH₃), nitrate (NO₃⁻), nitric oxide (NO), or N₂O.²⁹

The production of N₂O is often linearly correlated with the application of N fertilizer.³⁰ The production of N₂O in the soil N cycle occurs as a byproduct of nitrification of ammonium (NH₄⁺) to NO₃⁻ and as an intermediate in denitrification of NO₃⁻ to N₂ (Figure 2).³¹ N₂O production is highly variable throughout the crop growing season, often occurring after precipitation events that mobilize NH₄⁺ or NO₃⁻ in the soil.³²

4. STATE OF THE ART FOR NITROGEN FERTILIZER AND N_2O REDUCTION

Current approaches to managing N fertilizer and reducing N_2O emissions in biofuel crop production involve three areas: biological nitrogen fixation, nitrogen use efficiency, and chemical nitrification inhibition. The current state of the art of these technological approaches are addressed below, including potential white spaces of interest that ARPA-E has identified. However, the TEOSYNTE program is not limited to these approaches.

Biological Nitrogen Fixation (BNF)

Over the past century, researchers elucidated and defined the physiological, genetic, and molecular mechanisms that enable BNF in free-living diazotrophic bacteria to translate to agricultural applications.^{33,34} Recent commercial efforts have focused on modifying free-living diazotrophs present in the corn rhizosphere and delivering these modified bacteria to corn to fix N_2 for transfer to the plant. However, multiple independent agronomic studies show that efficacy of these modified diazotrophs in delivering fixed N is not consistent in field settings.^{35,36,37} Many hypotheses exist that can be evaluated for improving N_2 fixation for delivery to biofuel crops, including: improving plant-microbe interactions between diazotrophs

and the plant, reducing oxygen sensitivity of nitrogenase through breeding of crops that can provide an oxygen limited micro-environment, delivering increased root exudates to support the growth of the N₂-fixing population, or metabolic balancing of N demand for cell growth and fixed N excretion.^{38,39,40}

Nitrogen Use Efficiency (NUE)

NUE in ethanol crop production has focused on improving yields at high applied N. A study of commercial corn cultivars developed over 50 years showed that yield and NUE have increased in tandem.⁴¹ Average fertilizer application has plateaued at roughly 150 pounds per acre (lb/ac); however, yields have continued to increase, indicating a greater return of yield for a given unit of N.⁴² This paradigm of yield return operates under the expectation that N will remain at today's elevated level. Recent work has shown that modulating plant physiology or architecture may allow for less N to be applied.^{43,44} New cultivars of corn and sorghum will need to be developed that allow for the current and future yield demand but with substantially lower applied N.

Chemical Nitrification Inhibition

Currently, chemical inhibitors are commercially available that prevent nitrification of N fertilizer. These chemical inhibitors prevent NH₄⁺ loss, inhibiting the transformation of NH₄⁺ to NO₃⁻, thereby reducing N₂O emissions by 25-35%.⁴⁵ Despite their commercial availability and efficacy, chemical inhibitors are not popular due to increased costs associated with use.^{45,46}

Having nitrification inhibitors directly produced by crops may bypass this barrier to adoption. Several studies have shown that sorghum produces biological nitrification inhibitors (BNI), and that this trait can be readily bred.⁴⁷ Breeding or engineering high levels of BNI into corn and sorghum may allow for greater adoption of nitrification inhibition at a meaningful scale.

D. PROGRAM VISION AND OBJECTIVES

Reducing N₂O emissions by replacing synthetic N fertilizer with biological approaches will improve the sustainability of ethanol production from corn and sorghum, reducing GHG emissions in agriculture and lowering the CI of both ethanol fuel and ethanol-derived SAF. Therefore, this program will foster biotechnological advances that will achieve the linked goals of reducing both N₂O emissions and the application of synthetic N fertilizer. The technologies funded in this program will focus on redesigning the plants and microbes present in corn and sorghum cultivation to enable this vision.

The objectives of this program are to:

- (1) Reduce imports of foreign synthetic N fertilizer by reducing 27% of the N fertilizer usage in U.S. agriculture;⁴⁸
- (2) Improve efficiency by saving \$6.4 billion in operational cost for U.S. farmers, and reduce CI by 14-23% for ethanol and ethanol-derived SAF;⁴⁹ and
- (3) Remove 37 MMT-78 MMT of CO₂-eq (0.7-1.4% of total U.S. GHGs) emissions from agriculture-derived N₂O and CO₂ generated during N fertilizer production.

Successful completion of this research effort will ensure that the U.S. maintains a technological advantage in the deployment of advanced energy technologies.

ARPA-E seeks proposals that address and develop technologies that can lead to a 50% reduction in N₂O emissions by 2030 compared to the 2005 emissions baseline as targeted by the Biden Administration in 2021.⁵⁰ These technologies will require a minimum reduction of N fertilizer inputs by more than 48% in corn and sorghum cultivation without compromising yield. The program will focus on corn and sorghum as the crops of interest because of their current use in conversion to ethanol and their potential future role in SAF production. For sorghum, the

program will broadly explore cultivars that may be used in current or future ethanol production scenarios, including grain sorghum, sweet sorghum, forage sorghum, and biomass sorghum. The deployment of these technologies in commercial varieties of corn and sorghum is encouraged but not required for the projects in this program. Cover cropping, intercropping systems, and crop rotations that reduce the need for N fertilization of corn or sorghum by the identified metrics will be considered if elements of microbial and/or plant bio-design approaches are included in the proposal.⁵¹ The program will include lab-based experiments, and by the end of the program awardees are expected to show that their technologies are capable of N fertilizer replacement, as measured by yield, and N₂O emissions reduction, as measured by on-field N₂O emissions during at least two field seasons.

E. TECHNICAL CATEGORIES OF INTEREST

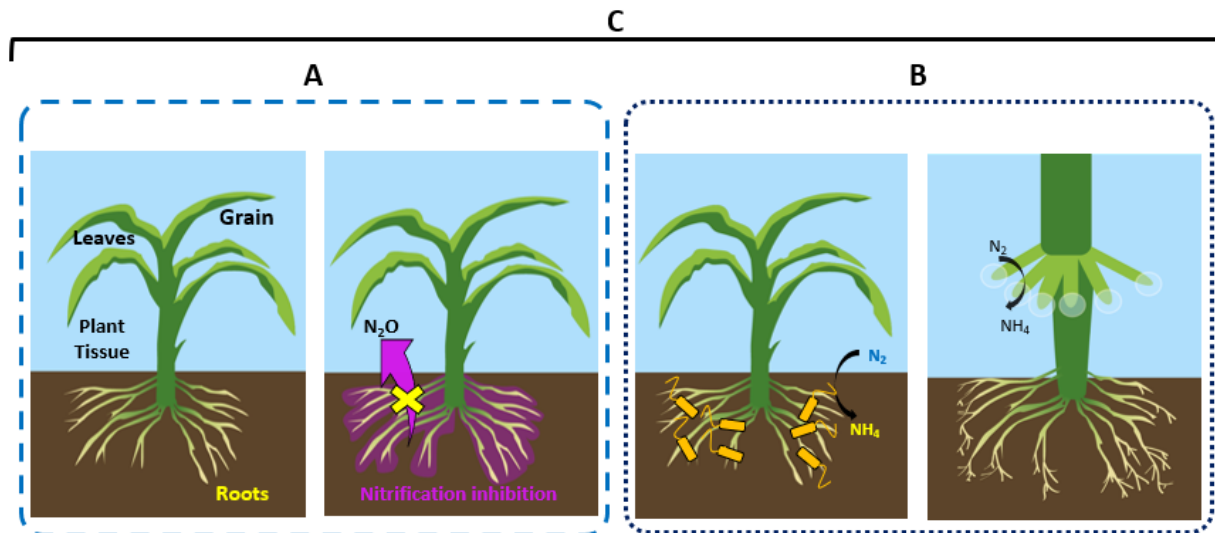


Figure 3. Three specific technical categories of interest of the TEOSYNTE program. Examples within each technical category include: Category A (dashed box) includes plant breeding and genetic engineering approaches to reduce the requirement of applied N or to prevent N loss to the environment; Category B (dotted box) contains microbial approaches to increase the delivery of N to plants; and Category C (bracket) encompasses systemic approaches to facilitate delivery of N by designed interactions between plant and microbe.

The TEOSYNTE program is comprised of three main technical categories of interest (A, B, and C) for a reduction of N application and N₂O emissions reduction, as described below. Other technologies that do not fit in categories A, B, and C may also be considered under a Category D if they include elements of plant and/or microbial bio-design. These technical categories are specifically of interest in their application to corn and sorghum as standalone solutions as described in Category A or Category B, or as a combined set of approaches described in Category C (Figure 3). Broadly, the categories of interest are as follows:

Category A: Crop breeding and genetic engineering approaches that alter plant physiology or plant architecture to reduce the requirement of applied N or to prevent N loss to the environment. Examples of these approaches may include, but are not limited to, improving crop N incorporation to a lower applied N rate, or employing biological nitrification inhibition to lower the amount of applied N and reduce N₂O emissions.

Category B: Microbial approaches to increase the delivery of N to plants. Examples of these approaches may include, but are not limited to, microbial engineering or microbiome design of N₂-fixing endophytic or free-living diazotrophs or utilizing engineered microorganisms, including fungi, to improve soil N mineralization and/or delivery of N to the plant.

Category C: Systemic approaches to facilitate delivery of N by designed interactions between plant and microbe. Proposed projects in Category C may combine the approaches of Categories A and B or focus specifically on the plant-microbe interface. Examples of these approaches may include, but are not limited to, combining plant modifications that improve N uptake with microbial modifications that enhance N delivery, or identifying and enhancing interactions between plant roots and diazotrophic microbes to facilitate the delivery of N.

Category D: Other technologies for coupled N fertilizer reduction and N₂O emissions mitigation that do not fit within Categories A, B, and C, if they include elements of plant and/or microbial bio-design.

F. TECHNICAL PERFORMANCE TARGETS

The TEOSYNTE program requires that all applicants show that their proposed technologies can meet the following performance targets:

- >50% reduction in N₂O emissions relative to unmodified control;
- >48% reduction (sorghum) or >55% reduction (corn) in N fertilizer use;
- Maintenance of ≥100% yield with N fertilizer reduction; and
- Observation of N₂O emissions reduction, N fertilizer reduction, and yield maintenance over two field seasons.

The following describes how the TEOSYNTE program's technical performance targets were determined. The technical target reduction of N₂O emissions (lb/ac) and N fertilizer rate (lb/ac) are based on data collected from the USDA National Agricultural Statistics Service's Agricultural Chemical Use Program as shown below. In cases where specific data are not available, values from the closest year are utilized. The determinations for the technical targets are as follows:

- *>50% reduction in N₂O emissions relative to unmodified control*: The reduction of N₂O is based on the U.S. commitment to lower greenhouse gas emissions by 50% from 2005 levels in 2030.⁵²
- *>48% reduction (sorghum) or >55% reduction (corn) in N fertilizer use*: The intent of this target is to achieve >50% N₂O emissions reduction. The stated reduction in fertilizer accounts for the emission factors correlated with the conversion of N fertilizer to N₂O emissions.^{53,54,55,56,57,58} See footnote for more explanation of how this percent reduction target was assessed.⁵⁹
- *Maintain ≥100% yield relative with N fertilizer reduction*: Maintenance of yield is critical to establish the viability of these technologies for eventual commercial adoption.
- *Show N₂O emissions reduction, N fertilizer reduction and yield maintenance over two field seasons*: Field measurements are critical to determining if the technologies in this program are viable for large-scale field testing leading to eventual commercial adoption.

G. TECHNOLOGY-TO-MARKET

ARPA-E awardees will be required to construct and execute a commercialization plan that is unique to their technology. The preparation of this plan will include conducting comprehensive market analyses, developing and refining business models, formulating an intellectual property strategy, and preparing the appropriate cost and technoeconomic models that validate value propositions to the customer. For example, in reducing N fertilizer application, the technologies resulting from this program would reduce farmer input costs and may reduce other

Achievement of the goal of 50% N₂O emissions reduction for sorghum based on 2003 levels would require an average reduction of 37 lb/ac of fertilizer for sorghum. This reduction is equivalent to 48% compared to current N fertilizer use for sorghum. It is expected that N application rates for projects in this program will be variable depending on the cultivar, field conditions and technology, so the performance metrics are expressed in % less N applied rather than lb/ac.

fertilization-associated operating costs. Proposed technologies should also reduce N₂O emissions, which could generate value for farmers by reducing feedstock CI and enabling biofuels producers to claim lower CI scores. If the targeted fertilizer reductions are achieved for corn and sorghum feedstocks, ARPA-E estimates ethanol CI score reductions of 14% and 23%, respectively.

To support the diffusion and adoption of newly developed technologies, technology commercialization plans should target a 2-3 time economic improvement over the current incumbent technology or practice.⁶⁰ This baseline calculation needs to be established using a nutrient calculator (such as the one linked in the footnotes).⁶¹ The unit of measurement should be contextualized and specified by the applicant; for example, economic improvement in N application cost per acre, return of investment ratio (crop revenue per acre divided by investment), or net return to N.

II. AWARD INFORMATION

A. AWARD OVERVIEW

ARPA-E expects to make approximately \$36 million available for new awards, subject to the availability of appropriated funds. ARPA-E anticipates making approximately 7-9 awards under FOAs DE-FOA-0003408 and DE-FOA-0003405. ARPA-E may, at its discretion, issue one, multiple, or no awards.

ARPA-E will accept only new applications under this FOA. Applicants may not seek renewal or supplementation of their existing awards through this FOA.

ARPA-E plans to fully fund negotiated budgets at the time of award.

Applicants must apply for a Combined Phase I/II Award or a Combined Phase I/II/IIS Award. Combined Phase I/II and I/II/IIS Awards are intended to develop transformational technologies with disruptive commercial potential. Such commercial potential may be evidenced by (1) the likelihood of follow-on funding by private or non-SBIR/STTR sources if the project is successful, or (2) the Small Business Concern's record of successfully commercializing technologies developed under prior SBIR/STTR awards. Phase IIS awards are a "sequential" (i.e., additional) Phase II award, intended to allow the continued development of promising energy technologies. Combined Phase I/II/IIS awards may be funded up to \$4,398,504. Funding amounts will be consistent with the Phase I and Phase II limits posted on the SBA's website.⁶²

ARPA-E reserves the right to select all or part of a proposed project (i.e., only Phase I, or only Phase I and Phase II). In the event that ARPA-E selects Phase I only or Phase I/II only, then the maximum award amount for a Phase I award is \$306,872 and the maximum amount for a Phase I/II award is \$2,352,688.

The period of performance for funding agreements may not exceed 36 months for a Combined Phase I/II/IIS Award. ARPA-E expects to issue funding agreements in April 2025, or as negotiated.

B. RENEWAL AWARDS

At ARPA-E's sole discretion, awards resulting from this FOA may be renewed by adding one or more budget periods, extending the period of performance of the initial award, or issuing a new award. Renewal funding is contingent on: (1) availability of funds appropriated by Congress for the purpose of this program; (2) substantial progress towards meeting the objectives of the approved application; (3) submittal of required reports; (4) compliance with the terms and conditions of the award; (5) ARPA-E approval of a renewal application; and (6) other factors identified by the Agency at the time it solicits a renewal application.

C. ARPA-E FUNDING AGREEMENTS

Through cooperative agreements, other transactions, and similar agreements, ARPA-E provides financial and other support to projects that have the potential to realize ARPA-E's statutory mission. ARPA-E does not use such agreements to acquire property or services for the direct benefit or use of the U.S. Government.

Congress directed ARPA-E to "establish and monitor project milestones, initiate research projects quickly, and just as quickly terminate or restructure projects if such milestones are not achieved."⁶³ Accordingly, ARPA-E has substantial involvement in the direction of every Cooperative Agreement, as described in Section II.C below.

Cooperative Agreements involve the provision of financial or other support to accomplish a public purpose of support or stimulation authorized by Federal statute. Under Cooperative Agreements, the Government and Prime Recipients share responsibility for the direction of projects.

Phase I will be made as a fixed-amount award. Phase II and Phase IIS of Combined Phase I/II/IIS awards will be made on a cost-reimbursement basis.

D. STATEMENT OF SUBSTANTIAL INVOLVEMENT

ARPA-E is substantially involved in the direction of projects from inception to completion. For the purposes of an ARPA-E project, substantial involvement means:

- Project Teams must adhere to ARPA-E's agency-specific and programmatic requirements.
- ARPA-E may intervene at any time in the conduct or performance of work under an

- ARPA-E does not limit its involvement to the administrative requirements of an award. Instead, ARPA-E has substantial involvement in the direction and redirection of the technical aspects of the project as a whole.
- ARPA-E may, at its sole discretion, modify or terminate projects that fail to achieve predetermined Go/No Go decision points or technical milestones and deliverables.
- During award negotiations, ARPA-E Program Directors and Prime Recipients mutually establish an aggressive schedule of quantitative milestones and deliverables that must be met every quarter. In addition, ARPA-E will negotiate and establish “Go/No-Go” milestones for each project. If the Prime Recipient fails to achieve any of the “Go/No-Go” milestones or technical milestones and deliverables as determined by the ARPA-E Contracting Officer, ARPA-E may – at its discretion - renegotiate the statement of project objectives or schedule of technical milestones and deliverables for the project. In the alternative, ARPA-E may suspend or terminate the award in accordance with 2 C.F.R. §§ 200.339 – 200.343.
- ARPA-E may provide guidance and/or assistance to the Prime Recipient to accelerate the commercialization of ARPA-E-funded technologies. Guidance and assistance provided by ARPA-E may include coordination with other Government agencies and nonprofits⁶⁴ to provide mentoring and networking opportunities for Prime Recipients. ARPA-E may also organize and sponsor events to educate Prime Recipients about key barriers to the commercialization of their ARPA-E-funded technologies. In addition, ARPA-E may establish collaborations with private and public entities to provide continued support for the development and commercialization of ARPA-E-funded technologies.

A. ELIGIBLE APPLICANTS

1. SBIR ELIGIBILITY

A Small Business Concern⁶⁵ may apply as a Standalone Applicant⁶⁶ or as the lead organization for a Project Team.⁶⁷ If applying as the lead organization, the Small Business Concern must perform at least 66.7% of the work in Phase I and at least 50% of the work in Phase II and Phase IIS, as measured by the Total Project Cost.⁶⁸

2. STTR ELIGIBILITY

Only a Small Business Concern may apply as the lead organization for a Project Team. The Small Business Concern must perform at least 40% of the work in Phase I, Phase II, and/or Phase IIS, as measured by the Total Project Cost. A single Research Institution must perform at least 30% of the work in Phase I, Phase II, and/or Phase IIS, as measured by the Total Project Cost. Please

3. JOINT SBIR AND STTR ELIGIBILITY

An Applicant that meets both the SBIR and STTR eligibility criteria above may request both SBIR and STTR funding if:

- The Small Business Concern is partnered with a Research Institution;
- The Small Business Concern performs at least 66.7% of the work in Phase I and at least 50% of the work in Phase II and/or Phase IIS (as applicable), as measured by the Total Project Cost;
- The partnering Research Institution performs 30-33.3% of the work in Phase I and 30-50% of the work in Phase II and/or Phase IIS (as applicable), as measured by the Total Project Cost; and
- The Principal Investigator (PI) is employed by the Small Business Concern. If the PI is employed by the Research Institution, submissions will be considered only under the STTR program.

B. ELIGIBLE SUBRECIPIENTS

1. RESEARCH INSTITUTIONS

A Research Institution⁶⁹ may apply only as a member of a Project Team (i.e., as a Subrecipient to a Small Business Concern). In STTR projects, a single Research Institution must perform at least 30%, but no more than 60%, of the work under the award in Phase I, Phase II, and/or Phase IIS (as applicable), as measured by the Total Project Cost.

2. OTHER PROJECT TEAM MEMBERS

The following entities are eligible to apply for SBIR/STTR funding as a member of a Project Team (i.e., as a Subrecipient to a Small Business Concern):

- For-profit entities, including Small Business Concerns

In SBIR projects, Project Team members other than the lead organization, including but not limited to Research Institutions, may collectively perform no more than 33.3% of the work under the award in Phase I and no more than 50% of the work under the award in Phase II and/or Phase IIS. This includes efforts performed by Research Institutions.

In STTR projects, Project Team members (other than the lead organization and the partnering Research Institution) may collectively perform no more than 30% of work under the award in Phase I, Phase II, and/or Phase IIS.

C. ELIGIBLE PRINCIPAL INVESTIGATORS

1. SBIR

For the duration of the award, the PI for the proposed project (or, if multiple PIs, at least one PI) must be employed by, and perform more than 50% of his or her work for, the Prime Recipient. The Contracting Officer may waive this requirement or approve the substitution of the PI after consultation with the ARPA-E SBIR/STTR Program Director.

For projects with multiple PIs, at least one PI must meet the primary employment requirement. That PI will serve as the contact PI for the Project Team.

2. STTR

For the duration of the award, the PI for the proposed project (or, if multiple PIs, at least one PI) must be employed by, and perform more than 50% his or her work for, the Prime Recipient or the partnering Research Institution. The Contracting Officer may waive this requirement or approve the substitution of the PI after consultation with the ARPA-E SBIR/STTR Program Director.

For projects with multiple PIs, at least one PI must meet the primary employment requirement. That PI will serve as the contact PI for the Project Team.

D. ELIGIBILITY OF PRIOR SBIR AND STTR Awardees: SBA Benchmarks on Progress Towards Commercialization

Applicants awarded multiple prior SBIR or STTR awards must meet DOE's benchmark requirements for progress towards commercialization before ARPA-E may issue a new Phase I award. For purposes of this requirement, Applicants are assessed using their prior Phase I and Phase II SBIR and STTR awards across all SBIR agencies. If an awardee fails to meet either of the benchmarks, that awardee is not eligible for an SBIR or STTR Phase I award and any Phase II award for a period of one year from the time of the determination.

ARPA-E applies two benchmark rates addressing an Applicant's progress towards commercialization: (1) the DOE Phase II Transition Rate Benchmark and (2) the SBA Commercialization Rate Benchmark:

- The DOE Phase II Transition Rate Benchmark sets the minimum required number of Phase II awards the Applicant must have received for a given number of Phase I awards received during the specified period. **This Transition Rate Benchmark applies only to Phase I Applicants that have received more than 20 Phase I awards during the last five (5) year period, excluding the most recently completed fiscal year.** DOE's Phase II Transition Rate Benchmark requires that 25% of all Phase I awards received over the past five years transition to Phase II awards.

The SBIR/STTR Phase II transition rates and commercialization rates are calculated using the data in the SBA's TechNet database. For the purpose of these benchmark requirements, awardee firms are assessed once a year, on June 1st, using their prior SBIR and STTR awards across all agencies. SBA makes this tabulation of awardee transition rates and commercialization rates available to all federal agencies. ARPA-E uses this tabulation to determine which companies do not meet the DOE benchmark rates and are, therefore, ineligible to receive new Phase I awards.

- The Commercialization Rate Benchmark sets the minimum Phase III⁷² commercialization results that an Applicant must have achieved from work it performed under prior Phase II awards (i.e., this measures an Applicant's progress from Phase II or Phase IIS to Phase III awards). **This benchmark requirement applies only to Applicants that have received more than 15 Phase II awards during the last 10 fiscal years, excluding the two most recently completed fiscal years.**

The current Commercialization Benchmark requirement, agreed upon and established by all 11 SBIR agencies, is that the Applicants must have received, to date, an average of at least \$100,000 of sales and/or investments per Phase II award received, or have received a number of patents resulting from the relevant SBIR/STTR work equal to or greater than 15% of the number of Phase II awards received during the period.

- On June 1 of each year, SBIR/STTR awardees registered on SBIR.gov are assessed to determine if they meet the Phase II Transition Rate Benchmark requirement. (At this time, SBA is not identifying companies that fail to meet the Commercialization Rate Benchmark requirement). Companies that fail to meet the Phase II Transition Rate Benchmark as of June 1 of a given year will not be eligible to apply to an SBIR/STTR FOA for the following year. For example, if SBA determined on June 1, 2017, that a small business failed to meet the Phase II Transition Rate Benchmark requirement, that small business would not be eligible to apply to an ARPA-E SBIR/STTR FOA from June 1, 2017, to May 31, 2018.

E. COST SHARING

Cost sharing is not required for this FOA.

1. COMPLIANT CRITERIA

Concept Papers are deemed compliant if:

A Concept Paper is incomplete if it does not include required information. ARPA-E will not extend the submission deadline for Applicants that fail to submit required information and documents due to server/connection congestion.

Full Applications are deemed compliant if:

- The Applicant submitted a compliant and responsive Concept Paper;

Replies to Reviewer Comments are deemed compliant if:

- The Applicant successfully uploads its response to ARPA-E eXCHANGE by the deadline stated in the FOA; and
- The Replies to Reviewer Comments comply with the content and form requirements of Section IV.E of the FOA.

ARPA-E will not review or consider noncompliant Replies to Reviewer Comments, including Replies submitted through other means and Replies submitted after the applicable deadline. ARPA-E will not extend the submission deadline for Applicants that fail to submit required information due to server/connection congestion. ARPA-E will review and consider each compliant and responsive Full Application, even if no Reply is submitted or if the Reply is found to be noncompliant.

2. RESPONSIVENESS CRITERIA

ARPA-E performs a preliminary technical review of Concept Papers and Full Applications. The following types of submissions may be deemed nonresponsive and may not be reviewed or considered:

- Submissions that fall outside the technical parameters specified in this FOA.
- Submissions that have been submitted in response to currently issued ARPA-E FOAs.
- Submissions that are not scientifically distinct from applications submitted in response to currently issued ARPA-E FOAs.
- Submissions for basic research aimed solely at discovery and/or fundamental knowledge generation.
- Submissions for large-scale demonstration projects of existing technologies.
- Submissions for proposed technologies that represent incremental improvements to existing technologies.

- Technologies to perform N₂ fixation *in planta*
- Testing of new N management approaches that do not involve plant and/or microbial bio-design
- Development or testing of exclusively agronomic practices that can reduce N application
- Technologies that exclusively reduce N₂O emissions
- Development of measurement and verification devices or methodologies

4. LIMITATION ON NUMBER OF SUBMISSIONS

ARPA-E is not limiting the number of submissions from Applicants. Applicants may submit more than one application to this FOA, provided that each application is scientifically distinct.

Small business Applicants that qualify as a “Small Business Concern” may apply to only one of the two ARPA-E TEOSYNTE FOAs: DE-FOA-0003408 (TEOSYNTE SBIR/STTR), or DE-FOA-0003405 (TEOSYNTE). Small businesses that qualify as “Small Business Concerns” are strongly encouraged to apply under the former (SBIR/STTR FOA). ARPA-E will encourage a subset of Applicants to submit Full Applications. Other Applicants will be discouraged from submitting a Full Application in order to save them the time and expense of preparing an application submission that is unlikely to be selected for award negotiations. By discouraging the submission of a Full Application, ARPA-E intends to convey its lack of programmatic interest in the proposed project. Such assessments do not necessarily reflect judgments on the merits of the proposed project. Unsuccessful Applicants should continue to submit innovative ideas and concepts to future FOAs.

1. ALLOWABLE COSTS

All expenditures must be allowable, allocable, and reasonable in accordance with the applicable Federal cost principles. Pursuant to 2 C.F.R. § 910.352, the cost principles in the Federal

2. PRE-AWARD COSTS

ARPA-E will not reimburse any pre-award costs incurred by Applicants before they are selected for award negotiations. Please refer to Section VI.A of the FOA for guidance on award notices.

Upon selection for award negotiations, Applicants may incur pre-award costs at their own risk, consistent with the requirements in 2 C.F.R. Part 200, as modified by 2 C.F.R. 3. PATENT COSTS

For Subject Inventions disclosed to DOE under an award, ARPA-E will reimburse the Prime Recipient – in addition to allowable costs associated with Subject Invention disclosures - up to \$30,000 of expenditures for filing and prosecution of United States patent applications, including international applications (PCT application) submitted to the United States Patent and Trademark Office (USPTO).

The Prime Recipient may request a waiver of the \$30,000 cap. Note that, patent costs are considered to be Technology Transfer & Outreach (TT&O) costs (see Section IV.G.8 of the FOA below) and should be requested as such.

4. CONSTRUCTION

ARPA-E generally does not fund projects that involve major construction. Recipients are required to obtain written authorization from the Contracting Officer before incurring any major construction costs.

ARPA-E requires all work under ARPA-E funding agreements to be performed in the United States – i.e., Prime Recipients must expend 100% of the Total Project Cost in the United States. 7. PURCHASE OF NEW EQUIPMENT

All equipment purchased under ARPA-E funding agreements must be made or manufactured in the United States, to the maximum extent practicable. This requirement does not apply to used or leased equipment. The Prime Recipients are required to notify the ARPA-E Contracting Officer reasonably in advance of purchasing any equipment that is not made or manufactured in the United States with a total acquisition cost of \$250,000 or more. Purchases of foreign equipment with a total acquisition cost of \$1,000,000 or more require the approval of the Head of Contracting Activity (HCA). The ARPA-E Contracting Officer will provide consent to purchase or reject within 30 calendar days of receipt of the Recipient's notification.

8. TECHNOLOGY TRANSFER AND OUTREACH

ARPA-E is required to contribute a percentage of appropriated funds to Technology Transfer and Outreach (TT&O) activities. In order to meet this mandate, every Project Team must spend at least 5% of the Federal funding provided by ARPA-E on TT&O activities to promote and further the development and eventual deployment of ARPA-E-funded technologies. Project Teams must also seek a waiver from ARPA-E to spend less than the minimum 5% TT&O expenditure requirement.

- An employee of a Member of Congress.

10. CONFERENCE SPENDING

Prime Recipients and Subrecipients may not use any Federal funds to:

- Defray the cost to the United States Government of a conference held by any Executive branch department, agency, board, commission, or office which is not directly and programmatically related to the purpose for which their ARPA-E award is made and for which the cost to the United States Government is more than \$20,000; or
- To circumvent the required notification by the head of any such Executive Branch department, agency, board, commission, or office to the Inspector General (or senior ethics official for any entity without an Inspector General), of the date, location, and number of employees attending such a conference.

11. INDEPENDENT RESEARCH AND DEVELOPMENT COSTS

ARPA-E does not fund Independent Research and Development (IR&D) as part of an indirect cost rate under its Grants and Cooperative Agreements. IR&D, as defined at FAR 31.205-18(a), includes cost of effort that is not sponsored by an assistance agreement or required in performance of a contract, and that consists of projects falling within the four following areas: (i) basic research, (ii) applied research, (iii) development, and (iv) systems and other concept formulation studies.

ARPA-E's goals are to enhance the economic and energy security of the United States through the development of energy technologies and ensure that the United States maintains a technological lead in developing and deploying advanced energy technologies. ARPA-E accomplishes these goals by providing financial assistance for energy technology projects and has well recognized and established procedures for supporting research through competitive financial assistance awards based on merit review of proposed projects. Reimbursement for independent research and development costs through the indirect cost mechanism could circumvent this competitive process.

To ensure that all projects receive similar and equal consideration, eligible organizations may compete for direct funding of independent research projects they consider worthy of support by submitting proposals for those projects to ARPA-E. Since proposals for these projects may be submitted for direct funding, costs for independent research and development projects are not allowable as indirect costs under ARPA-E awards. IR&D costs, however, would still be included in the direct cost base that is used to calculate the indirect rate so as to ensure an appropriate allocation of indirect costs to the organization's direct cost centers.

12. PROHIBITION ON CERTAIN TELECOMMUNICATIONS AND VIDEO SURVEILLANCE SERVICES OR EQUIPMENT

Per 2 C.F.R. § 200.216, recipients and subrecipients are prohibited from obligating or expending project funds to: (1) procure or obtain; (2) extend or renew a contract to procure or obtain; or (3) enter into a contract (or extend or renew a contract) to procure or obtain equipment, services, or systems that uses covered telecommunications equipment or services as a substantial or essential component of any system, or as critical technology as part of any system. As described in Public Law 115–232, section 889, covered telecommunications equipment is telecommunications equipment produced by Huawei Technologies Company or ZTE Corporation (or any subsidiary or affiliate of such entities). Refer to 2 C.F.R. § 200.216 for possible additional prohibitions and limitations.

13. BUY AMERICA REQUIREMENT FOR PUBLIC INFRASTRUCTURE PROJECTS

Projects funded through this FOA that are for, or contain, construction, alteration, maintenance, or repair of public infrastructure in the United States undertaken by applicable recipient types, require that:

- All iron, steel, and manufactured products used in the infrastructure project are produced in the United States; and
- All construction materials used in the infrastructure project are manufactured in the United States.

However, ARPA-E does not anticipate soliciting for or selecting projects that propose project tasks that are for, or contain, construction, alteration, maintenance, or repair of public infrastructure. If a project selected for award negotiations includes project tasks that may be subject to the Buy America Requirement, those project tasks will be removed from the project before any award is issued – i.e., no federal funding or Recipient cost share will be available for covered project tasks.

This “Buy America” requirement does not apply to an award where the Prime Recipient is a for-profit entity.

- Sufficiency of technical approach to accomplish the proposed R&D objectives, including why the proposed concept is more appropriate than alternative approaches and how technical risk will be mitigated;
- Clearly defined project outcomes and final deliverables; and
- The demonstrated capabilities of the individuals performing the project, the key capabilities of the organizations comprising the Project Team, the roles and responsibilities of each organization and (if applicable) previous collaborations among team members supporting the proposed project.

- b. The limitation above shall not contravene requirements applicable to Standard Form 312, Form 4414, or any other form issued by a Federal department or agency governing the nondisclosure of classified information.
- c. Notwithstanding the provision listed in paragraph (a), a nondisclosure confidentiality policy form or agreement that is to be executed by a person connected with the conduct of an intelligence or intelligence-related activity, other than an employee or officer of the United States Government, may contain provisions appropriate to the particular activity for which such document is to be used. Such form or agreement shall, at a minimum, require that the person will not disclose any classified information received in the course of such activity unless specifically authorized to do so by the United States Government. Such nondisclosure or confidentiality forms shall also make it clear that they do not bar disclosure to congress, or to an authorized official of an executive agency or the Department of Justice, that are essential to reporting a substantial violation of law.

B. GOVERNMENT RIGHTS IN SUBJECT INVENTIONS

Where Prime Recipients and Subrecipients retain title to subject inventions, the U.S. Government retains certain rights.

1. GOVERNMENT USE LICENSE

The U.S. Government retains a nonexclusive, nontransferable, irrevocable, paid-up license to practice or have practiced for or on behalf of the United States any subject invention throughout the world. This license extends to contractors doing work on behalf of the Government.

2. MARCH-IN RIGHTS

The U.S. Government retains march-in rights with respect to all subject inventions. - The U.S. Manufacturing requirement has not been met.

C. RIGHTS IN TECHNICAL DATA

Data rights differ based on whether data is first produced under an award or instead was developed at private expense outside the award.

- Background or “Limited Rights Data”: The U.S. Government will not normally require delivery of technical data developed solely at private expense prior to issuance of an

award, except as necessary to monitor technical progress and evaluate the potential of proposed technologies to reach specific technical and cost metrics.

- Generated Data: Pursuant to special statutory authority for SBIR/STTR awards, data generated under ARPA-E SBIR/STTR awards may be protected from public disclosure for twenty years from the date of award in accordance with provisions that will be set forth in the award. Application: The entire submission received by ARPA-E, including the Preliminary Application, Full Application, Reply to Reviewer Comments, and Small Business Grant Application (if applicable).

ARPA-E: is the Advanced Research Projects Agency – Energy, an agency of the U.S. Department of Energy.

Cost Sharing: Is the portion of project costs from non-Federal sources that are borne by the Prime Recipient (or non-Federal third parties on behalf of the Prime Recipient), rather than by the Federal Government.

Covered Individual: an individual who contributes in a substantive, meaningful way to the scientific development or execution of an R&D project proposed to be carried out with an award from ARPA-E. This includes, but is not limited to, the PI, Co-PI, Key Personnel, and technical staff (e.g., postdoctoral fellows/researchers and graduate students). ARPA-E may further designate covered individuals during award negotiations or the award period of performance.

Deliverable: A deliverable is the quantifiable goods or services that will be provided upon the successful completion of a project task or sub-task.

DOE: U.S. Department of Energy.

DOE/NNSA: U.S. Department of Energy/National Nuclear Security Administration.

Prime Recipient: The signatory to the funding agreement with ARPA-E.

PI: Principal Investigator.

Project Team: A Project Team consists of the Prime Recipient, Subrecipients, and others performing or otherwise supporting work under an ARPA-E funding agreement.

SBA: U.S. Small Business Administration.

SBIR: Small Business Innovation Research Program.

Small Business: Small businesses are domestically incorporated entities that meet the criteria established by the U.S. Small Business Administration’s (SBA) “Table of Small Business Size Standards Matched to North American Industry Classification System Codes” (NAICS) (<http://www.sba.gov/content/small-business-size-standards>).

Small Business Concern: A for-profit entity that: (1) maintains a place of business located in the United States; (2) operates primarily within the United States or makes a significant contribution to the United States economy through payment of taxes or use of American products, materials or labor; (3) is an individual proprietorship, partnership, corporation, limited liability company, joint venture, association, trust, or cooperative; and (4) meets the size eligibility requirements set forth in 13 C.F.R. § 121.702. Where the entity is formed as a joint venture, there can be no more than 49% participation by foreign business entities in the joint venture. Such joint ventures must submit the VCOC/FJV Certification (the seventh component of the Full Application).

Standalone Applicant: An Applicant that applies for funding on its own, not as part of a Project Team.

STTR: Small Business Technology Transfer Program.

Total Project Cost: The sum of the Prime Recipient share and the Federal Government share of total allowable costs. The Federal Government share generally includes costs incurred by GOGOs, FFRDCs, and GOCOs.
