Priority Region: Europe

Executive Summary

DRL requests proposals to strengthen and develop democratic resilience, rule of law, freedom of speech and freedom of the press, and the defense of human rights in Europe through research, conferences, cultural engagements, and support for civil society to address national sovereignty, migration, censorship, and lawfare challenges in line with shared political philosophy, law, and our common Western civilizational heritage.

B. Eligibility

1. Eligible Applicants

The following organizations are eligible to apply:

- U.S.-based non-profit organizations/nongovernmental organizations (NGOs)
- Foreign-based non-profit organizations/NGOs
- Private or public institutions of higher education
- For-profit organizations or businesses

2. Cost Sharing or Matching

Providing cost sharing, matching, or cost participation is not an eligibility factor or requirement for this NOFO and providing cost share will not result in a more favorable competitive ranking. Per 2 CFR 200.306, budget line items that are proposed for cost share must be allowable per 2 CFR 200, Subpart E—Cost Principles.

3. Other Eligibility Requirements

All organizations must have a Unique Entity Identifier (UEI) issued via SAM.gov as well as a valid registration in SAM.gov. Please see Section D.3 for more information. Individuals are not required to have a UEI or be registered in SAM.gov.

Applicants are only allowed to submit one proposal per organization. If more than one proposal is submitted from an organization, all proposals from that institution will be considered ineligible for funding.

C. Program Description

1. Goals and Objectives

The purpose of democratic government is to protect natural rights and fundamental freedoms, including free speech and religious liberty, while ensuring citizens can freely choose their elected officials and hold their government accountable. For centuries, the transatlantic partnership has been rooted in a common understanding of natural law, virtue, and national sovereignty. However, European governments are increasingly drifting from these foundations through supranational bureaucratic overreach and partisan weaponization that concentrates power in technocratic institutions less accountable to democratic choices. At the 2026 Munich Security Conference, Secretary of State Marco Rubio called for renewing the U.S.-Europe partnership to defend common heritage, restore respect for sovereignty, and address modern challenges like mass migration and violations of free speech.

Supra-national institutions and governments are using state power to undermine fundamental principles of democratic self-government through overbroad and vague hate-speech laws and online content regulations that police and punish speech while suppressing political participation. Lawfare—the manipulation of legal systems for political purposes—has become a primary tool

for suppressing freedom of speech and civic engagement through politically motivated prosecutions, strategic lawsuits against public participation (SLAPPs), criminal defamation laws, and regulatory sanctions against dissenting voices. These tactics create chilling effects that discourage individuals and organizations from speaking out, even when cases lack merit, as the legal process itself becomes burdensome and intimidating. Media regulators have also been weaponized to investigate or sanction outlets publishing dissenting views under the guise of combating "misinformation" or "disinformation," undermining independent journalism and democratic accountability.

DRL solicits proposals for \$ 1,000,000- \$3,000,000 to develop democratic resilience, rule of law, sovereignty, and civilizational self-confidence in Europe through research, conferences, cultural engagements, and support for civil society to address national sovereignty, migration, censorship, and lawfare challenges in line with our shared political philosophy, law, and Western heritage. Projects should promote natural rights and fundamental freedoms, partner with civil society, and engage in targeted research and advocacy, and not attempt to reform the legislative processes of host governments.

Applicants may work as individual organizations or as a consortium or in other teaming arrangements for activities that meet program objectives. Proposals must focus on one or more of the following objectives. For each activity, the applicant must identify the target country(ies) and describe in detail why the geographic scope is necessary to achieve the project goal and objectives.

Objective 1: Civil society identify, analyze and respond to instances of lawfare and judicial activism that undermine democracy and national sovereignty.

Illustrative activities:

- Trainings on how to recognize, prepare for, and respond to lawfare tactics, including understanding legal risks, documenting harassment, and building networks of support.
- Monitor judicial proceedings to identify patterns of judicial overreach, and understand the legal mechanisms being exploited for political purposes.
- Advocacy for reforms that protect against abuse of legal systems while maintaining judicial independence and access to justice.

Illustrative outcomes:

- Greater resilience and protection for targets of lawfare through improved skills to recognize, document, and respond to abusive legal tactics.
- Increased use of tools, such as complaint mechanisms, to counter instances of lawfare and combat free speech violations.
- Stronger legal safeguards that clarify and reinforce protections for fundamental freedoms in future cases.

Objective 2: Civil society elevates debate on EU integration, national sovereignty, migration, and Western identity.

Illustrative activities:

- Research on the impact of mass migration across Europe, as it relates to concerns about fundamental freedoms, and democratic backsliding.
- Policy debates on sovereignty, migration, and “globalism” to examine the balance between national sovereignty and supranational governance and compare the U.S. federalism and EU integration models.
- Consensus-building forums for civil society and other relevant experts on national sovereignty, Western identity, and anti-democratic trends and actors.
- Cultural engagements to promote European history and Western identity and its role in promoting democracy and natural rights.
- Presentation of peer-reviewed research papers that showcase an appreciation of European history, philosophy, and Western identity as these issues relate to the protection of natural rights, fundamental freedoms, and democratic institutions.

Illustrative outcomes:

- Civil society is a credible stakeholder in facilitating debates on democratic resilience, sovereignty, and migration.
- Civil society publishes evidence-based reports on democratic backsliding and the impact of mass migration on local safety.
- Public discourse in Europe reflects the views of all citizens and includes discussions of sovereignty and Western heritage.
- Policies are developed to address threats to national sovereignty.
- Enhanced expertise among partners, consortium members, and civil society organizations in documenting threats to national sovereignty across Europe.
- Improved research methodologies for analyzing the impact of mass migration on democratic institutions and national sovereignty are used to inform discussions on those topics.

Projects awarded under this solicitation are subject to availability of funds and terms and conditions of the grants or cooperative agreement, including high-income country waivers as needed.

In addition, competitive proposals will meet the following criteria:

- Proposals should describe clear performance indicators, data collection methods, and how progress toward objectives will be measured.
- Explain how feedback from beneficiaries will be incorporated into ongoing program adjustments and how lessons learned will be documented and shared.
- Consistent with the Foreign Assistance Act and applicable State/Foreign Operations appropriations provisions governing democracy and political party assistance, all proposed activities must be nonpartisan and offered on a fair and equitable basis to all democratic political parties, and implementers will not seek to influence the outcome of any election.

- Applicants may allocate a proportion of the funding as subaward agreements, whereby subrecipients implement program activities that contribute to meeting the program goal and objectives. While the application will be strengthened by inclusion of at least 1-2 identified subrecipients at the time of application, including letter(s) of commitment, other subrecipients may be identified and approved by DRL during the period of performance of the award.

Program Requirements:

- a. The organization will submit to DRL for approval an annual workplan that includes a timeline, planned milestones, and short descriptions of all workshops and events, and a list of stakeholder groups and organizations participating.
- b. The organization will submit to DRL for approval a Monitoring & Evaluation Narrative to describe the organization's approach to monitoring and evaluation, including proof and verification of results outlined in the Monitoring and Evaluation Plan and methodologies for internal and external evaluations.
- c. The organization will submit to DRL for approval the criteria and job descriptions of any Key Personnel proposed under the award.
- d. The organization could be subject to annual site visits by the programming monitoring team.
- e. Grantees must notify their Grants Officer Representative and their Technical Program Officer prior to any international travel, even if pre-approved in the grant budget. Grantees must also notify their Grants Officer Representative and their Technical Program Officer regarding any travel-related incidents resulting from any programmatic activities under any project or grant, USG or otherwise.
- f. The organization will submit to DRL for approval any evaluation, research or survey methodologies.
- g. DRL may also provide technical assistance or subject matter expertise, reviews and comments on draft materials, reports, or publications.

2. Substantial Involvement

The award will be a cooperative agreement. The Department of State will be substantially involved in carrying out the following various aspects of this cooperative agreement. Examples of substantial involvement may include but are not limited to:

The proposal should contain sufficient information that anyone not familiar with it would understand exactly what the applicant wants to do. You may use your own proposal format, but it must include all the items below.

- **Proposal Summary:** Short narrative that outlines the proposed project, including project objectives and anticipated impact.
- **Introduction to the Organization or Individual applying:** A description of past and present operations, showing ability to carry out the program, including information on all previous grants from the State Department and/or U.S. government agencies.
- **Problem Statement:** Clear, concise and well-supported statement of the problem to be addressed and why the proposed program is needed

- **Project Goals and Objectives:** The “goals” describe what the program is intended to achieve. The “objectives” refer to the intermediate accomplishments on the way to the goals. These should be achievable and measurable.
- **Project Activities:** Describe the program activities and how they will help achieve the objectives.
- **Project Methods and Design:** A description of how the program is expected to work to solve the stated problem and achieve the goal. Include a logic model as appropriate.
- **Proposed Project Schedule and Timeline:** The proposed timeline for the program activities. Include the dates, times, and locations of planned activities and events.
- **Key Personnel:** Resumes are not required at this time. Instead, provide only the selection criteria your program will apply throughout the grant period of performance when filling key positions.
- **Project Partners:** List the names and type of involvement of key partner organizations and sub-awardees.
- **Project Monitoring and Evaluation Plan:** This is an important part of successful grants. Throughout the timeframe of the grant, how will the activities be monitored to ensure they are happening in a timely manner, and how will the program be evaluated to make sure it is meeting the goals of the grant?

3. Unique entity identifier and System for Award Management (SAM.gov)

Required Registrations

All organizations, whether based in the United States or in another country, must have a Unique Entity Identifier (UEI) and an active registration in SAM.gov. A UEI is one of the data elements mandated by Public Law 109-282, the Federal Funding Accountability and Transparency Act (FFATA), for all Federal awards. An applicant must maintain an active registration while it has a proposal under review by the Department and must continue to keep the registration active for the entire duration of the period of performance of any Federal award that results from this NOFO.

The 2 CFR 200 requires subrecipients to obtain a UEI. Please note the UEI for subrecipients is not required at the time of application but will be required before an award is processed and/or directed to a subrecipient.

Note: The process of obtaining or renewing a SAM.gov registration may take anywhere from 4-8 weeks. Please begin your registration as early as possible.

- Organizations **based in the United States** or that pay employees within the United States will need an Employer Identification Number (EIN) from the Internal Revenue Service (IRS) and a UEI prior to registering in SAM.gov.
- Organizations **based outside of the United States** and that do not pay employees within the United States do not need an EIN from the IRS but do need a UEI prior to registering in SAM.gov.

Exemptions

An exemption from the UEI and sam.gov registration requirements may be permitted on a case-by-case basis. See [2 CFR 25.110](#) for a full list of exemptions.

Organizations requesting exemption from UEI or SAM.gov requirements must email the point of contact listed in the NOFO at least two weeks prior to the deadline in the NOFO providing a justification of their request. Approval for a SAM.gov exemption must come from the warranted Grants Officer before the application can be deemed eligible for review.

4. Submission Dates and Times

Applications are due no later than **August 12, 2026 at 23:59:59 ET**.

5. Funding Restrictions

- i. Funding Restrictions for the United Nations Relief and Works Agency (UNRWA)

None of the funds awarded resulting from this Notice of Funding Opportunity may be made available for subawards, direct financial support, or otherwise used to provide any payment or transfer to United Nations Relief and Works Agency (UNRWA).

- ii. Certification Regarding Compliance with applicable Federal anti-discrimination laws

If the place of performance or delivery of any award made under this NOFO will be within the United States, applicants are advised that they will be required to certify the following at the time of award:

Recipients do not need to submit a copy of the plan. Recipients must re-certify on an annual basis for the entire award period of performance.

The Department recognizes there are costs associated with these policies. 6. Other Submission Requirements

All application materials must be submitted electronically through www.Grants.gov or MyGrants.

F. Application Review Information

1. Review Criteria

Each application will be evaluated and rated based on the evaluation criteria outlined below.

Quality and Feasibility of the Program Idea: The program idea is well developed, with detail about how program activities will be carried out. The proposal includes a reasonable

implementation timeline. The proposal does not include any activities contrary to any standing Executive Orders. For a full list, see <https://www.federalregister.gov/>.

Organizational Capacity and Record on Previous Grants: The organization has expertise in its stated field and has the internal controls in place to manage federal funds. This includes a financial management system and a bank account. If sub-awards are proposed, applicant demonstrates experience managing subawards.

Program Planning/Ability to Achieve Objectives: Goals and objectives are clearly stated and program approach is likely to provide maximum impact in achieving the proposed results.

Budget: The budget justification is detailed. Costs are reasonable in relation to the proposed activities and anticipated results. The budget is realistic, accounting for all necessary expenses to achieve proposed activities.

Monitoring and evaluation plan: Applicant demonstrates it is able to measure program success against key indicators and provides milestones to indicate progress toward goals outlined in the proposal. The program includes output and outcome indicators and shows how and when those will be measured.

Sustainability: Program activities will continue to have positive impact after the end of the program.

2. Indirect Costs

If two or more applications receive equivalent scores based on the evaluation criteria outlined in this NOFO, preference will be given to the applicant with the lower indirect cost rate, as consistent with Executive Order 14332, Section 4(b)(iii). This preference will only be applied as a tie-breaking mechanism and does not supersede the primary evaluation criteria.

3. Review and Selection Process

A review committee will evaluate all eligible applications.

4. Risk Review

i. Risk factors

Under the merit review as required by 2 CFR 200.206, prior to making a Federal Award the Department will review and consider the following risk factors:

- a. Financial stability
- b. Management systems and standards

- c. History of performance
- d. Audit reports and findings
- e. Ability to effectively implement requirements

ii. Responsibility/Qualification Information in SAM.gov

The Federal awarding agency, prior to making a Federal award with a total amount of Federal share greater than the simplified acquisition threshold, is required to review and consider any information about the applicant that is in the U.S. government designated integrity and performance system accessible through SAM.gov (see 41 U.S.C. 2313)

An applicant can review and comment on any information in the responsibility/qualification records available in SAM.gov.

Before making decisions in the risk review required by 2 CFR 200.206, the Department will consider any comments by the applicant, along with information available in the responsibility/qualification records in SAM.gov.

G. Award Notices

The award or cooperative agreement will be written, signed, awarded, and administered by the Grants Officer. The award agreement is the authorizing document, and it will be provided to the recipient for review and counter-signature. The recipient may only start incurring project expenses beginning on the start date shown on the award document signed by the Grants Officer.

If a proposal is selected for funding, the Department of State has no obligation to provide any additional future funding. Renewal of an award to increase funding or extend the period of performance is at the discretion of the Department of State.

Issuance of this NOFO does not constitute an award commitment on the part of the U.S. government, nor does it commit the U.S. government to pay for costs incurred in the preparation and submission of proposals. Further, the U.S. government reserves the right to reject any or all proposals received.

Unsuccessful applicants: Unsuccessful applicants will be notified via email.

Payment Method:

Payments under this award will be made through the U.S. Department of Health and Human Services (HHS) Payment Management System (PMS).

Recipients may not draw down funds without the affirmative authorization of the Department of State. In addition, recipients must submit, with each PMS payment request, a detailed explanation justifying the request.

H. Post-Award Requirements and Administration

1. Administrative and National Policy Requirements

 - Providing a preference, to the extent permitted by law, to maximize use of goods, products, and materials produced in the United States (2 CFR part 200.322), and
 - Terminating agreements pursuant to the U.S. Department of State Standard Terms and Conditions, including, to the greatest extent authorized by law, if an award no longer effectuates the program goals or agency priorities (2 CFR part 200.340). For the avoidance of doubt, the Department has sole discretion over the determination that an award no longer effectuates program goals or agency priorities, and this provision permits awards to be terminated at the Department's convenience, including when it determines that the award no longer advances the national interest.

2. *Reporting*

Reporting Requirements: Recipients will be required to submit financial reports and program reports. The award document will specify what reports are required and how often these reports must be submitted.

Foreign Assistance Data Review: As required by Congress, the Department of State must make progress in its efforts to improve tracking and reporting of foreign assistance data through the Foreign Assistance Data Review (FADR). The FADR requires tracking of foreign assistance activity data from budgeting, planning, and allocation through obligation and disbursement. Successful applicants will be required to report and draw down federal funding based on the appropriate FADR Data Elements, indicated within their award documentation. In cases of more than one FADR Data Element, typically program or sector and/or regions or country, the successful applicant will be required to maintain separate accounting records.

Applicants should be aware of the post award reporting requirements reflected in [2 CFR 200 Appendix XII—Award Term and Condition for Recipient Integrity and Performance Matters](#).

3. **Branding and Marking**

The Department of State, its programs, and U.S. Government funding and assistance should be easily identifiable to the Department's global audiences.

Recipients of federal assistance awards must follow the branding guidance published at [Guidance for Contracts and Grants - U.S. Department of State Brand System](#). Branding policy exceptions are outlined in the U.S. Department of State Foreign Affairs Manual [10 FAM 416, Policy Exceptions](#).

I. Other Information

Guidelines for Budget Justification

Personnel and Fringe Benefits: Describe the wages, salaries, and benefits of temporary or permanent staff who will be working directly for the applicant on the program, and the percentage of their time that will be spent on the program.

Travel: Estimate the costs of travel and per diem for this program, for program staff, consultants or speakers, and participants/beneficiaries. If the program involves international travel, include a brief statement of justification for that travel.

Equipment: Describe any machinery, furniture, or other personal property that is required for the program, which has a useful life of more than one year (or a life longer than the duration of the program), and costs at least \$10,000 per unit.

Supplies: List and describe all the items and materials, including any computer devices, that are needed for the program. If an item costs more than \$10,000 per unit, then put it in the budget under Equipment.

Contractual: Describe goods and services that the applicant plans to acquire through a contract with a vendor. Also describe any sub-awards to non-profit partners that will help carry out the program activities.

Other Direct Costs: Describe other costs directly associated with the program, which do not fit in the other categories. For example, shipping costs for materials and equipment or applicable taxes. All “Other” or “Miscellaneous” expenses must be itemized and explained.

Indirect Costs: These are costs that cannot be linked directly to the program activities, such as overhead costs needed to help keep the organization operating. If your organization has a Negotiated Indirect Cost Rate (NICRA) and includes NICRA charges in the budget, attach a copy of your latest NICRA. Organizations that have never had a NICRA may request indirect costs of 15% of Modified Total Direct Costs as defined in 2 CFR 200.1.

“Cost Sharing” refers to contributions from the organization or other entities other than the U.S. Embassy. It also includes in-kind contributions such as volunteers’ time and donated venues.

Alcoholic Beverages: Please note that award funds cannot be used for alcoholic beverages.
