A. Program Description

A1. Authority

43 U.S.C. 1345(e) gives the Interior Secretary general authority to enter into cooperative agreements with affected States for purposes which are consistent with OCSLA. Such agreements may include, but need not be limited to, the sharing of information (in accordance with 43 U.S.C. 1352), the joint utilization of available expertise, the facilitating of permitting procedures, joint planning and review, and the formation of joint surveillance and monitoring arrangements to carry out applicable Federal and State laws, regulations, and stipulations relevant to Outer Continental Shelf operations both onshore and offshore.

A2. Background, Purpose and Program Requirements

The Bureau of Ocean Energy Management (BOEM), a bureau of the Department of the Interior (DOI), is responsible for managing the exploration and development of energy and mineral resources on the Outer Continental Shelf (OCS). BOEM's mission is to promote economic development and energy independence while ensuring protection of the environment. To ensure that the nation receives the best value for its resources, the MMD actively seeks out and generates information to support decision-making both in the DOI and in coastal states and local governments. The MMD also has stewardship responsibilities over OCS marine minerals, whether critical, strategic, or economic.

The Outer Continental Shelf Lands Act (OCSLA), Section 1331 encourages state participation in policy and planning decisions related to OCS resources. OCSLA Section 1336 authorizes leasing of minerals on the OCS. OCSLA Section 1345 authorizes the use of cooperative agreements with affected States to meet the requirements of OCSLA, including sharing of information, joint utilization of available expertise, formation of joint monitoring arrangements to carry out applicable Federal and State laws, regulations, and stipulations relevant to outer continental shelf operations both onshore and offshore.

Cooperative partnerships for marine minerals investigations have successfully been completed since 1994.

Project Summary

This cooperative agreement would apply forecasting tools developed in partnership with the Delaware Geological Survey to expand BOEM's ongoing evaluation of sediment demand and supply in the Mid-Atlantic. As a result, BOEM would be better equipped to evaluate and characterize regional sand supply gaps over time scenarios relevant to climate change adaptation. Understanding these gaps would help BOEM to identify strategic areas for future investments in data acquisition surveys and to prioritize (de-conflict) sand resource areas in this region of concentrated wind energy infrastructure (including transmission lines).

This agreement would help advance the National Offshore Sand Inventory. It also would address coastal resilience considerations reflected in sections 211 and 214 of Executive Order 14008, "Tackling the Climate Crisis at Home and Abroad." These considerations include mitigating climate change and strengthening resilience by protecting and restoring vulnerable coastlines, which are projected to need OCS sand resources for at least the next 50 years. Datasets would be housed in the Marine Minerals Information System and shared with State resource agencies, Federal partners, and other stakeholders.

3. Classify or confirm existing classifications of existing mineral resources into categories: Proven, Potential, Unverified, and Unusable. Create new data and classify data as needed.
4. Research, identify, and described demand and supply for traditional USACE projects and non-USACE projects in the region that may be required to support resilience of other federal or state-managed lands, such as National Parks or wildlife refuges.

If the required data is not already available, the recipient must produce the proposed geospatial data, products, or services in compliance with applicable proposed guidance and standards established by the Federal Geospatial Data Committee (FGDC) posted at www.fgdc.gov.

Recipients must submit a digital copy of all GIS data produced or collected as part of the award funds to the bureau or office via email or data transfer. All GIS data files shall be in open format. All delineated GIS data (points, lines or polygons) should be established in compliance with the approved open data standards with complete feature level metadata.

*Geospatial data refers to data regarding natural or man-made, imaginary, or physical features. It also includes location information, and information referring to boundaries, points of interest, and mobility data.

Requirements for Availability of Data (2 CFR § 1402.315)

All data, methodology, factual inputs, models, analyses, technical information, reports, conclusions, valuation products or other scientific assessments in any medium or form, including textual, numerical, graphic, cartographic, narrative, or audiovisual, resulting from a financial assistance agreement is available for use by the Department of the Interior, including being available in a manner that is sufficient for independent verification.

The Federal Government has the right to:

1. Obtain, reproduce, publish, or otherwise use the data, methodology, factual inputs, models, analyses, technical information, reports, conclusions, or other scientific assessments, produced under a Federal award; and
2. Authorize others to receive, reproduce, publish, or otherwise use such data, methodology, factual inputs, models, analyses, technical information, reports, conclusions, or other scientific assessments, for Federal purposes, including to allow for meaningful third-party evaluation.
