A. Clarifications

<u>Equipment</u>: As indicated in d) Summary Budget, Detailed Budget, and Budget Narrative, (3), 4), the definitions of equipment, capital assets, and personal property (tangible) can be found in 2 CFR 200.1.

<u>Construction</u>: As indicated in Section B, 3.c., construction is not authorized under this NOFO and will not be financed. Per ADS 303maw, found at

https://www.usaid.gov/about-us/agency-policy/series-300/references-chapter/303maw, construction is defined as follows: "Construction" for purposes of this policy means: construction, alteration, or repair (including dredging and excavation) of buildings, structures, or other real property and includes, without limitation, improvements, renovation, alteration and refurbishment. The term includes, without limitation, roads, power plants, buildings, bridges, water treatment facilities, and vertical structures. The term does not include emplacement and removal of prefabricated structures and humanitarian shelters that are designed and constructed to be readily moved, erected, disassembled, stored, and reused (i.e., "relocatable buildings"), unless the emplacement and removal of the relocatable building requires site preparation work that otherwise meets the definition of construction."

<u>Non-USAID contributions</u>: The application budget must only include costs attributed to the activities proposed for financing by USAID. Any contributions by the applicant or third parties should be identified separately.
