Overview

The [U.S. Department of Justice](#) (DOJ), [Office of Justice Programs](#) (OJP), [Office for Victims of Crime](#) (OVC), is seeking applications for funding for the 2022, 2023, and 2024 Victims of Crime Act (VOCA) National Training Conferences for State VOCA Victim Assistance and Compensation Administrators. This program furthers the Department's mission by supporting annual national training for VOCA administrators and their staff to strengthen the administration of federal victim service funding and improve services, compensation, and victim access to both.

Program Description

Overview

The Department of Justice is committed to advancing work that promotes civil rights, increases access to justice, supports crime victims, protects the public from crime and evolving threats, and builds trust between law enforcement and the community.

Under this solicitation, the Office for Victims of Crime (OVC) will make an award to an eligible organization to support the 2022, 2023, and 2024 VOCA National Training Conferences for State VOCA Victim Assistance and Compensation Administrators and their staff. The conferences will provide training and technical assistance and facilitate an opportunity for the presentation of state issues and practices through lectures, panels, workshops, and forums.

Statutory Authority

34 U.S.C. § 20103(c)(1)(A)

Specific Information

The selected organization will plan and administer training activities to bring VOCA Victim Assistance and Victim Compensation Administrators and their staff together for training conferences in 2022, 2023, and 2024. The conferences will provide training and current information on federal grant management and victim services to state VOCA assistance administrative agencies and crime victim compensation programs. The trainings will: include approaches to improve the delivery of services to victims of crime; address issues and trends in victim services; improve the administration of VOCA victim assistance and/or crime victim compensation formula grants; provide a forum for the exchange of information, views, and experiences with colleagues; improve the provision of victim services; and provide support on effective program, grant, and financial management. The conferences will also provide VOCA Administrators with information vital to complying with their responsibilities as managers of VOCA victim assistance and/or crime victim compensation programs.

Goals, Objectives, Deliverables, and Timeline

Goals

The goal of this program is to improve the delivery of victim services and compensation by VOCA-funded victim assistance and victim compensation programs.

Objectives

The objective is to hold national training conferences for State VOCA Victim Assistance and Victim Compensation Administrators in 2022, 2023, and 2024.

Deliverables

The deliverables required by OVC for this project include the following:

1. National Training Conferences to be held annually in 2022, 2023, and 2024 with an overall emphasis on VOCA formula subject matters, issues raised by the Office of the Inspector General, fundamental grants and financial management trainings, programmatic and innovative trainings, and criminal justice topics. The conferences will be in-person with the option for virtual delivery.
2. Regular planning meetings with OVC to assist the conference coordinator with identifying the subject matter of the conference and possible speakers and workshop facilitators.
3. Posting of conference materials to the recipient's website and the OVC website.
4. A Final Conference Report, which will include the conference evaluations submitted by the attendees, assessment of the conference planning, and recommendations for improvement.
5. Any other related activities as identified by OVC.

The Goals, Objectives, and Deliverables are directly related to the performance measures that demonstrate the results of the work completed, as discussed under Application and Submission Information.

Proposal Abstract

A proposal abstract (no more than 400 words) summarizing the proposed project including primary activities, products and deliverables, the service area, and who will benefit from the proposed project, will be completed in the JustGrants Web-based form.

Proposal Narrative

The proposal narrative should be submitted as an attachment in JustGrants. The attached document should be double-spaced, using a standard 12-point Times New Roman font; have no less than 1-inch margins; and should not exceed 20 pages. Pages should be numbered and submitted as an attachment. If the proposal narrative fails to comply with these length restrictions, OVC may negatively consider such noncompliance in peer review and in final award decisions.

The following sections must be included as part of the proposal narrative:

a. Description of the Issue

1. Describe the problem to be addressed through this project, and why it is necessary for the field.
2. Describe current services, training, and technical assistance available to State Administrators, and gaps.
3. Describe how the funding will alleviate the problem.

b. Project Design and Implementation

The application must provide a clear link between the proposed activities and the need identified in the “Description of the Issue” section above.

This section must:

1. Describe in detail specific activities necessary for accomplishing each goal and objective of the proposed project. Include a description of project phases, tasks, activities, staff responsibilities, and clear descriptions of interim deliverables and final products. Also include a separate **Time-Task Plan** that clearly identifies objectives, major activities, and products. The time-task plan presented in chart form will not be included as part of the 20-page program narrative limitation.
2. Describe coordination with OVC and other key partners including the National Association for VOCA Assistance Administrators and the National Association of Crime Victim Compensation Boards, national training and technical assistance providers, and the victim assistance field.
3. Describe how the conferences will be implemented in 2022, 2023, and 2024, including an optional virtual component.

c. Capabilities and Competencies

This section must:

1. Identify the key individuals and organizations involved in the proposed project.
2. Provide a clear description of the applicant’s management structure.
3. Demonstrate that the individuals and organizations identified have the capacity to address the stated need, including the expertise necessary to coordinate and execute three national conferences and coordinate with federal entities in delivering national conferences; experience with coordinating virtual trainings and the ability to implement the proposed project activities.
4. Describe specific roles and responsibilities of all project partners and key staff.
5. Clearly describe who will implement activities as described in the Project Design and Implementation section.
6. Describe their experience managing federal grants that support training and technical assistance, coordination and implementation of national conferences, and victim services.
7. Include a clear description of the applicant’s management structure. **Resumes and Position Descriptions of Key Personnel** should be included as a separate attachment.
8. Describe how the program will be managed and include an **organizational chart** or information describing the roles and responsibilities of key organizational and functional components and personnel.
9. Include a **list of personnel** responsible for managing and implementing the major stages of the project. If additional staff will be hired to complete the project, the applicant should identify the selection criteria.
10. Provide detailed information about staff members who have committed to work on the project contingent upon receipt of funding.

d. Plan for Collecting the Data Required for this Solicitation’s Performance Measures

This section must:

1. State the applicant’s understanding of the performance data reporting requirements for this grant program and describe a plan for collecting all of the performance measures data required by this solicitation.
2. Identify key staff who will be responsible for collecting and reporting data.
3. Outline a plan for conducting evaluation activities to determine if the project is meeting goals and objectives.

OJP will require each successful applicant to submit regular performance data that demonstrate the results of the work carried out under the award. The performance data directly relate to the goals, objectives, and deliverables identified under “Goals, Objectives, and Deliverables” in the Program Description.

Award recipients will be required to submit performance measure data in the Performance Measurement Tool (PMT) and/or JustGrants. Application Review Information

Review Criteria

a. Merit Review Criteria

Applications that meet basic minimum requirements will be evaluated by peer reviewers. Applications will be evaluated on how the proposed project/program addresses the following criteria:

1. Description of the Issue (20%) - evaluate the applicant's understanding of the program/issue to be addressed.
2. Project Design and Implementation (45%) - evaluate the adequacy of the proposal, including the goals, objectives, timelines, milestones, and deliverables. Including the separately attached Time-Task Plan.
3. Capabilities and Competencies (20%) - evaluate administrative and technical capacity of the applicant to successfully accomplish the goals and objectives. Including the separately attached resumes and positions descriptions of key personnel.
4. Plan for Collecting the Data Required for this Solicitation's Performance Measures (5%) - evaluate the applicant's understanding of the performance data reporting requirements and the plan for collecting the required data.
5. Budget (10%) - evaluate for completeness, cost effectiveness, and allowability (e.g., reasonable, allocable, and necessary for project activities).

b. Other Review Criteria/Factors

Other important considerations for OVC include geographic diversity, strategic priorities, available funding, past performance, and the extent to which the Budget Worksheet and Budget Narrative (web-based form) accurately explain project costs that are reasonable, necessary, and otherwise allowable under federal law and applicable federal cost principles.

Review Process

Applications submitted under this solicitation that meet basic minimum requirements, will be evaluated for technical merit by a peer review panel(s) in accordance with OJP peer review policy and procedures using the stated review criteria

above.

OJP screens applications to ensure they meet the basic minimum requirements prior to conducting peer review. Although specific requirements may vary, the following are common requirements applicable to all solicitations for funding under OJP programs:

- The application must be submitted by an eligible type of applicant.
- The application must request funding within programmatic funding constraints (if applicable).
- The application must be responsive to the scope of the solicitation.
- The application must include all items necessary to meet the basic minimum requirements.

Pursuant to the Part 200 Uniform Requirements, before award decisions are made, OJP also reviews information related to the degree of risk posed by the applicant.
