Notice of Intent to Award to a Single Source without Competition (NOI)

Per 505 DM 2, Section 2.14, a single source award is a financial assistance award specifically directed to a known recipient that is statutorily designated or determined to be an appropriate partner based on demonstrable criteria, such as unique expertise or capacity. Decisions to award funds to a single source without engaging in competition must withstand scrutiny, should protect the public interest, and should comport with management priorities, objectives and statutory requirements. **Programs must use this NOI template to document justification for issuing funds in any amount to a single source without competition.** The completed NOI template must be included in the official award file maintained by the program office. At this point time, and recent availability of this grant funding, a search for capable sources to administer and manage the funds and construction activities would certainly add an unknown burden of time to this restoration and construction of the access road and trail. Sonoma Land Trust has been effectively and efficiently managing this project for over 5 years and have now entered the actual construction of the restoration. Additionally, through partnerships already in place, the two lane gated access road, separate universal access trail, parking area, and wildlife dependent recreation pull-outs have already been engineered to bid design. Finally, this entire restoration has been publically known for over 3 years and the granting of these funds has been published through the U.S. Department of Transportation.
