

The [National Institute of Corrections](#) (NIC) is seeking applications for funding under the Fiscal Year (FY) 2019, to deliver the Collaborative Case Work with Women model (CCW-W). CCW-W is an intensive, individualized case work process for justice-involved women with multiple and complex needs. CCW-W will be delivered in partnership with the “to be determined” host agency.

NIC FY 2019 Collaborative Case Work with Women (CCW-W)

Eligibility

NIC invites applications from nonprofit organizations (including faith-based, community, and tribal organizations), for-profit organizations (including tribal for-profit organizations), and institutions of higher education (including tribal institutions of higher education). Recipients, including for-profit organizations, must agree to waive any profit or fee for services.

NIC welcomes applications that involve two or more entities; however, one eligible entity must be the applicant and the others must be proposed as sub-recipients. The applicant must be the entity with primary responsibility for administering the funding and managing the entire program.

NIC may elect to make awards for applications submitted under this solicitation in future fiscal years, dependent on the merit of the applications and on the availability of appropriations.

Deadline

Applicants must register with [Grants.gov](#) prior to submitting an application. NIC encourages applicants to **register several weeks before** the application submission deadline. In addition, NIC urges applicants to **submit applications 72 hours** prior to the application due date. All applications are due to be submitted and in receipt of a successful validation message in Grants.gov by 11:59 p.m. eastern time on **March 14, 2019**. Late applications are neither reviewed nor considered.

NIC FY 2019 Collaborative Case Work with Women (CCW-W) (CFDA # 16.601)

A. Program Description

Overview

The data is sobering, the numbers of women incarcerated between the years 1980 and 2017 increased in excess of 700%. (*Carson, E.A 2018 Prisoners in 2016, Washington, DC BJS*), twice that of men. Within that increase, more than 60% of women have a child under the age of 18 (*Glaze, L.E. and Maruschak, L.M. 2009, Parents in Prison and Their Minor Children, Washington, DC, BJS*). Women are more likely than men to be incarcerated for drug or property offenses; African American and Hispanic women are imprisoned at higher rates than white women and serious mental health disorders for women are almost twice that of men in prison (*Indicators of Mental Health Problems: Reported by Prisoners and Jail Inmates (2011-2012 BJS)*). All of these issues, contribute to and impact women in prison and are interwoven into their process of transition from prison to the community.

CCW-W is an intensive, individualized case work process for justice-involved women with multiple and complex needs. During the case work process an emphasis is placed on assisting her to mobilize existing strengths, build new skills and, to connect with resources that provide advocacy, awareness, treatment, and any other relevant services.

A salient characteristic and defining feature of the CCW-W model is that it is NOT a program but a *process*. As women participate in CCW-W they are provided with opportunities to promote the successful transition from prison and/or supervision into the community. Ideally CCW-W begins at the moment a woman enters the criminal justice system and continues in a seamless fashion until intervention is no longer required.

CCW-W is rooted in the belief that when women reach an optimum level of success and wellness, everyone benefits, including: the woman being served, her family, her natural support system, and the larger community. To achieve this goal we believe that each woman must be a collaborative partner in the change process. This means that she is one member of a team of individuals who work together to prioritize the focus of change, develop a plan, implement the plan, and monitor progress.

Summary of elements of the CCW-W process:

Guiding Principles: CCW-W is built around 7 guiding principles identified from the bodies of research on correctional risk, need and responsivity; case management outcome literature; and the gender-informed research specific to women. The principles that are foundational to this model include Gender-Responsive Principles, Individualized Service, Team Approach, Continuity of Care, Agency Partnerships, Comprehensive and Holistic Committed to Program Integrity and Committed to Process and Outcome Evaluation. The model incorporates the theory, research and necessary practice that underlies each of the guiding principles noted above.

Process: As noted earlier CWW-W is a process, not a program. The 4 process stages are identified as Engage & Access; Enhance Motivation; Implement Case Plan and Continuous

Review and Support. Anticipate that over time the four overlapping stages and identified priorities may shift and need revision with changes in her life circumstances.

Activities for Implementation include: Client selection based on assessment of gender responsive risk, needs & strengths; identifying supports; development of the CCW-W team to identify and define roles; training activities that prepare staff to implement the CCW-W model; present overview of model to executive and management; coaching of the CCW-W Team, and a process for selecting and training of trainers to build agency delivery capacity; building and mobilizing of agency partnerships; monitoring CCW-W fidelity and outcomes using various measures.

Additional activities include leading the process of building inter-agency support; preparing agency and staff for training; building agency capacity for CCW-W delivery; delivery of training and supervision which will cover a broad range of areas (GR philosophy and guiding principles; elements of gender responsive practice, gender-responsive assessment, engaging and assessing; enhancing motivation; developing a GR case plan, review progress and supporting success); team building; building partnerships; working in a trauma informed way, self-care, and guidance to move staff from 'fixing to guiding' the intervention process. Further, prepare agency and staff to implement quality assurance measures and conduct process and outcome evaluation.

Information regarding delivery:

The CCW-W process will be delivered over multiple trips, determined in consultation with hosting site based on agency's capacity and mutually agreed upon scheduling.

1. Meet with agency leadership and designees to provide overview of the CCW-W process, discuss logistics, develop the implementation protocol and evaluation framework; determine onsite delivery dates for each phases of the process for up to 30 agency staff and external partners. (Up to 2 days)
2. Phase 1: Onsite instructor lead (ILT) delivery of modules to designated agency staff and external partners and follow up distance Virtual Instructor Lead (VILT) coaching sessions (up to 9 days)
3. Phase 2: Onsite delivery (ILT) for up to 8 Training for Staff Trainers candidates and follow up distance (VILT) coaching sessions (up to 5 days)
4. Onsite delivery (ILT) of CCW-W training for staff and external partners co-facilitated by trainer candidates and awardee, review of trainer candidates and follow up distance (VILT)coaching sessions for trainers (up to 9 days)

Goals, Objectives, and Deliverables

Goal: To provide training and support to host site participants to implement, sustain and evaluate the Collaborate Case Work – Women process with fidelity.

Objectives:

1. To deliver the CCW-W model as specified in this cooperative agreement
2. In concert with the justice involved women recipients of CCW-W:
 - o Agency CCW-W team will have a picture of her strengths, current support and her personal incentives for positive change.
 - o Identification of a priority focus with the setting of personal goals
 - o Through collaborative efforts she has identified action steps to complete

- the case plan for implementation.
- o Reviewing successes and barriers and revising goals to promote resiliency and facilitate positive change.

Deliverables:

In addition to the strategy and content of the process design, the successful applicant must complete the following deliverables during the project period. The narrative should reflect how the applicant will accomplish these activities.

1. Participate in an initial virtual meeting with the NIC program manager to discuss the cooperative agreement, scope of work, and all related aspects of the cooperative agreement within 30 days of award.
 2. One complete delivery of all of the phases of CCW-W as noted in this cooperative agreement solicitation.
- Awardee will work with host agency to ensure that they can provide the physical space and technical requirements for the face-to-face Instructor Led Training (ILT) as outlined in the requirements below:
 - o Each participant student must have a copy of the CCW-W materials.
 - Students MUST be granted time during regular duty hours to complete the inter-session assignments. These typically take about 2 hours per week.
 - For the face-to-face Instructor Led Training (ILT) the host agency must arrange for:
 - o Training facility with one room large enough to accommodate 30 students and trainers, with 1-2 breakout rooms.
 - o A computer and LCD projector in each room
 - o Access to a copy machine (for last-minute items)
 - o Capacity to show and listen to DVDs in the main room
 - o Four chart stands and lots of chart paper
 - o Tape, markers, pads of paper, sticky notes, pens, and all other standard training supplies
 - o Name tents
 - The awardee will work with the host agency to identify up to 30 participants to be available for the duration of the process as well as in the capacity of staff trainer for CWW-W. The NIC program manager will approve the final roster.
 - Printing of the Participant Manuals are the responsibility of each participant.
 - Awardee will work with the host agency and NIC program manager to ensure all participants are registered in NIC's Learning Management System.
 - Awardee will use only NIC provided program facilitation materials for all VILT and ILT sessions.
 - Each program will be facilitated by trainers approved by the NIC program manager. See Specific Requirements for trainer qualifications.
 - The Awardee will work with the trainers to establish an agenda for each program, and clearly outline roles for the delivery of the course.

- The Awardee will work with the trainers to establish and share any and all responsibilities beyond the delivery of the curriculum itself, including, but not limited to, such tasks as: determining and sending out trainer assignments for each of the VILTs and the ILT; preparing a participant roster; taking attendance at each VILT; creating participant “try-out” and coaching assignment documents; and corresponding with all participants of this learning event.
- The Awardee/trainers will read and prepare all assigned lessons, to include all supplemental materials.
- The Awardee/trainers will be fully prepared to deliver the curriculum, to include all VILTs and the ILT.
- The Awardee/training team will sign onto each VILT before its designated start time in order to ensure that all aspects of the event are ready. After starting the VILT the Awardee/trainers will prepare the platform to make it ready for all learning activities.
- The Awardee/trainers are responsible for loading all slides and additional materials before the start of the VILT and creating all necessary breakout sessions.
- The Awardee/trainers will facilitate or co-facilitate all aspects of the program as decided upon during planning activities. The Awardee will assist trainers to deliver the best possible program.
- The Awardee/trainers will follow all aspects of the CCW-W process with fidelity, effectively assist the host agency, and represent NIC in a positive, professional manner.
- The Awardee/trainers will serve as coaches to class participants and must be available during normal business hours to coach participants.
- The Awardee/trainers will ensure that all participants understand the homework assignments between each VILT and ILT.
- The Awardee/trainers will be present during all training events, even when not teaching or facilitating activities.
- The Awardee/trainers will monitor activities, be familiar with all presenters' presentations, provide assistance as needed, and participate in discussions and exercises. At the end of each training event, the Awardee/trainers will participate in an evaluation meeting to debrief the training and instructional outcomes.
- Develop a comprehensive Participant Readiness Evaluation form in both digital and hard copy that identifies the participants' level of mastery and need for continued support and coaching. The evaluation form should consist of a scoring rubric that reduces bias and allows for fair and equitable evaluation from all trainers involved in the program.

- Notes for each session that includes:
- a. Skills and competencies discussed

 - c. Participant centered and directed action plan steps
 - d. Action step outcomes
4. Create a digital (PDF) program information package for host site, including, but not limited to, the following content:
- o Program overview
 - o Program objectives
 - o Program agenda
 - o Regional training host information to include agency point of contact (name, phone number, email address, map to training location)
5. Facilitate a closeout meeting with the NIC Project Manager to discuss delivery strategies, format, potential next steps and overall operation of the cooperative agreement. This meeting may be in person or virtual.

Award Conditions. The successful applicant will:

- Articulate experience in working with correctional executive management and leadership, staff and related stakeholders in delivering training and other types of correctional assistance.
- Articulate a clear understanding of and experience in Collaborative Case Work – Women (CCW-W) as presented by NIC
- Demonstrate proven expertise and experience in correctional project management, adult learning and performance, training development, and virtual and classroom-based facilitation
- Demonstrate substantial capacity to provide the complete CCW-W training (e.g.,

ensure host agencies are prepared for the Instructor Led Training (ILT) requirements, classes are filled)

- Demonstrate proven experience in the delivery model of CWW-W and expertise in adult learning principles, specifically, the T4C training-for-trainers curricula

Specific Requirements

In order to deliver CCW-W with fidelity, staff of the host agency will need to either have been trained in the foundational research and theory of CWW-W (Gender-Responsive strategies, evidence-based practices, Motivational Interviewing, casework strategies to include strengths based research and cultural competence, trauma informed practice and/or receive refresher training in those areas. The applicant must have the knowledge, expertise and experience in both delivery of those areas noted above and in assessing the extent to which the agency requesting to implement CCW-W has or must be trained in those areas and provide information where gaps exist.

Awardee will lead the Quality Assurance process to ensure consistency with the structural components of CCW-W and to generate a strategic plan to fully operationalize and integrate each component.

Will lead the training, support and coaching process in the delivery of CCW-W to women assessed at higher levels of risk.

Delivery of the CCW-W requires knowledge and expertise with evidence based, gender informed research and practice. Expertise in gender-informed risk and needs, skills in developing casework teams and promoting group/team collaboration, designating and working with internal partners, establishing quality assurance measures for process and outcome evaluations while ensuring adherence to the fidelity of CCW.

Awardee will work with the agency to collect relevant data, evaluate the result of a readiness survey, oversee and prepare materials for each on site event and relevant audiences, delivery of on site and distance coaching to ensure participants deliver the CCW-W with fidelity.

Will work with agency to identify team of staff designated to be in-house trainer and coaches.

Will work closely with NIC to ensure materials needed for training are made available to the agency for purposes of copying and distribution to participants, develop training dates, agenda and establish delivery timelines that meet the need of the host agency.

Contractor must develop the framework and submit a final report summarizing the impact of delivery of CCW-W, lead discussion with leadership and develop a summary of recommendations for next steps.

Expertise in working with correctional executive and management as well as corrections staff, service providers and other related stakeholders.

Will lead the work with agency leadership to discuss implementation issues related to existing policy and procedures.

- Awardee shall actively work with NIC program manager to determine the suitability of the trainers brought on by awardee. Final determination rests with NIC program manager.
- Project Director must:
 - o Have significant expertise and experience (minimum of 8 years) in project management with successful deliverables and completion of project
 - o Have demonstrated experience (minimum of 3 years) working as a Trainer of Trainers (T4T) for a correctional agency or within individual jurisdictions
 - o Have demonstrated experience (minimum of 3 years) using the CCW-W model.
 - o Have significant experience (minimum of 3 years) in managing training-based programs and projects with successful deliverables and completion of projects
 - o Have significant experience (minimum of 2 years) in facilitating elements of the CCW-W model with corrections clients
 - o Submit a resume and bio detailing experience and qualifications
- Trainers brought on by awardee must:
 - o Have demonstrated experience in delivering training on evidence-based practices, gender-responsive (women) theory and research, trauma informed care and case planning with offender groups and/or staff (minimum of 3 years).
 - o Have demonstrated experience (minimum of 3 years) working as a Trainer of Trainers (T4T) for a correctional agency nationally or within individual jurisdictions
 - o Submit a resume and bio detailing experience and qualifications
 - o Submit a statement of availability and interest to participate
- Awardee is responsible for all trainers expenses and fees, to include planning meetings.
- Awardee shall, throughout the award period, maintain regular, routine contact with NIC program manager regarding programmatic and deliverable progress. This includes, but is not limited to:
 - o Schedule and conduct at least monthly telephone updates, providing NIC program manager with information about status of deliverables, challenges, areas where assistance is required, etc. A summary email detailing the key areas discussed during the telephone update will also be sent to the NIC program manager by the Project Director.
 - o Provide quarterly progress reports in adherence to written requirements and prescribed schedule outlined in the award documents.
 - o Submit end of process reports for each completed host site event.
- Awardee shall provide appropriate documentation and reports of meeting outcomes (e.g., planning sessions, focus groups) to NIC program manager. A final closeout report for the cooperative agreement is also required.
- Awardee will ensure that all electronic deliverables are compatible with NIC's systems.
- Awardee will, at a minimum, deliver the following items in electronic versions via

thumb drive and hard copy for all deliverables in this cooperative agreement:

- o Program information packet
- o Final Participant Roster
- o Coaching Logs
- o Participant Evaluation Form
- o Host Site end of program reports
- o Final closeout report for the cooperative agreement

Evaluation Requirements. All training programs must have an evaluation conducted, processed, and tallied into a formal, written report. At a minimum, evaluation reports are to be electronically submitted to the NIC program manager.

- Awardee is responsible for developing and coordinating the post-training and technical assistance evaluation process, including (1) development of evaluation instrument(s) (2) instrument distribution to training participants and instructors, (3) collection and analysis of responses, and (4) preparation/delivery of summaries of outcomes to the NIC program manager. At a minimum, evaluation reports should include numeric averages, qualitative comments, and participation rate.

Conduct follow-up evaluations at thirty (30) days and sixty (60) days post program. If time permits, a ninety (90) day evaluation should also be conducted. The purpose of the evaluation is to determine evidence of the impact on the participatory agencies. The results of the evaluations must be submitted within thirty (30) days of follow-up completion..

Evidence-based programs or practices. NIC strongly emphasizes the use of data and evidence in policy making and program development.

- improving the quantity and quality of evidence NIC generates;
- integrating evidence into program, practice, and policy decisions within NIC and the field; and
- improving the translation of evidence into practice.

NIC considers programs and practices to be evidence-based when their effectiveness has been demonstrated by causal evidence, generally obtained through one or more outcome evaluations. Causal evidence documents a relationship between an activity or intervention (including technology) and its intended outcome, including measuring the direction and size of a change, and the extent to which a change may be attributed to the activity or intervention. Causal evidence depends on the use of scientific methods to rule out, to the extent possible, alternative explanations for the documented change. The strength of causal evidence, based on the factors described above, will influence the degree to which NIC considers a program or practice to be evidence-based.

NIC training and technical assistance awardee standards. NIC has developed the [TA Handbook] to promote among providers the consistency and quality of NIC-sponsored training and technical assistance and to advance common expectations of performance excellence. The standards present minimum expectations that providers must meet for effective practice in the planning, coordination, delivery, and evaluation of training.

B. Federal Award Information

NIC expects to make one award for as much as **\$60,000.00** for a 12-month project period, beginning on **April 5, 2019**.

If the awardee demonstrates significant progress toward implementing project activities and achieving project goals, NIC may, in certain cases, provide supplemental funding for FY 2020 and FY 2021 to the awardee. With the supplemental funding, the project period can be extended up to two additional 12-month increments for an overall project period of 36 months. Important considerations in decisions regarding supplemental funding include, among other factors, the availability of funding, strategic priorities, assessment of the quality of the management of the award (for example, timeliness and quality of progress reports), and assessment of the progress of the work funded under the award.

All awards are subject to the availability of appropriated funds and to any modifications or additional requirements that may be imposed by law.

Type of award. NIC expects to make an award from this solicitation in the form of a cooperative agreement which is a particular type of grant used when NIC expects to have ongoing substantial involvement in award activities. Substantial involvement includes direct oversight and involvement with the grantee organization in implementation of the grant but does not involve day-to-day project management. See [Administrative, National Policy, and Other Legal Requirements](#), under Section [F. Federal Award Administration](#), for details regarding the federal involvement anticipated under an award from this solicitation.

Financial management and system of internal controls.

Award recipients and subrecipients (including recipients or sub recipients that are pass-through entities) must, as described in Part 200 Uniform Requirements as sent out as set out at 2 C.F.R. 200.303:

- (a) Establish and maintain effective internal control over the federal award that provides reasonable assurance that the nonfederal entity is managing the federal award in compliance with federal statutes, regulations, and the terms and conditions of the federal award. These internal controls should be in compliance with guidance in “Standards for Internal Control in the Federal Government” issued by the Comptroller General of the United States and the “Internal Control Integrated Framework”, issued by the Committee of Sponsoring Organizations of the Treadway Commission (COSO).
- (b) Comply with federal statutes, regulations, and the terms and conditions of the federal awards.
- (c) Evaluate and monitor the nonfederal entity's compliance with statute, regulations, and the terms and conditions of federal awards.
- (d) Take prompt action when instances of noncompliance are identified, including noncompliance identified in audit findings.

- (e) Take reasonable measures to safeguard protected personally identifiable information and other information the federal awarding agency or pass-through entity designates as sensitive or the nonfederal entity considers sensitive consistent with applicable federal, state, and local laws regarding privacy and obligations of confidentiality.

Budget Information

Pre-Agreement Cost Approvals. NIC does not typically approve pre-agreement costs; an applicant must request and obtain the prior written approval of NIC for all such costs. If approved, pre-agreement costs could be paid from grant funds consistent with a grantee's approved budget, and under applicable cost standards. However, all such costs prior to award and prior to approval of the costs are incurred at the sole risk of an applicant.

Generally, no applicant should incur project costs *before* submitting an application requesting federal funding for those costs. Should there be extenuating circumstances that appear to be appropriate for NIC's consideration as pre-agreement costs, the applicant should contact the point of contact listed on the title page of this announcement for details on the requirements for submitting a written request for approval.

Limitation on use of award funds for employee compensation; waiver. With respect to any award of more than \$250,000 made under this solicitation, recipients may not use federal funds to pay total cash compensation (salary plus cash bonuses) to any employee of the award recipient at a rate that exceeds 110 percent of the maximum annual salary payable to a member of the Federal Government's Senior Executive Service (SES) at an agency with a Certified SES Performance Appraisal System for that year. The 2019 salary table for SES employees is available at the Office of Personnel Management [website](#). Note: A recipient may compensate an employee at a greater rate, provided the amount in excess of this compensation limitation is paid with non-federal funds. (Any such additional compensation will not be considered matching funds where match requirements apply.)

D. Application and Submission Information

What an Application Should Include

Applicants should anticipate that if they fail to submit an application that contains all of the specified elements, it may negatively affect the review of their application; and, should a decision be made to make an award, it may result in the inclusion of special

conditions that preclude the recipient from accessing or using award funds pending satisfaction of the conditions.

Moreover, applicants should anticipate that applications that are determined to be nonresponsive to the scope of the solicitation, do not request funding within the funding limit, or that do not include the application elements that NIC has designated to be critical, will neither proceed to peer review nor receive further consideration. Under this solicitation, NIC has designated the following application elements as critical: Program Narrative, Budget Detail Worksheet or Budget Narrative.

Applicants should review the “Note on File Names and File Types” under [How To Apply](#) to be sure that they submit their applications in the permitted formats.

NIC strongly recommends that applicants use appropriately descriptive file names (e.g., “Program Narrative,” “Budget Detail Worksheet and Budget Narrative,” “Timelines,” “Memoranda of Understanding,” “Résumés”) for all attachments. Also, NIC recommends that applicants include résumés in a single file.

1. Information to Complete the Application for Federal Assistance (SF-424)

The SF-424 is a required standard form used as a cover sheet for submission of pre-applications, applications, and related information. This form can be found on Grants.gov and NIC’s website www.nicic.gov.

Intergovernmental review. This funding opportunity is **not** subject to [Executive Order 12372](#). (In completing the SF-424, applicants are to make the appropriate selection in response to question 19 to indicate that the “Program is not covered by E.O. 12372.”)

2. Project Abstract

Applications should include a high-quality project abstract that summarizes the proposed project in 400 words or less. Project abstracts should be

- written for a general public audience;
- submitted as a separate attachment with “Project Abstract” as part of its file name; and
- single-spaced, using a standard 12-point font (Times New Roman) with 1-inch margins.

As a separate attachment, the project abstract will **not** count against the page limit for the program narrative.

The abstract should briefly describe the project’s purpose, the population to be served, and the activities that the applicant will implement to achieve the project’s goals and objectives. The abstract should describe how the applicant will measure progress toward these goals.

3. Program Narrative

Applicants must submit a program narrative that presents a detailed description of the purpose, goals, objectives, strategies, design, and management of the proposed program. The program narrative should be double-spaced with 1-inch margins, not

exceeding 30 pages of 8½ by 11 inches, and use a standard 12-point font, preferably Times New Roman. Pages should be numbered “1 of 30,” etc. The tables, charts, pictures, etc., including all captions, legends, keys, subtext, etc., may be single-spaced and will count in the 30-page limit. Material required under the Budget and Budget Narrative and Additional Attachments sections will not count toward the program narrative page count. Applicants may provide bibliographical references as a separate attachment that will not count toward the 30-page program narrative limit. If the program narrative fails to comply with these length-related restrictions, NIC may consider such noncompliance in peer review and in final award decisions.

The program narrative should address the following selection criteria: (1) statement of the problem; (2) goals, objectives, and performance measures; (3) program design and implementation; and (4) capabilities/competencies. The applicant should clearly delineate the connections between and among each of these sections. For example, the applicant should derive the goals and objectives directly from the problems to be addressed. Similarly, the project design section should clearly explain how the program's structure and activities will accomplish the goals and objectives identified in the previous section.

The following sections should be included as part of the program narrative:

a. Statement of the problem.

Applicants should describe any research or evaluation studies that relate to the problem and contribute to the applicant's understanding of its causes and potential solutions. While NIC expects applicants to review the research literature for relevant studies, they should also explore whether unpublished local sources of research or evaluation data are available.

b. Goals, objectives, and performance measures. Applicants should describe the goals of the proposed training and technical assistance program and identify its objectives. When formulating the program's goals and objectives, applicants should be cognizant of the performance measures that NIC will require successful applicants to provide.

Goals. Applicants should describe the program's intent to deliver training and technical assistance, as described in the previous section and outline the project's goals.

Program objectives. Applicants should explain how the program will accomplish its goals. Objectives are specific, quantifiable statements of the project's desired results. They should be clearly linked to the training and technical assistance strategy identified in the preceding section and measurable.

Performance measures. NIC requires all applicants to submit quarterly progress reports demonstrating progress towards completion of the work proposed under this solicitation. The performance measures for this solicitation are:

NIC does not require applicants to submit performance measures data with their application. Performance measures are included as an alert that NIC will require successful applicants to submit specific data as part of their reporting requirements. For the application, applicants should indicate an understanding of these requirements and discuss how they will gather the required data, should they receive funding.

- c. Project design and implementation.** Applicants should detail how the project will operate throughout the funding period and describe the strategies that they will use to achieve the goals and objectives identified in the previous section. Applicants should describe how they will complete the deliverables stated in the Goals, Objectives, and Deliverables section on page 5. NIC encourages applicants to select evidence-based practices for their programs.

Logic model. Applicants should include a logic model that graphically illustrates how the performance measures are related to the project's problems, goals, objectives, and design. Applicants should submit the logic model as a separate attachment, as stipulated in Additional Attachments.

Timeline. Applicants should submit a milestone chart that indicates major tasks associated with the goals and objectives of the project, assigns responsibility for each, and plots completion of each task by month or quarter for the duration of the award, using "Year 1," "Month 1," "Quarter 1," etc., not calendar dates.

Applicants should submit the timeline as a separate attachment, as stipulated in Additional Attachments, page 19. On receipt of an award, the recipient may revise the timeline, based on training and technical assistance that NIC will provide.

- d. Capabilities and competencies.** This section should describe the experience and capability of the applicant organization and any contractors or subgrantees that the applicant will use to implement and manage this effort and its associated federal funding, highlighting any previous experience implementing projects of similar design or magnitude. Applicants should highlight their experience/capability/capacity to manage subawards, including details on their system for fiscal accountability. Management and staffing patterns should be clearly connected to the project design described in the previous section. Applicants should describe the roles and responsibilities of project staff and explain the program's organizational structure and operations. Applicants should include a copy of an organizational chart showing how the organization operates, including who manages the finances; how the organization manages subawards, if there are any; and the management of the project proposed for funding.

Letters of Support/Memoranda of Understanding. If submitting a joint application, as described under Section C: Eligibility Information, page 1, applicants should provide signed and dated letters of support or memoranda of understanding for all key partners that include the following:

- expression of support for the program and a statement of willingness to participate and collaborate with it;
- description of the partner's current role and responsibilities in the planning process and expected responsibilities when the program is operational; and

- estimate of the percentage of time that the partner will devote to the planning and operation of the project.

4. Budget Detail Worksheet and Budget Narrative

Applicants should provide a budget that (1) is complete, allowable, and cost-effective in relation to the proposed activities; (2) shows the cost calculations demonstrating how they arrived at the total amount requested; and (3) provides a brief supporting narrative to link costs with project activities. The budget should cover the entire award period.

- Budget Detail Worksheet.** The Budget Detail Worksheet should provide the detailed computation for each budget line item, listing the total cost of each and showing how it was calculated by the applicant. For example, cost for personnel should show the annual salary rate and the percentage of time devoted to the project for each employee paid with cooperative agreement funds. The Budget Detail worksheet should present a complete itemization of all proposed costs
- Budget Narrative.** The budget narrative should thoroughly and clearly describe every category of expense listed in the Budget Detail Worksheet. NIC expects proposed budgets to be complete, cost effective, and allowable (e.g., reasonable, allocable, and necessary for project activities).

Applicants should demonstrate in their budget narratives how they will maximize cost effectiveness of grant expenditures. Budget narratives should generally describe cost effectiveness in relation to potential alternatives and the goals of the project. For example, a budget narrative should detail why planned in-person meetings are necessary, or how technology and collaboration with outside organizations could be used to reduce costs, without compromising quality.

The narrative should be mathematically sound and correspond with the information and figures provided in the Budget Detail Worksheet. The narrative should explain how the applicant estimated and calculated all costs, and how they are relevant to the completion of the proposed project. The narrative may include tables for clarification purposes but need not be in a spreadsheet format. As with the Budget Detail Worksheet, the Budget Narrative should be broken down by year.

- Noncompetitive procurement contracts in excess of simplified acquisition threshold.** If an applicant proposes to make one or more non-competitive procurements of products or services, where the noncompetitive procurement will exceed the simplified acquisition threshold (also known as the small purchase threshold), which is currently set at \$150,000, the application should address the considerations outlined in 2 C.F.R.200.317 - 200.317.
- Preagreement cost approvals.** For information on pre-agreement costs, see Section [B. Federal Award Information](#).

5. Indirect Cost Rate Agreement (if applicable)

Indirect costs are allowed only if the applicant has a current federally approved indirect cost rate, this requirement does not apply to units of local government. Attach a copy of the federally approved indirect cost rate agreement to the application. Applicants that do not

have an approved rate may request one through their cognizant federal agency, which will review all documentation and approve a rate for the applicant organization, or, if the applicant's accounting system permits, costs may be allocated in the direct cost categories.

Indirect costs may be charged to an award only if:

- (a) The recipient has a current (unexpired), federally approved indirect cost rate; or
- (b) The recipient is eligible to use, and elects to use, the "de minimus" indirect cost rate described in the Part 200 Uniform Requirements as set out at 2 C.F.R. 200.414

6. Tribal Authorizing Resolution

Tribes, tribal organizations, or third parties proposing to provide direct services or assistance to residents on tribal lands should include in their applications a resolution, letter, affidavit, or other documentation, as appropriate, that certifies that the applicant has the legal authority from the tribe(s) to implement the proposed project on tribal lands. In those instances when an organization or consortium of tribes applies for a grant on behalf of a tribe or multiple specific tribes, the application should include appropriate legal documentation, as described above, from all tribes that would receive services or assistance under the grant. A consortium of tribes for which existing consortium bylaws allow action without support from all tribes in the consortium (i.e., without an authorizing resolution or comparable legal documentation from each tribal governing body) may submit, instead, a copy of its consortium bylaws with the application.

7. Applicant Disclosure of High Risk Status

Applicants are to disclose whether they are currently designated high risk by another federal grant making agency. This includes any status requiring additional oversight by the federal agency due to past programmatic or financial concerns. If an applicant is designated high risk by another federal grant making agency, you must submit the following information to at the time of application submission:

- the federal agency that currently designated the applicant as high risk;
- date the applicant was designated high risk;
- the high risk point of contact name, phone number, and email address, from that federal agency; and
- reasons for the high risk status as set out by the federal awarding agency.

NIC seeks this information to ensure appropriate federal oversight of any grant award. Unlike the Excluded Parties List, this high risk information does not disqualify any organization from receiving an NIC award. However, additional oversight may be included, if necessary, in award documentation.

8. Additional Attachments

Applicants should submit the following information, as stipulated in the cited pages, as attachments to their applications. While the materials listed below are not assigned specific point values, peer reviewers will, as appropriate, consider these items when rating applications. For example, reviewers will consider résumés and/or letters of support/ memoranda of understanding when assessing "capabilities/competencies." Peer

reviewers will not consider any additional information that the applicant submits other than that specified below.

- a. Applicant disclosure of pending applications.** Applicants are to disclose whether they have pending applications for federally funded grants or subgrants (including cooperative agreements) that include requests for funding to support the same project being proposed under this solicitation and will cover the identical cost items outlined in the budget narrative and worksheet in the application under this solicitation. The disclosure should include both direct applications for federal funding (e.g., applications to federal agencies) and indirect applications for such funding (e.g., applications to state agencies that will subaward federal funds).

NIC seeks this information to help avoid any inappropriate duplication of funding. Leveraging multiple funding sources in a complementary manner to implement comprehensive programs or projects is encouraged and is not seen as inappropriate duplication.

Applicants that have pending applications as described above are to provide the following information about pending applications submitted within the last 12 months:

- the federal or state funding agency;
- the solicitation name/project name; and
- the point of contact information at the applicable funding agency.

Applicants should include the table as a separate attachment, with the file name "Disclosure of Pending Applications," to their application. Applicants that do not have pending applications as described above are to include a statement to this effect in the separate attachment page (e.g., "[Applicant Name on SF-424] does not have pending applications submitted within the last 12 months for federally funded grants or subgrants (including cooperative agreements) that include requests for funding to support the same project being proposed under this solicitation and will cover the identical cost items outlined in the budget narrative and worksheet in the application under this solicitation.").

- b.** Logic model.
- c.** Timeline or milestone chart.
- d.** Résumés of all key personnel.
- e.** Job descriptions outlining roles and responsibilities for all key positions.

- f. Letters of support/memoranda of understanding from partner organizations.
- g. Evidence of nonprofit status, e.g., a copy of the tax exemption letter from the Internal revenue Service, if applicable.
- h. Evidence of for-profit status, e.g., a copy of the articles of incorporation, if applicable.

9. Disclosure of Lobbying Activities

All applicants must complete this information. Applicants that expend any funds for lobbying activities are to provide the detailed information requested on the form Disclosure of Lobbying Activities (SF-LLL). Applicants that do not expend any funds for lobbying activities are to enter “N/A” in the text boxes for item 10 (“a. Name and Address of Lobbying Registrant” and “b. Individuals Performing Services”).

How to Apply

Applicants must register in and submit applications through Grants.gov, a “one-stop storefront” to find federal funding opportunities and apply for funding. Find complete instructions on how to register and submit an application [here](#). Applicants that experience technical difficulties during this process should call the Grants.gov Customer Support Hotline at **800-518-4726** or **606-545-5035**, 24 hours a day, 7 days a week, except federal holidays.

Registering with Grants.gov is a one-time process; however, **processing delays may occur, and it can take several weeks** for first-time registrants to receive confirmation and a user password. NIC encourages applicants to **register several weeks before** the application submission deadline. In addition, NIC urges applicants to submit applications 72 hours prior to the application due date to allow time to receive validation messages or rejection [notifications](#) from Grants.gov, and to correct in a timely fashion any problems that may have caused a rejection notification.

All applicants are required to complete the following steps:

NIC may not make a federal award to an applicant until the applicant has complied with all applicable DUNS and SAM requirements. If an applicant has not fully complied with the requirements by the time the federal awarding agency is ready to make a federal award, the federal awarding agency may determine that the applicant is not qualified to receive a federal award and use that determination as a basis for making a federal award to another applicant.

Registration and Submission Steps

1. **Acquire a Data Universal Numbering System (DUNS) number.** In general, the Office of Management and Budget requires that all applicants (other than individuals) for federal funds include a DUNS number in their applications for a new award or a supplement to an existing award. A DUNS number is a unique nine-digit sequence recognized as the universal standard for identifying and differentiating entities receiving federal funds. The identifier is used for tracking purposes and validating address and point of contact information for federal assistance applicants, recipients, and sub-recipients. The DUNS number will be used throughout the grant life cycle. Obtaining a DUNS number is a free, one-time activity. 2. **Acquire or maintain registration with the System for Award Management (SAM).** SAM is the repository for standard information about federal financial assistance applicants, recipients, and subrecipients. NIC requires all applicants (other than individuals) for federal financial assistance to maintain current registrations in the SAM database. Applicants must be registered in SAM to successfully register in Grants.gov, failure to register with SAM will prevent your organization from applying through Grants.gov. Applicants must **update or renew their SAM registration annually** to maintain an active status.

Applicants cannot successfully submit their applications until Grants.gov receives the SAM registration information. **The information transfer from SAM to Grants.gov can take as long as 48 hours.** NIC recommends that the applicant register or renew registration with SAM as early as possible.

3. **Acquire an Authorized Organization Representative (AOR) and a Grants.gov username and password.** Complete the AOR profile on Grants.gov and create a username and password. Applicant organizations must use their DUNS number to complete this step. For more information about the registration process, go [here](#).
4. **Acquire confirmation for the AOR from the E-Business Point of Contact (E-Biz POC).** The E-Biz POC at the applicant organization must log into Grants.gov to confirm the applicant organization's AOR. When applications are submitted through Grants.gov, the name of the organization's AOR that submitted the application is inserted into the signature line of the application, serving as the electronic signature. The EBiz POC must

authorize individuals who are able to make legally binding commitments on behalf of the organization as an AOR; this step is often missed and it is crucial for valid and timely submissions

5. **Search for the funding opportunity on Grants.gov.** Use the following identifying information when searching for the funding opportunity on Grants.gov. The Catalog of Federal Domestic Assistance number for this solicitation is **16.601** and the funding opportunity number is **NIC-19CS08**.
6. **Access Funding Opportunity and Application package from Grants.gov.** Select “Apply for Grants” under the “Applicants” column. Enter you email address to be notified of any changes to the opportunity package before the closing date. Click the Workspace icon to use Grants.gov Workspace.
7. **Submit a valid application consistent with this solicitation by following the directions in Grants.gov.** Within 24–48 hours after submitting the electronic application, the applicant should receive two notifications from Grants.gov. The first will confirm the receipt of the application and the second will state whether the application has been successfully validated, or rejected due to errors, with an explanation. It is possible to first receive a message indicating that the application is received and then receive a rejection notice a few minutes or hours later. Adobe Reader: If you decide not to apply by filling out webforms you can download individual PDF forms in Workspace so that they will appear similar to other Standard or National Institute of Corrections forms. The individual PDF forms can be downloaded and saved to your local device storage, network drive(s), or external drives, then accessed through Adobe Reader.

b. **Mandatory Fields in Forms:** In the forms, you will note fields marked with an asterisk and a different background color. These fields are mandatory fields that must be completed to successfully submit your application.

c. **Complete SF-424 Fields First:** The forms are designed to fill in common required fields across other forms, such as the applicant name, address, and DUNS number. To trigger this feature, an applicant must complete the SF-424 information first. Once it is completed, the information will transfer to the other forms.

3) **Submit a Workspace:** An application may be submitted through workspace by clicking the Sign and Submit button on the Manage Workspace page, under the Forms tab. Grants.gov recommends submitting your application package at least 24-48 hours prior to the close date to provide you with time to correct any potential technical issues that may disrupt the application submission.

4) **Track a Workspace:** After successfully submitting a workspace package, a Grants.gov Tracking Number (GRANTXXXXXXXX) is automatically assigned to the package. The number will be listed on the Confirmation page that is generated after submission.

4. Timely Receipt Requirements and Proof of Timely Submission

a. **Online Submission.** Proof of timely submission is automatically recorded by Grants.gov. An electronic date/time stamp is generated within the system when the application is successfully received by Grants.gov. The applicant AOR will receive an acknowledgement of receipt and a tracking number (GRANTXXXXXXXX) from Grants.gov with the successful transmission of their application. Applicant AORs will also receive the official date/time stamp and Grants.gov Tracking number in an email serving as proof of their timely submission.

When the National Institute of Corrections successfully retrieves the application from Grants.gov, and acknowledges the download of submissions, Grants.gov will provide an electronic acknowledgment of receipt of the application to the email address of the applicant with the AOR role. Again, proof of timely submission shall be the official date and time that Grants.gov receives your application. Applications received by Grants.gov after the established due date for the program will be considered late and will not be considered for funding by the National Institute of Corrections.

Applicants using slow internet, such as dial-up connections, should be aware that transmission can take some time before Grants.gov receives your application. Again, Grants.gov will provide either an error or a successfully received transmission in the form of an email sent to the applicant with the AOR role. The Grants.gov Support Center reports that some applicants end the transmission because they think that nothing is occurring during the transmission process. Please be patient and give the system time to process the application.

Experiencing Unforeseen Grants.gov Technical Issues

Applicants that experience unforeseen Grants.gov technical issues beyond their control that prevent them from submitting their application by the deadline must contact the Grants.gov [Customer Support Hotline](#) or the [SAM Help Desk](#) to report the technical issue and receive a tracking number. The applicant must e-mail the Response Center at BOP-NIC/General@bop.gov **within 24 hours after the application deadline** and request approval to submit their application. The e-mail must describe the technical difficulties, and include a timeline of the applicant's submission efforts, the complete grant application, the applicant's DUNS number, and any Grants.gov Help Desk or SAM tracking number(s). **Note: NIC does not automatically approve requests.** After the program office reviews the submission and contacts the Grants.gov or SAM Help Desks to validate the reported technical issues, NIC will inform the applicant whether the request to submit a late application has been approved or denied. If NIC determines that the applicant failed to follow all required procedures, which resulted in an untimely application submission, NIC will deny the applicant's request to submit their application.

The following conditions are insufficient to justify late submissions:

- failure to register in SAM or Grants.gov in sufficient time; (SAM registration and renewal can take as long as 10 business days to complete. The information transfer from SAM to Grants.gov can take up to 48 hours.)
- failure to follow Grants.gov instructions on how to register and apply as posted on its website;
- failure to follow each instruction in the NIC solicitation; and
- technical issues with the applicant's computer or information technology environment, including firewalls.

E. Application Review Information

Selection Criteria

The following three (3) selection review criteria will be used to evaluate each application, with the different weight given to each based on the percentage value listed after each individual criteria. For example, the first criteria, Programmatic Review, is worth 40 percent of the entire score in the application review process.

1. Programmatic Review (40)
 - a. Project tasks adequately discussed?
 - b. Clear statement of how each task will be accomplished?
 - c. New approaches, techniques, or design aspects to enhance the project?
2. Organizational Review (35)
 - a. Skills of the proposed project members.
 - b. Organizational capacity to complete all project tasks.
 - c. Realistic and sufficient project and management plans to complete within the

time frame.

3. Management/Administrative Review (25)
 - a. Identification of reasonable objectives.
 - b. Reasonable justification for inclusion of consultants or partnerships if used.
 - c. Realistic budget proposed.

See section What an Application Should Include for the criteria that the peer reviewers will use to evaluate applications.

Review Process

NIC is committed to ensuring a fair and open process for awarding grants. NIC reviews the application to make sure that the information presented is reasonable, understandable, measurable, and achievable, as well as consistent with the solicitation.

Peer reviewers will review the applications submitted under this solicitation that meet basic minimum requirements. For purposes of assessing whether applicants have met basic minimum requirements, NIC screens applications for compliance with specified program requirements to help determine which applications should proceed to further consideration for award. Although program requirements may vary, the following are common requirements applicable to all solicitations for funding under NIC grant programs:

- Applications must be submitted by an eligible type of applicant.
- Applications must request funding within programmatic funding constraints (if applicable).
- Applications must be responsive to the scope of the solicitation.
- Applications must include all items designated as “critical elements”.
- Applicants will be checked against the General Services Administration’s Excluded Parties List.

NIC may use internal peer reviewers, external peer reviewers, or a combination, to assess applications meeting basic minimum requirements on technical merit using the solicitation’s selection criteria. An external peer reviewer is an expert in the subject matter of a given solicitation who is not a current DOJ employee. An internal reviewer is a current NIC employee who is well-versed or has expertise in the subject matter of this solicitation. A peer review panel will evaluate, score, and rate applications that meet basic minimum requirements. Peer reviewers’ ratings and any resulting recommendations are advisory only, although their views are considered carefully. In addition to peer review ratings, considerations for award recommendations and decisions may include, but are not limited to, underserved populations, geographic diversity, strategic priorities, past performance under prior NIC and NIC awards, and available funding.

NIC reviews applications for potential discretionary awards to evaluate the risks posed by applicants before they receive an award. This review may include but is not limited to the following:

1. Financial stability and fiscal integrity.
2. Quality of management systems and ability to meet the management standards prescribed in the Financial Guide.
3. History of performance.
4. Reports and findings from audits.
5. The applicant's ability to effectively implement statutory, regulatory, or other requirements imposed on non-Federal entities.
6. Proposed costs to determine if the Budget Detail Worksheet and Budget Narrative accurately explain project costs, and whether those costs are reasonable, necessary, and allowable under applicable federal cost principles and agency regulations.

Absent explicit statutory authorization or written delegation of authority to the contrary, all final award decisions will be made by the NIC Director, who may consider factors including, but not limited to, peer review ratings, underserved populations, geographic diversity, strategic priorities, past performance under prior NIC awards, and available funding when making awards.

F. Federal Award Administration Information

Federal Award Notices

NIC award notification will be sent from NIC's Office via FedEx or USPS within 45 days of the award decision.

Administrative, National Policy, and Other Legal Requirements

If selected for funding, in addition to implementing the funded project consistent with the agency-approved project proposal and budget, the recipient must comply with award terms and conditions, and other legal requirements, including but not limited to OMB or other federal regulations that will be included in the award, incorporated into the award by reference, or are otherwise applicable to the award. NIC strongly encourages prospective applicants to review the information pertaining to these requirements **prior** to submitting an application.

As stated above, NIC anticipates that it will make any award from this solicitation in the form of a cooperative agreement. Cooperative agreement awards include standard "federal involvement" conditions that describe the general allocation of responsibility for execution of the funded program. Generally-stated, under cooperative agreement awards, responsibility for the day-to-day conduct of the funded project rests with the recipient in implementing the funded and approved proposal and budget, and the award terms and conditions.

Responsibility for oversight and redirection of the project, if necessary, rests with NIC. NIC's role will include the following tasks:

- reviewing and approving major work plans, including changes to such plans, and key decisions pertaining to project operations;
- reviewing and approving major project-generated documents and materials used in the provision of project services; and

- providing guidance in significant project planning meetings and participating in project sponsored training events or conferences.

In addition to any “federal involvement” condition(s), NIC cooperative agreement awards include a special condition specifying certain reporting requirements required in connection with conferences, meetings, retreats, seminars, symposium, training activities, or similar events funded under the award, consistent with NIC policy and guidance on conference approval, planning, and reporting.

Plain Language

The successful applicant shall ensure that relevant deliverables (with information regarding a service, benefit, or requirement provided by the government) conform to the Plain Writing Act of 2010, meaning that it should contain only writing that is clear and that outlines information in manner that is easy to use. Paperwork Reduction Act

In accordance with the Paperwork Reduction Act (PRA), Cooperative Agreement awardee shall not proceed with collecting information from surveys, questionnaires, or interviews until Project Monitor obtains approval from Office of Management and Budget clearance. For any Cooperative Agreement award involving a requirement to collect or record information calling either for answers to identical questions from 10 or more persons other than Federal employees, or information from Federal employees which is outside the scope of their employment, for use by the Federal Government or disclosure to third parties, the Cooperative Agreement awardee must comply with the PRA of 1995 (44 U.S.C. 3501et seq.).
