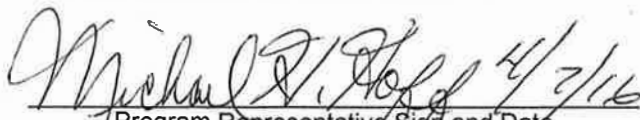

Under FY15 appropriations to the Great Lakes Restoration Initiative (GLRI), the U.S. Fish and Wildlife Service (FWS) intends to enter into a sole source Cooperative Agreement with the Illinois Department of Natural Resources (IDNR), to award, without competition, financial and technical support to implement projects required under the 2015 Inter-agency Asian Carp Control Strategy Framework (<http://asiancarp.us/documents/2015Framework.pdf>). The award will support specific activities, and require specific deliverables of the each agency that only they can conduct and deliver under the 2015 Asian Carp Control Strategy Framework. The work conducted cooperatively under this Cooperative Agreement continues work activities initiated in 2010, and continued since.
