Per NOFO Section A Basic Information (page 5), "USAID intends to award one (1) award with renewal periods pursuant to this notice of funding opportunity. Yes, applicants can be involved in incubation for young people who want to set up business, if the activity will support achievement of the Objectives described in NOFO Section C. Program Description (page 10).

As per NOFO Section C Program Description, (page 9), "The Activity will build the capacity of energy stakeholders (including developers, electrification agencies, industry associations, cooperatives, savings and credit groups, and other enterprises, institutions, decision-makers, and consumers). "It continues to state, "the Activity will pay special attention to building the knowledge, skills, abilities of women, youth, and other underrepresented populations, including but not limited to female business and advocacy group leaders."

NOFO Attachment 8 Concept Paper Format states, "Describe all proposed activities, including rationale, planned inputs, and anticipated outputs." Applicants must propose the number of projects/beneficiaries. NOFO Section C Program Description (page 10), "Targets and data collection methods for the program will be established upon award in accordance with the Power Africa MEL plan."

Organizations should comply with legal registration requirements of the country where they intend to implement. If an applicant intends to only implement short term training in a country, then perhaps it isn't required.
