Overview

The [U.S. Department of Justice](#) (DOJ), [Office of Justice Programs](#) (OJP), [Office for Victims of Crime](#), (OVC) is seeking applications for funding for the development, operation, and management of the Office for Victims of Crime's National Center for Culturally Responsive Victim Services. This program furthers the Department's mission by providing training and technical assistance to increase access to victim services and victim compensation for victims of crime in areas that have been historically underserved, marginalized, and adversely affected by inequality.

This solicitation incorporates the [OJP Grant Application Resource Guide](#) by reference. The OJP Grant Application Resource Guide provides guidance to applicants for the preparation and submission to OJP of applications for funding. **If this solicitation expressly modifies any provision in the OJP Grant Application Resource Guide, the applicant is to follow the guidelines in this solicitation as to that provision.**

To advance Executive Order 13929 Safe Policing for Safe Communities, as of October 28, 2020, the Attorney General determined that all state, local, and university or college law enforcement agencies must be certified by an approved independent credentialing body or have started the certification process to be allocated FY 2021 DOJ discretionary grant funding, as either a recipient or a subrecipient. All recipients and subrecipients (including any for-profit organization) must forgo any profit or management fee.

OVC will consider applications under which two or more entities would carry out the federal award; however, only one entity may be the applicant. Any others must be proposed as subrecipients (subgrantees). For additional information on subawards, see the [OJP Grant Application Resource Guide](#).

OVC may elect to fund applications submitted under this FY 2021 solicitation in future fiscal years, dependent on, among other considerations, the merit of the applications and on the availability of appropriations.

To be considered timely, the full application must be submitted in JustGrants by the JustGrants application deadline.

Program Description

Overview

The Department of Justice is committed to advancing work that promotes civil rights, increases access to justice, supports crime victims, protects the public from crime and evolving threats, and builds trust between law enforcement and the community.

The program provides for the development, operation, and management of the Office for Victims of Crime's National Center for Culturally Responsive Victim Services (the Center). The Center will facilitate the delivery of national-scale, high-quality training and technical assistance to increase access to victim services and victim compensation for victims of crime in areas that have been historically underserved, marginalized, and adversely affected by inequality, including communities of color. See Executive Order 13985, *Advancing Racial Equity and Support for Underserved Communities Through the Federal Government* § 2(b) ([January 20, 2021](#)) (defining "underserved communities"). The Center will increase the capacity of community-based organizations to address the critical need for culturally relevant, trauma-informed, victim-centered services. The Center's efforts will also align with the Federal government's goal in advancing equity for all, as outlined in Executive Order 13985.

Statutory Authority

34 U.S.C. § 20103(c)(1)(A)

Specific Information

The Center will serve as a national resource to help analyze critical issues, provide education and outreach, develop resources, promote culturally relevant advocacy and intervention; and provide consultation, peer-to-peer learning opportunities and other technical assistance and training. The Center will inform public policy and improve culturally relevant, trauma-informed, victim-centered services for victims in the communities to be served. The Center will work to strengthen and support victim services provided by community- and faith-based organizations and other stakeholders who provide direct assistance to victims of crime as all or part of their mission. The Center will provide technical assistance to develop infrastructure that improves service delivery and builds capacity for the management of state and federal grants for victim services.

The grantee funded under this program should have an established record of representing and working on behalf of historically underserved communities, including communities of color, as its primary mission and demonstrate successful outcomes.

Goals, Objectives, Deliverables, and Timeline

Goals

The goals of this program are to: 1) promote racial equity in victim services and compensation by enhancing the organizational and programmatic capacity of victim service organizations run by and for historically underserved communities, including communities of color; 2) provide comprehensive, training and technical assistance to advance services to victims of crime; and 3) to build the capacity and infrastructure of organizations that provide victim services in underserved communities as all or part of their mission.

Objectives

1. Identify and reach out to organizations that serve victims in communities that have been historically underserved, marginalized, and adversely affected by persistent inequality, including communities of color, where there are few or no state or federally funded grantees or subgrantees that serve victims.
2. Conduct a needs assessment in those communities to: identify barriers that are inhibiting victims' awareness, access, and utilization of victim services and victim compensation; identify gaps in victim services to better understand the capacity of community-based organizations to provide culturally specific services to crime victims; and raise the awareness of those community-based organizations about state and federal programs, resources, and funding opportunities.
3. Develop and deliver culturally competent training and technical assistance to victim service providers, community- and faith-based organizations, and other stakeholders in historically underserved communities, including communities of color, that provide direct assistance to victims as all or part of their mission.
4. Enhance knowledge of and access to state and federal grant opportunities for organizations that serve victims of crime in underserved communities and provide training and technical assistance on programmatic and fiscal management of state and federal grant funds.

Deliverables

1. Develop an outreach plan to obtain insight from historically underserved communities, including communities of color. This could include conducting site visits and hosting listening sessions in the communities to be served.
2. Complete a needs assessment that identifies underlying causes of violence and victimization; barriers that inhibit victims in underserved communities from accessing services and victim compensation; and gaps in victim services.

3. Develop and implement a training and technical assistance capacity building strategy that addresses outreach to culturally specific community-based organizations in historically underserved communities, including communities of color, where there are few or no Victims of Crime Act (VOCA) programs; culturally competent training and technical assistance to victim service providers, community- and faith-based organizations, and other stakeholders in underserved communities who may provide services to crime victims as all or part of their mission; and increase knowledge of, and access to, state and federal victim service grant opportunities to strengthen and sustain organizations in the identified communities.
4. Work collaboratively with OVC and other OVC technical assistance providers, particularly those working with VOCA State Administrators, to advance access to victims services and compensation in historically underserved communities, including communities of color.
5. Develop a report on the success of the project in meeting OVC goals and objectives.
6. Complete and submit financial, progress, and other reports as required by the cooperative agreement.

The Goals, Objectives, and Deliverables are directly related to the performance measures that demonstrate the results of the work completed, as discussed under Application and Submission Information.

Evidence-Based Programs or Practices

The Department of Justice is committed to advancing work that promotes civil rights, increases access to justice, supports crime victims, protects the public from crime and evolving threats, and builds trust between law enforcement and the community. In FY 2021, OJP will give priority consideration in award decisions to applications that demonstrate ways in which their projects will advance one or more of these areas.

To receive priority consideration for advancing one or more of the Department's priorities, the applicant must provide a sufficient narrative explanation as an attachment, that specifies how the project will advance the promotion of civil rights, access to justice, support to crime victims, protecting the public from crime and evolving threats, or building trust between law enforcement and the community.

In addition, OJP will give priority consideration, if applicable, to applicants that demonstrate that the individuals who are intended to benefit from the requested grant reside in high-poverty areas or persistent-poverty counties.

To receive priority consideration under the poverty priority, the applicant must provide information to demonstrate that the individuals who are intended to benefit from the requested grant reside in high-poverty areas or persistent poverty counties. For purposes of this priority consideration, the term "high-poverty area" means any census tract with a poverty rate of at least 20 percent as measured by the 2013–2017 5-year data series available from the American Community Survey of the Census Bureau (applicants may search by census tract at <https://www.census.gov/acs/www/data/data-tables-and-tools/narrative-profiles/2017/>) and the term "persistent poverty counties" means any county that has had 20 percent or more of its population living in poverty over the past 30 years, as measured by the 1990 and 2000 decennial censuses and the most recent Small Area Income and Poverty Estimates (applicants may search by county at <https://www.census.gov/data/tables/time-series/dec/census-poverty.html> and at <https://www.census.gov/programs-surveys/saie.html>).

Proposal Abstract

A proposal abstract (no more than 400 words) summarizing the proposed project including primary activities, products and deliverables, the service area, and who will benefit from the proposed project, will be completed in the JustGrants Web-based form.

Proposal Narrative

The proposal narrative should be submitted as an attachment in JustGrants. The attached document should be double-spaced, using a standard 12-point Times New Roman font; have no less than 1-inch margin; and should not exceed 20 pages. Pages should be numbered and submitted as an attachment. If the proposal narrative fails to comply with these length restrictions, OVC may negatively consider such noncompliance in peer review and in final award decisions.

The following sections must be included as part of the proposal narrative:

a. Description of the Issue

1. Describe the problem to be addressed.
2. Describe the communities to be served.
3. Describe current services available to victims and gaps in services.
4. Describe the process for facilitating intentional, coordinated and mission-driven efforts to strengthen organizations to improve services in underserved communities, including communities of color.
5. Describe the challenge in filling these gaps.
6. Describe how the funding will alleviate the problem.

b. Project Design and Implementation

The application must provide a clear link between the proposed activities and the need identified in the “Statement of the Problem” section above.

This section must:

1. Describe in detail specific activities necessary for accomplishing each goal and objective of the proposed project.

2. Describe how the Center will implement the goals and objectives of the project.
3. Describe how the Center will work with key partners, stakeholders and victim service organizations who will assist in the implementation of this project.

c. Capabilities and Competencies

This section must:

1. Include a list of key personnel who may be responsible for managing and implementing the major developmental stages of the Center.
2. Describe the applicant's substantive expertise and experience in performing the duties of this project, as well as the ability to perform this work on a National scale.
3. Job descriptions and copies of resumes for proposed key staff positions who will manage or otherwise be involved in the project should be included, as a separate attachment not subject to the program narrative page limitation.
4. Responding entities should have the capability to conduct needs assessments and analyses describing the successful activities undertaken by the Center.
5. Describe demonstrable ties to the communities to be served and experience in providing culturally competent services.

d. Plan for Collecting the Data Required for this Solicitation's Performance Measures

The successful applicant will be responsible for measuring project performance. OJP will require each successful applicant to submit regular performance data that demonstrate the results of the work carried out under the award. The performance data directly relate to the goals, objectives, and deliverables identified under "Goals, Objectives, and Deliverables" in the Program Description. Award recipients will be required to submit performance measure data in the Performance Measurement Tool (PMT) and/or JustGrants. Further guidance on the post-award submission process will be provided, if selected for award. OVC will use this information to guide and evaluate the impact of the project. 3. Capabilities and Competencies (30%) - evaluate administrative and technical capacity of the applicant to successfully accomplish the goals and objectives, including the applicant's authentic, demonstrable connections to the communities to be served
4. Plan for Collecting the Data Required for this Solicitation's Performance Measures (5%) - evaluate the applicant's understanding of the performance data reporting requirements and the plan for collecting the required data.
5. Budget (10%) - evaluate for completeness, cost effectiveness, and allowability (e.g., reasonable, allocable, and necessary for project activities).
