OVERVIEW, RECIPIENT AND NPS SUBSTANTIAL INVOLVEMENT

Archaeology Southwest (ASW) will collaborate with the National Park Service (NPS) to identify and separate any human remains from faunal material using the methods and protocols discussed under Article III, Section A, Identification of Human Remains in Faunal Material and prepare a report summarizing the results of this effort, conduct research necessary to identify associated and unassociated funerary objects in the BIA collections and prepare a report of findings using the methods and protocols identified in Article III, Section A, Identification of Associated and Unassociated Funerary Objects, catalog archeological collections using the

methods and protocols identified in Article III, Section A, Catalog Records, and store archeological collections using the methods and protocols identified in Article III, Section A, Properly Stored Collections.

Substantial involvement on the part the National Park Service (NPS) is anticipated for the successful completion of the objectives to be funded by this award. NPS staff will select the collections to be cataloged under this project, train students on cataloging, storage, photography, and storage protocols and entry of information into ICMS. Assist the students with objects or situations that are not addressed by existing protocols, provide NAGPRA sensitivity training and guidance on the application of NAGPRA requirements to the overall project, work with the Recipient’s program coordinator on recruiting, interviewing, and recommending appropriate candidates, provide technical consultation throughout the ongoing work, review all products and the final project report and provide students with feedback and corrections needed for the products to meet standards, determine rehousing strategies and provide all supplies necessary for rehousing and other aspects of the project, and coordinate access to objects repositories necessary for the conduct and completion of this project.

SINGLE-SOURCE JUSTIFICATION

DEPARTMENT OF THE INTERIOR SINGLE SOURCE POLICY REQUIREMENTS
Department of the Interior Policy (505 DM 2) requires a written justification which explains why competition is not practicable for each single-source award. The justification must address one or more of the following criteria as well as discussion of the program legislative history, unique capabilities of the proposed recipient, and cost-sharing contribution offered by the proposed recipient, as applicable.
In order for an assistance award to be made without competition, the award must satisfy one or more of the following criteria: (1) Unsolicited Proposal – The proposed award is the result of an unsolicited assistance application which represents a unique or innovative idea, method, or approach which is not the subject of a current or planned contract or assistance award, but which is deemed advantageous to the program objectives; (2) Continuation – The activity to be funded is necessary to the satisfactory completion of, or is a continuation of an activity presently being funded, and for which competition would have a significant adverse effect on the continuity or completion of the activity; (3) Legislative intent – The language in the applicable authorizing legislation or legislative history clearly indicates Congress’ intent to restrict the award to a particular recipient of purpose; (4) Unique Qualifications – The applicant is uniquely qualified to perform the activity based upon a variety of demonstrable factors such as location, property ownership, voluntary support capacity, cost-sharing ability if applicable, technical expertise, or other such unique qualifications; (5) Emergencies – Program/award where there is insufficient time available (due to a compelling and unusual urgency, or substantial danger to health or safety) for adequate competitive procedures to be followed.

NPS did not solicit full and open competition for this award based the following criteria:

(4) Unique Qualifications -The cooperator is a member of an established Cooperative Ecosystem Studies Unit (CESU) network, and was awarded a Cooperative Agreement (P14AC00921) allowing

ASW to participate in specific tasks, and can provide the specific research and investigative support to conduct this particular task while providing an effective outcome for the National Park Service and the research project. As such, the applicant is uniquely qualified to perform the activity based on their participation as a Non-Profit Partner in the Cooperative Ecosystems Study Unit, their capacity to provide appropriate researchers, and their ability to broadly utilize research results as teaching tool.
