A2. Background, Purpose and Program Requirements

The Western Ecological Research Center of the U.S. Geological Survey (USGS) is offering a funding opportunity to a CESU Partner for research for the project is titled “Using environmental DNA to aid in Sierra Madre Yellow-legged Frog (*Rana muscosa*) recovery in southern California”

Project Goals: The overall goal of this project is to assess the efficacy and applications for eDNA analysis to find rare or listed species and associated potential predatory invasive species.

Specific Objectives:

1. Create assays of known co-occurring aquatic species for genetic comparison of eDNA samples.
2. Process 528 eDNA samples.
3. Analyze results of the sample run and quantify parameters such as DNA matching, signal strength, and any anomalies.
4. This project may continue for up to 5 years with additional samples.

Deliverables:

1. Raw scientific data that contributes to professional journal articles and presentations. Joint authorship of any manuscripts that result from this work.

The collection of environmental DNA (eDNA) has been used to determine presence of aquatic vertebrates, though strength of the signal and detectability varies from study to study in part due to biotic and abiotic factors including density of a species and variation in stream flow, light, and temperature (Goldberg et al. 2011; Pilliod et al. 2013). eDNA is collected by filtering water in the target stream to pick up skin cells shed from species within the aquatic environment. The

DNA can later be extracted from the filter paper and quantified using quantitative polymerase chain reaction (qPCR) techniques (Pilliod et al. 2013).

This information is especially useful where access to sites is limited and/or target species are rare and have not turned up in surveys but are suspected to be present. As such detectability of listed species and potential predatory exotic species may be determined at a broader geographic scale for the same or less effort compared to traditional detection surveys which require repeated days of searching at each site over an expansive area. The use of eDNA for sampling also allows for a reduction in permitting issues, and is less invasive on the habitat and species of interest compared to traditional sampling techniques.

In collaboration with universities, USGS scientists are interested in determining the efficacy of using eDNA to determine presence of the endangered Sierra Madre yellow-legged frog (*Rana muscosa*) in historic or known occupied streams throughout southern California. This declining species inhabits high mountain and remote streams which are often logistically and physically difficult to get to.

This CESU solicitation will enhance the ability of all federal and academic partners to focus research on questions related to critical resource restoration and provide the best available science to regulators and land managers to make management decisions.

1) *Create a Workspace*: Creating a workspace allows you to complete it online and route it through your organization for review before submitting.

2) *Complete a Workspace*: Add participants to the workspace to work on the application together, complete all the required forms online or by downloading PDF versions, and check for errors before submission. The Workspace progress bar will display the state of your application process as you apply. As you apply using Workspace, you may click the blue question mark icon near the upper-right corner of each page to access context-sensitive help.

b. *Mandatory Fields in Forms*: In the forms, you will note fields marked with an asterisk and a different background color. These fields are mandatory fields that must be completed to successfully submit your application.

c. *Complete SF-424 Fields First:* The forms are designed to fill in common required fields across other forms, such as the applicant name, address, and DUNS Number. Once it is completed, the information will transfer to the other forms.

3) *Submit a Workspace:* An application may be submitted through workspace by clicking the Sign and Submit button on the Manage Workspace page, under the Forms tab. An electronic date/time stamp is generated within the system when the application is successfully received by Grants.gov. The applicant with the AOR role who submitted the application will receive an acknowledgement of receipt and a tracking number (GRANTXXXXXXXX) from Grants.gov with the successful transmission of their application. This applicant with the AOR role will also receive the official date/time stamp and Grants.gov Tracking number in an email serving as proof of their timely submission.

When USGS successfully retrieves the application from Grants.gov, and acknowledges the download of submissions, Grants.gov will provide an electronic acknowledgment of receipt of the application to the email address of the applicant with the AOR role who submitted the application. 1. SF-424, Application for Federal Assistance

Data Management Plan Requirements

Proposals submitted to USGS must include a supplementary document of no more than four pages labeled "Data Management Plan" (DMP). A valid DMP may include only the statement that no detailed plan is needed (e.g. "No data are expected to be produced from this project"), as long as the statement is accompanied by a clear justification. This supplementary document may include:

- the types of data, samples, physical collections, software, curriculum materials, and other materials to be produced in the course of the project;

- the standards to be used for data and metadata format and content (where existing standards are absent or deemed inadequate, this should be documented along with any proposed solutions or remedies);
- policies for access and sharing including provisions for appropriate protection of privacy, confidentiality, security, intellectual property, or other rights or requirements;
