I. FUNDING OPPORTUNITY DESCRIPTION

A. AGENCY OVERVIEW

The Advanced Research Projects Agency – Energy (ARPA-E), an organization within the Department of Energy (DOE), is chartered by Congress in the America COMPETES Act of 2007 (P.L. 110-69), as amended by the America COMPETES Reauthorization Act of 2010 (P.L. 111-358), as further amended by the Energy Act of 2020 (P.L. 116-260):

- “(A) to enhance the economic and energy security of the United States through the development of energy technologies that—
- (i) reduce imports of energy from foreign sources;
 - (ii) reduce energy-related emissions, including greenhouse gases;
 - (iii) improve the energy efficiency of all economic sectors;
 - (iv) provide transformative solutions to improve the management, clean-up, and disposal of radioactive waste and spent nuclear fuel; and
 - (v) improve the resilience, reliability, and security of infrastructure to produce, deliver, and store energy; and
- (B) to ensure that the United States maintains a technological lead in developing and deploying advanced energy technologies.”

ARPA-E issues this Funding Opportunity Announcement (FOA) under its authorizing statute codified at 42 U.S.C. § 16538. The FOA and any cooperative agreements or grants made under this FOA are subject to 2 C.F.R. Part 200 as supplemented by 2 C.F.R. Part 910.

ARPA-E funds research on, and the development of, transformative science and technology solutions to address the energy and environmental missions of the Department. The agency focuses on technologies that can be meaningfully advanced with a modest investment over a defined period of time in order to catalyze the translation from scientific discovery to early-stage technology. ARPA-E funds transformational research. Existing energy technologies generally progress on established “learning curves” where refinements to a technology and the economies of scale that accrue as manufacturing and distribution develop drive improvements to the cost/performance metric in a gradual fashion. This continual improvement of a technology is important to its increased commercial deployment and is appropriately the focus of the private sector or the applied technology offices within DOE. In contrast, ARPA-E supports transformative research that has the potential to create fundamentally new learning curves. ARPA-E technology projects typically start with cost/performance estimates well above the level of an incumbent technology. Given the high risk inherent in these projects, many will fail to progress, but some may succeed in generating a new learning curve with a projected cost/performance metric that is significantly better than that of the incumbent technology.

ARPA-E funds technology with the potential to be disruptive in the marketplace. The mere creation of a new learning curve does not ensure market penetration. Rather, the ultimate value of a technology is determined by the marketplace, and impactful technologies ultimately become disruptive – that is, they are widely adopted and displace existing technologies from the marketplace or create entirely new markets. ARPA-E understands that definitive proof of market disruption takes time, particularly for energy technologies. Therefore, ARPA-E funds the development of technologies that, if technically successful, have clear disruptive potential, e.g., by demonstrating capability for manufacturing at competitive cost and deployment at scale.

ARPA-E funds applied research and development. The Office of Management and Budget defines “applied research” as an “original investigation undertaken in order to acquire new knowledge...directed primarily towards a specific practical aim or objective” and defines “experimental development” as “creative and systematic work, drawing on knowledge gained from research and practical experience, which is directed at producing new products or processes or improving existing products or processes.”¹ Applicants interested in receiving financial assistance for basic research (defined by the Office of Management and Budget as “experimental or theoretical work undertaken primarily to acquire new knowledge of the underlying foundations of phenomena and observable facts”)² should contact the DOE’s Office of Science (<http://science.energy.gov/>). Office of Science national scientific user facilities (<http://science.energy.gov/user-facilities/>) are open to all researchers, including ARPA-E Applicants and awardees. These facilities provide advanced tools of modern science including accelerators, colliders, supercomputers, light sources and neutron sources, as well as facilities for studying the nanoworld, the environment, and the atmosphere. B. PROGRAM OVERVIEW

The Creating Hardened And Durable fusion first Wall Incorporating Centralized Knowledge (CHADWICK) program will pursue discovery and testing of novel, first-wall materials that will maintain design performance over the target 40-year design lifetime of a fusion power plant.³ In most fusion power systems, the fusion reactions are physically contained by the first wall.

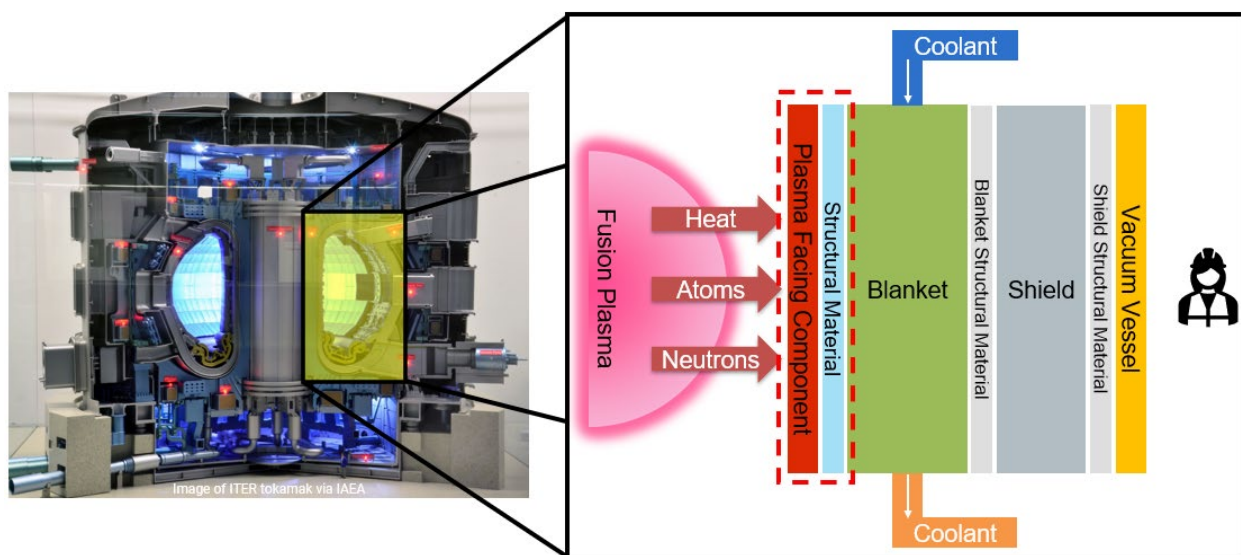


Figure 1. Conceptual illustration of a fusion power system from ITER and the layered components between the fusion plasma and the ambient environment.⁵

The first wall bears the mechanical load and protects the components from the extreme heat and highly energetic charged and neutral particles (Figure 1).⁴ The safety and structural performance of the first wall are compromised over time by significant exposure to high-energy (>1 million electron volts (MeV)) neutrons and heat flux as much as 10 megawatts per square meter (MW/m²). As fusion energy advances towards commercial deployment, the lifetime and maintainability of first-wall materials will become a major challenge for the commercial viability of fusion power plants with high neutron flux.

Thermal effects on materials are relatively well understood. However, the combination of heat plus an intense neutron environment can generate many nonlinear effects that are difficult to predict. Radiation most commonly damages a material by driving atomic displacements and the transmuting of isotopes within the material structure. Some transmutation events encourage the development of activation product gasses, such as hydrogen and helium, which encourage wall swelling. The combination of stresses caused by atomic dislocations, swelling, and thermal contraction and expansion drive material hardening and embrittlement, ultimately promoting premature cracking and failure.⁶ The most common descriptor for radiation damage is displacements per atom (dpa). These displacements can cause irradiation embrittlement leading to the loss of ductility in a material after exposure to radiation. Fusion power plant first-wall materials are anticipated to experience >50 dpa over the desired 40-year operational

period. Radiation damage has been observed to harden and embrittle first-wall materials at levels as low as 5 dpa.

The goal of the CHADWICK program is the discovery, development, and production of new materials that can maintain the following metrics in a fusion first-wall environment:

- Room temperature ductility after 50 dpa of irradiation damage and helium generation;
- Sufficiently high thermal conductivity to remove up to 10 MW/m² of heat;
- Activation below 10,000 Sieverts per hour (Sv/hr) to enable remote handling;
- Swelling below 1% to maintain dimensional stability; and
- Tritium retention and plasma erosion lower than current state-of-the-art (SoA) materials.

SoA materials under consideration for fusion first-wall applications are currently limited to reduced activation ferritic martensitic (RAFM) steels and tungsten.⁷ Both materials suffer from irradiation and helium embrittlement issues that make fusion power plants prohibitively expensive to qualify and operate.^{8,9} New materials that are highly resistant or functionally immune to irradiation embrittlement up to 50 dpa can increase the lifetime of the first wall by a factor of 10. These materials are envisioned to be essential to the deployment of sustained and economical fusion energy.

C. PROGRAM OBJECTIVES

The primary objective of the CHADWICK program is the development of new first-wall materials that will significantly improve the commercial viability of nuclear fusion. Commercial materials with known high-temperature resistance will often see severe embrittlement and swelling under irradiation.¹⁰ Materials that exhibit high irradiation resistance may show low thermal conductivity or high activation. Finding a material that has the most optimized performance for a fusion first wall is a major scientific and engineering challenge. The multi-objective optimization of new materials will challenge the scientific community to use the latest tools to solve the longstanding problem of finding a material that can survive in a fusion environment.

This program seeks to go beyond optimization of known alloys and provide a comprehensive wide-ranging survey and analysis of new material chemistries and manufacturing processes by

reimagining what is possible in fusion materials. For example, recent advancement in high entropy alloys (HEA) suggest higher strength can be found by combining three or more alloying elements in comparable amounts without sacrificing toughness or ductility.¹¹ Advancements and validation of computational multi-scale modeling such as density functional theory, objective kinetic Monte Carlo, and 3D dislocation dynamics have also enabled better predictive modeling of irradiated microstructure, allowing more sophisticated design of materials targeted specifically against irradiation damage.¹²

Under the ARPA-E Ultrahigh Temperature Impervious Materials Advancing Turbine Efficiency (ULTIMATE) program, more than 350 novel refractory alloys have been synthesized and experimentally validated for basic properties using high-throughput materials discovery approaches. Diverse materials processing routes such as additive manufacturing, powder metallurgy, melting, and casting have been successfully used to produce coupons of acceptable quality. Some of these alloys showed exceptional high-temperature strength (1300°C yield strength >350 megapascal (MPa)) without compromising the room temperature fracture toughness (>10 megapascal square root meter (MPa√m)).¹³ Similarly, ARPA-E's Galvanizing Advances in Market-aligned fusion for an Overabundance of Watts (GAMOW) program showed that laser powder bed fusion techniques can produce novel tungsten alloys at >95% density without room temperature cracking. Under the GAMOW program, five tons of nanostructured ferritic alloys were produced to validate the scalability of nanostructured materials.¹⁴

In addition to increasing the strength and density of a material, the first wall will require resistance to irradiation embrittlement, plasma erosion, tritium retention, low activation, and high thermal conductivity. It is crucial to leverage the tools available today to discover new materials that can solve fusion first-wall challenges, which will enable sustained operations of fusion power systems required for the commercialization of fusion energy in the future.

For the CHADWICK program, ARPA-E highly encourages computational and experimental material scientists to work together with metallurgists, chemists, nuclear engineers, irradiation experts, and data scientists to discover new materials that address the problem of irradiation embrittlement in a fusion environment (see Section I.D.3). Instead of testing all possible combinations of material elements and impurities, computational material scientists will use SoA modeling tools to down-select options to a subset that is reasonable for testing. It is

expected that new materials will be tested and analyzed in direct comparison with their current SoA counterparts to show improved performance. For the CHADWICK program, a new material is defined as having novel composition, microstructure, or macrostructure compared to existing commercially available products. This program is agnostic towards how the new material is discovered but will enforce strict interim and final metrics on material performance. More specific metrics for a particular area of research are presented in Section I.E Technical Performance Targets. Applicants shall describe their detailed approach on materials discovery and justification for how it can achieve the metrics of this program.

D. TECHNICAL CATEGORIES OF INTEREST

The CHADWICK program is comprised of three technical categories to support the program objectives outlined in Section I.C. Applicants can apply to Category A, Category B, a combination of Categories A and B, or Category C, based on their expertise. Category C capability teams will support analysis and facilitate communications between Category A and B project teams and fusion power system designer end users by performing techno-economic analyses (TEA) and life-cycle analyses (LCA) of their materials products. See Section I.F of the FOA for specifics of data-sharing requirements between Category A/B and Category C teams.

1. CATEGORY A – PLASMA-FACING COMPONENT MATERIALS

Applicants to this category will discover and validate materials that maintain room temperature ductility after significant irradiation damage and helium generation while satisfying the unirradiated thermal conductivity, plasma erosion, and tritium retention performance metrics of tungsten in fusion power system first-wall applications.

2. CATEGORY B – STRUCTURAL MATERIALS

Applicants to this category will discover and validate materials that maintain room temperature ductility after significant irradiation damage and helium generation while satisfying the unirradiated thermal, mechanical, and tritium retention performance metrics of RAFM steels in fusion power system first-wall applications.

3. CATEGORY C – CAPABILITY TEAMS

Applicants seeking to contribute an expert or specialist capability that could assist multiple Category A and/or B experimental teams in fulfilling program objectives should consider selecting Category C.

Applicants to this category will have the capability to consolidate the materials discovery and performance data generated within the program (more information is available in Section I.F). Category C teams will develop and maintain a materials database and perform TEA on fusion

power system concepts using different materials of construction and develop a material activation analysis tool for rapid assessment of radioactivity to support LCA of fusion materials. Capability teams will support project performers on digitization, standardization, and storage of materials data, and create the framework for TEA and LCA of fusion power system designs with various materials of construction. Capability teams will function as a resource for existing fusion designers to establish a baseline model that captures high-level requirements on first-wall materials, and model differing materials of construction to evaluate the impact on the total cost. Capability teams will also be responsible for assessing the radioactivity of new material compositions to ensure that Class C radioactive waste requirements will be met, as well as neutron activation metrics outlined in Section I.E.

4. CATEGORY AND TEAM LOGISTICS

For Categories A and/or B, submissions should include cross-functional teams, with each individual team capable of materials discovery, rapid synthesis and screening that minimizes humans in the loop, irradiation damage modeling, and irradiation and materials testing. The program is intended to bring together cutting-edge material screening and synthesis technologies with SoA irradiation physics modeling to create a new framework that can discover, synthesize, irradiate, test, and validate fusion materials within the maximum three-year Period of Performance. Applicants are strongly encouraged to utilize the Teaming Partner List Announcement, available via ARPA-E eXCHANGE (<https://arpa-e-foa.energy.gov>) to find collaborators with complementary expertise for submission to this program.

A team which proposes materials to solve both plasma-facing and structural needs may submit one joint application to both Categories A and B. A joint application will be judged by the criteria of both categories. For each submission, the teams must provide detailed descriptions of their approach for validating the performance metrics of the final material products.

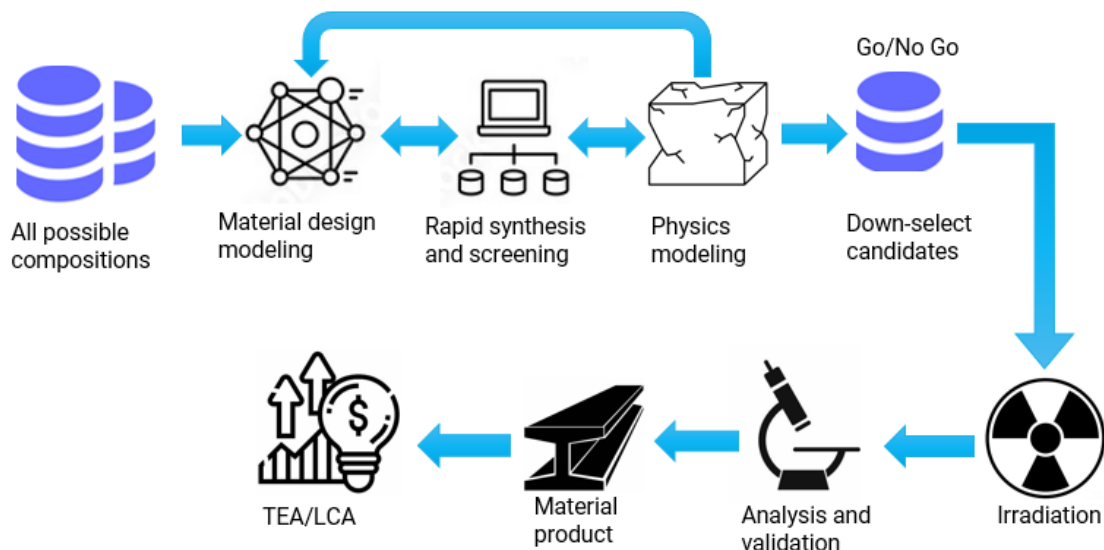


Figure 2. Sample process flow of a materials discovery framework for integrated irradiation testing of fusion first-wall materials.

Teams proposing to establish the process, standards, workflow, and tools necessary to rapidly screen and validate the cost performance of the materials products should apply to Category C. Teams in Category C will concurrently develop a tool for rapid assessment of radioactivity of new materials discovered by Category A and B teams. Such teams will also build and maintain a material performance database to conduct TEA and LCA. Figure 2 illustrates an example process flow and the expertise anticipated for the successful execution of projects under this program.

Each project team will have a Technology-to-Market component to promote paths to commercialization of fusion materials. The teams are expected to perform activities supporting market identification, investor engagement, and partnership with private fusion companies to commercialize their material or software product. When appropriate, connections to federal programs involved in finance scaling may be facilitated. The Technology-to-Market component also encourages engagement with community-based organizations for two-way dialogue surrounding waste streams originating from these materials and engagements with other

industry stakeholders. More information is available in Section IV.F.8 Technology Transfer and Outreach and Section VI.B.6 Technology-to-Market Plan.

Examples of technical approaches of interest for fusion materials discovery include but are not limited to:

- Advanced HEAs with high radiation resistance and high thermal conductivity;
- Novel oxide dispersion strengthened alloys with low irradiation embrittlement and low activation;
- High-temperature refractory alloys with increased ductility and low plasma erosion;
- High temperature ceramics with increased fracture toughness and low tritium retention;
- Coating or liquid plasma-facing material with low plasma erosion and low activation;
- Approaches that couple material physics modeling predictions of irradiated microstructure to aid in the optimization of irradiated properties that can be validated via testing;
- Approaches that leverage an AI/ML based materials discovery framework to accelerate the screening and analysis of material properties; and
- Approaches that leverage unique composition or structural advantages from advanced manufacturing techniques that have not been assessed under irradiation.

E. TECHNICAL PERFORMANCE TARGETS

Presently, there are many fusion power system concepts that show promise for eventual use in a fusion power plant. Each of the unique concepts has different loading conditions on their first wall. However, all first-wall materials for concepts that use deuterium and tritium as fuel are expected to suffer from significant irradiation embrittlement that will result in failures and

require frequent replacement. The technical performance targets for this program are focused on solving irradiation-related issues while maintaining or improving on the other requirements for the first wall.

Table 1 summarizes the performance target for the new material and the metrics to be measured by performers in Category A (Plasma-Facing Components), Category B (Structural Materials), and Category C (Capability Teams). The target metrics ensure the material will have better irradiation performance in key scenarios that can significantly reduce the operation and maintenance cost of fusion power systems. The metrics of irradiation to 50 dpa and equivalent helium content of 500 atomic parts per million (appm) are chosen to reflect the materials damage expected in a fusion-relevant environment. The irradiation embrittlement of materials from fission neutrons, which have a highly asymmetric energy distribution with most neutrons having energies between 1 MeV and 2 MeV, is observed to saturate at well below 50 dpa.^{15,16} However, fusion neutrons, which have an energy distribution that is strongly peaked at 14 MeV, could cause additional damage to materials in ways that are unanticipated. Domestic and international efforts are in progress to establish the capability to irradiate materials up to 50 dpa to retire that risk, but no facilities currently exist to irradiate materials using prototypical fusion neutrons.¹⁷ This program will allow the use of surrogate radiation sources or validated modeling extrapolations as defined by the Applicants to screen new materials irradiated to a dose anticipated to show the maximum embrittlement.

The key post-irradiation performance targets for the plasma-facing and structural materials for this program are irradiation embrittlement, swelling, and activation. Irradiation embrittlement is the loss of ductility of a material after exposure to radiation. This phenomenon has been observed in nuclear power plants and can become the life-limiting factor for nuclear components. For example, a typical stainless steel material is very ductile and allows for plastic

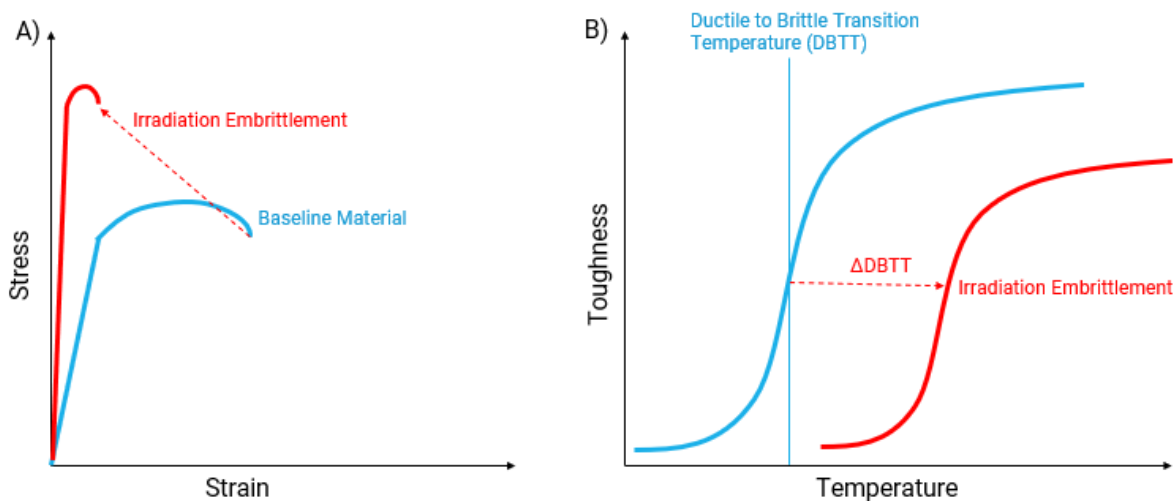


Figure 3. Schematic illustration of the change in a material's behavior after irradiation embrittlement. A) Stress strain curve showing the unirradiated material in blue and the expected increase in strength and reduction in ductility after irradiation in red. B) Fracture toughness curve showing the unirradiated material in blue and the expected increase in DBTT after irradiation in red.

deformation of more than 20% elongation in the unirradiated condition. This typical stainless steel loses its ductility and suffers brittle fracture after neutron irradiation levels as low as 2 dpa.¹⁸ Because the ductility of a material is also a function of temperature, irradiation embrittlement is typically measured as a shift in the ductile to brittle transition temperature (DBTT) of the fracture toughness. Figure 3 illustrates the general relationship between strength, elongation, and fracture toughness of an irradiated and unirradiated material. Previous studies on irradiated steels showed brittle fracture of a specimen irradiated to 4.3 dpa with a measured fracture toughness 28 MPaVm.¹⁹ This program seeks to find a material that can maintain fracture toughness of greater than 30 MPaVm at room temperature even after irradiation damage of up to 50 dpa. Any submissions to Category A or B shall provide a detailed description of the proposed irradiation conditions, mechanical testing, and analysis methods to validate the irradiation embrittlement of any newly discovered material.

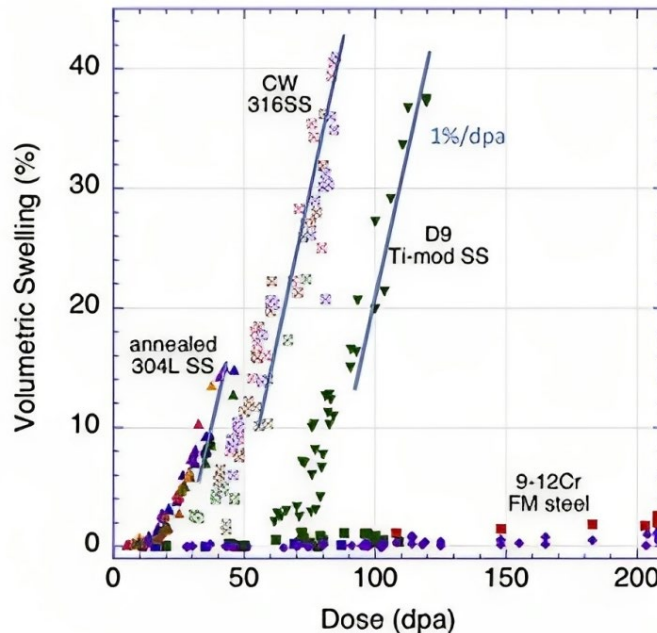


Figure 4. High dose irradiation swelling measured for stainless and ferritic martensitic (FM) steels. The different colors and symbols show different ion energies and irradiation facilities.²²

In addition to maintaining ductility, the first-wall material must also be reasonably resistant to swelling. The problem of irradiation swelling has been identified in previous tests related to advanced fission reactors that limits the lifetime of power plants. Figure 4 shows the extreme swelling rates of 1%/dpa that can occur in stainless steels after high dose irradiation.²⁰ The

current SoA RAFM steel is expected to swell less than <1% at 50 dpa.²¹ Any new materials discovered in this program must show the same level of low swelling behavior under high dose irradiation with high helium generation. Any submissions to Category A or B shall provide a detailed description of the proposed irradiation methodology and swelling analysis procedure to validate volumetric swelling behavior of any newly discovered materials.

Neutron activation of the first-wall material is a major constraint for maintenance, disposal, and licensing of any fusion power system. A preliminary analysis of a first-of-its-kind Tokamak design by the Advanced Research Innovation and Evaluation Study program suggests that it is feasible for radiation-hardened remote handling tools to accommodate highly irradiated materials up to a dose of 10,000 Sv/hr.²³ Studies on fusion waste have shown that some elements can cause excessive radioactivity for thousands of years after a single operational cycle in a commercial fusion power plant.²⁴ The excessive use of those elements (e.g., nickel, copper, molybdenum) will likely cause materials within the fusion power system to be too radioactive to be handled and disposed of.

Existing tools such as adaptive Laplacian and analytic radioactivity analysis, inventory simulation platform for nuclear observables and materials science, and open source Monte Carlo are currently being used to couple neutron and photon transport codes for shutdown dose activation analysis of fusion power systems.²⁵ Category C teams will further develop the toolset for general use and perform independent activation analysis on new materials discovered by Category A and B teams. Category C teams shall develop a standard methodology for baseline activation assessment of the new material assuming a 50 cm by 50 cm by 5 cm plate irradiated in a fusion first-wall environment for one year after three months decay. All new materials discovered shall be subject to the same activation analysis. As inputs to the activation analysis, Category A and B teams are required to provide detailed composition in weight percent and impurity information in parts per million of the newly discovered material to Category C teams. New materials with radioactivity expected to exceed 10,000 Sv/hr shall be flagged for the problematic isotopes to be identified and communicated to the program as part of the go/no go evaluations for the projects. See Section I.F, Data Storage and Access Plan, for the conditions that govern the exchange of such data.

Beyond the shared optimization targets for irradiation performance summarized in Table 1, Categories A and B have additional constraints unique to the intended function for each material. Unirradiated material properties of tungsten and RAFM steels set the minimum baseline acceptable values for the current SoA. Aspirational preferred values are provided as additional constraints for multi-variable optimization of any new material discovered by Category A and B teams.

Table 2 and Table 3 summarize the unique constraints related to plasma-facing and structural materials for a range of properties that are acceptable for Category A and B projects, respectively. The Applicants shall make the necessary effort to achieve the target values in Table 2 and Table 3 where possible, but must achieve the acceptable baseline values at minimum.

Thermal conductivity is a key metric measured in watts per meter-Kelvin (W/m-K) for the first-wall material due to the extremely high heat flux that is estimated to result from the fusion plasma. It is expected that in a commercial fusion power plant, as much as 10 MW/m² could be incident on the first wall.²⁶ Depending on the thickness of the plasma-facing and structural components, the ability to adequately transfer the heat away will be determined by the thermal conductivity of the material. The goal of the project is to ensure that any new material developed will have equivalent, if not better, heat removal capability than the material it is trying to replace. Therefore, the room temperature thermal conductivity of the new material for plasma-facing components in Category A should be better than 170 W/m-K of tungsten²⁷ and structural material in Category B should be better than 33 W/m-K of reduced activation steels.²⁸

High-temperature strength is a requirement for any material that will serve a structural function in high-temperature systems. Current SoA structural steels, including reduced RAFM steels, have sufficient high temperature strength to support most fusion power system designs. Similarly, any new structural materials discovered under this program must have similar strength at the anticipated operating temperatures within a fusion power system of 600-900°C.²⁹ Therefore, a high temperature strength constraint of higher than 280 MPa at 650°C will be imposed on Category B projects to provide reasonable assurance that any newly discovered structural material will not creep or buckle under normal operations. Since plasma-facing components do not serve a major structural function and may be a coating or be in the liquid phase, this constraint does not apply to Category A materials.

Excessive plasma erosion not only impacts the lifetime of plasma-facing components, but also results in sputtered and evaporated materials depositing and building up elsewhere, including as impurities in the fusion plasma that can severely degrade plasma performance. Current estimates on plasma erosion predict mass loss on the order of 1,000 kgs per year in commercial fusion power plant operations.³⁰ At minimum, a 30 mm thick piece of tungsten needs to show erosion rates less than 3.4 μm per hour to survive one year. Previous studies have shown blister formation and weight loss of tungsten after deuterium plasma bombardment up to 10^{26} ions/ m^2 at 550°C.³¹ The plasma exposure in this program shall have the capability to produce an ion flux of $10^{22}/\text{m}^2\text{-s}$ at temperatures greater than 650°C to reach similar conditions. New material of the same thickness should show 40x reduction in erosion rate in these conditions to determine its ability to survive 40 years in operation. This requirement does not apply to Category B structural materials as they are not exposed to the fusion plasma.

Tritium is envisioned to be both a fuel and a byproduct of commercial fusion power systems. Tritium is a radioactive element with a 12-year half-life that can impact the licensing case of fusion power plants. As an isotope of hydrogen, it can be trapped inside the first-wall materials and cause hydrogen embrittlement. Some studies have been performed on the tritium retention characteristics of plasma-facing materials to establish the baseline thermal diffusivity and solubility of hydrogen in tungsten.³² Similar studies have also been performed on select reduced activation ferritic martensitic steels.³³ The data from these studies are used as minimum acceptable diffusivity and solubility baseline metrics as summarized in Table 2 and Table 3. Any submissions to Category A or B shall provide a detailed description of the proposed testing and analysis approach that can show a side-to-side comparison of improved tritium retention characteristics against the baseline tungsten and steel materials.

Due to the high cost and long lead time of materials testing, this program must mitigate the risk of developing a material that performs well in the laboratory but cannot be scaled commercially. Table 4 summarizes the requirements any new material product discovered by Category A and B teams must meet to show it has commercial viability.

The category specific design constraints outlined in Table 2, Table 3, and Table 4 are designed to ensure any new materials developed will maintain integrated performance compared to current baselines and advance the understanding of plasma erosion and tritium retention for fusion materials. An inability to meet one of the constraints may not necessarily disqualify a material product from being used in the first wall of new fusion concepts if the fusion power system designers are willing to accept the tradeoffs.

Each Category C capability team shall have one or more of the following responsibilities:

- Develop the toolset and perform independent activation analysis on new materials discovered by Category A and B teams;
- Develop and maintain a publicly available materials database to house all relevant public data generated as part of this program. Once developed, the database is intended to be available for use during the project performance period;
- Develop and maintain a LCA tool to analyze the impact on fusion power systems from changing materials of construction; and/or
- Perform TEA and LCA for fusion power system designers and provide real-time feedback to Category A and B project teams on changing requirements or performance criteria.

F. DATA STORAGE AND ACCESS PLAN

The Applicant must provide a detailed data storage and access plan that describes what data they intend to keep confidential and what data are expected to be released publicly. The data

storage and access plan will also describe how curated data and metadata collected through the project funding will be archived.

Teams should plan to store their data in a long-term archive, and the costs for data management, archiving, and access should be clearly articulated in the budget and reflected in the total project cost. If applicable, Applicants will be encouraged to address how historical or legacy data will be integrated into the project. Applicants will provide the widest practical access to data collected under this program and the data storage and access plan must describe how these requirements will be satisfied.

The materials discovery teams in Categories A and B will work with Category C team(s) to analyze the impact of using new materials in fusion power system design concepts. In specific cases, standardization of data collection methods, data analysis, and labeling are required between the teams. Category A and B Applicants may prepare inter-related submissions in response to the FOA or enter collaborative partnerships. Note that while Categories A and B are optimizing for different material products, the tools and processes involved may share similarities and the teams are encouraged to share best practices and lessons learned.

Three major types of data are likely to be generated by the Category A and B teams:

- Composition and impurities data of new materials
- Testing data on the performance of the new materials
- Scientific data related to modeling and testing methodology used for material validation

Category C teams will need to take this data and perform LCA and TEA on the new materials. It is expected that generalized, non-specific testing data and scientific data generated under this program are intended for public release and can be shared openly amongst all project teams. Detailed information on material composition, impurities, testing results, and processing parameters may qualify as entitled to be treated as confidential under the terms of the award (e.g., invention disclosures, protected data, and proprietary data) by Category A or B teams. In cases where Category C teams may need access to such data from the Category A and B teams, the Category C teams must commit to maintaining strict confidentiality regarding such data and the results that are generated using such data that are identifiable with a specific performer unless the collaborating awardee agrees otherwise. Confidential data to be generated by another team about individual awardee data will only be made available unless agreed to otherwise by the awardee and ARPA-E. An awardee cannot refuse to collaborate with teams who require that the above restrictions apply to the collaboration. All Category C awardees must agree to the above requirements to be selected for award.

II. AWARD INFORMATION

A. AWARD OVERVIEW

ARPA-E expects to make approximately \$30 million available for new awards, subject to the availability of appropriated funds. ARPA-E anticipates making approximately 7-8 awards under this FOA. ARPA-E may, at its discretion, issue one, multiple, or no awards.

Individual awards may vary between \$1 million and \$7 million in Federal share.

The period of performance for funding agreements may not exceed 36 months. ARPA-E expects to issue funding agreements in September 2024, or as negotiated.

Submissions requiring proof-of-concept R&D can propose a project with the goal of delivering on the program metric at the conclusion of the period of performance. These submissions must contain an appropriate cost and project duration plan that is described in sufficient technical detail to allow reviewers to meaningfully evaluate the proposed project. If awarded, such projects should expect a rigorous go/no-go milestone early in the project associated with the proof-of-concept demonstration. Alternatively, submissions requiring proof-of-concept R&D can propose a project with the project end deliverable being an extremely creative, but partial solution. However, the Applicants are required to provide a convincing vision how these partial solutions can enable the realization of the program metrics with further development.

ARPA-E will provide support at the highest funding level only for submissions with significant technology risk, aggressive timetables, and careful management and mitigation of the associated risks.

ARPA-E will accept only new submissions under this FOA. Applicants may not seek renewal or supplementation of their existing awards through this FOA.

ARPA-E plans to fully fund the negotiated budget at the time of award.

B. RENEWAL AWARDS

At ARPA-E's sole discretion, awards resulting from this FOA may be renewed by adding one or more budget periods, extending the period of performance of the initial award, or issuing a new award. Renewal funding is contingent on: (1) availability of funds appropriated by Congress for the purpose of this program; (2) substantial progress towards meeting the objectives of the approved application; (3) submittal of required reports; (4) compliance with the terms and conditions of the award; (5) ARPA-E approval of a renewal application; and (6) other factors identified by the Agency at the time it solicits a renewal application.

C. ARPA-E FUNDING AGREEMENTS

Through cooperative agreements, other transactions, and similar agreements, ARPA-E provides financial and other support to projects that have the potential to realize ARPA-E's statutory mission. ARPA-E does not use such agreements to acquire property or services for the direct benefit or use of the U.S. Government.

Congress directed ARPA-E to "establish and monitor project milestones, initiate research projects quickly, and just as quickly terminate or restructure projects if such milestones are not achieved."³⁴ Accordingly, ARPA-E has substantial involvement in the direction of every Cooperative Agreement, as described in Section II.D below.

1. COOPERATIVE AGREEMENTS

ARPA-E generally uses Cooperative Agreements to provide financial and other support to Prime Recipients.³⁵

Cooperative Agreements involve the provision of financial or other support to accomplish a public purpose of support or stimulation authorized by Federal statute. Under Cooperative Agreements, the Government and Prime Recipients share responsibility for the direction of projects.

2. FUNDING AGREEMENTS WITH FFRDCs/DOE LABS, GOGOs, AND FEDERAL INSTRUMENTALITIES

Any Federally Funded Research and Development Centers (FFRDC) involved as a member of a Project Team must provide the information requested in the "FFRDC Lab Authorization" and "Field Work Proposal" section of the Business Assurances & Disclosures Form, which is submitted with the Applicant's Full Application.

When a FFRDC/DOE Lab (including the National Energy Technology Laboratory or NETL) is the *lead organization* for a Project Team, ARPA-E executes a funding agreement directly with the FFRDC/DOE Lab and a single, separate Cooperative Agreement with another entity on the Project Team. Notwithstanding the use of multiple agreements, the FFRDC/DOE Lab is the lead organization for the entire project, including all work performed by the FFRDC/DOE Lab and the rest of the Project Team.

When a FFRDC/DOE Lab is a *member* of a Project Team, ARPA-E executes a funding agreement directly with the FFRDC/DOE Lab and a single, separate Cooperative Agreement with the Prime Recipient, as the lead organization for the Project Team. Notwithstanding the use of multiple agreements, the Prime Recipient under the Cooperative Agreement is the lead organization for the entire project, including all work performed by the FFRDC/DOE Lab and the rest of the Project Team.

Funding agreements with DOE/NNSA FFRDCs take the form of Work Authorizations issued to DOE/NNSA FFRDCs through the DOE/NNSA Field Work Proposal system for work performed under Department of Energy Management & Operation Contracts. Funding agreements with non-DOE/NNSA FFRDCs, GOGOs (including NETL), and Federal instrumentalities (e.g., Tennessee Valley Authority) will be consistent with the sponsoring agreement between the U.S. Government and the Laboratory. Any funding agreement with an FFRDC or GOGO will have similar terms and conditions as ARPA-E's Model Cooperative Agreement (<https://arpa-e.energy.gov/technologies/project-guidance/pre-award-guidance/funding-agreements>).

Non-DOE GOGOs and Federal agencies may be proposed to provide support to the Project Team members on an applicant's project, through a Cooperative Research and Development Agreement (CRADA) or similar agreement.

3. OTHER TRANSACTIONS AUTHORITY

ARPA-E may use its "other transactions" authority under the America COMPETES Reauthorization Act of 2010 and DOE's other transactions authority as codified at 42 USC §7256(a) and (g) to enter into an other transaction agreement with Prime Recipients, on a case-by-case basis.

ARPA-E may negotiate an other transaction agreement when it determines that the use of a standard cooperative agreement, grant, or contract is not feasible or appropriate for a project.

The federal share of other transactions agreements should meet or exceed \$3,000,000. In general, an other transaction agreement normally requires a minimum cost share of 50%. See Section III.B.2 of the FOA.

D. STATEMENT OF SUBSTANTIAL INVOLVEMENT

ARPA-E is substantially involved in the direction of projects from inception to completion. For the purposes of an ARPA-E project, substantial involvement means:

- Project Teams must adhere to ARPA-E's agency-specific and programmatic requirements.
- ARPA-E may intervene at any time in the conduct or performance of work under an

award.

- ARPA-E does not limit its involvement to the administrative requirements of an award. Instead, ARPA-E has substantial involvement in the direction and redirection of the technical aspects of the project as a whole.
- ARPA-E may, at its sole discretion, modify or terminate projects that fail to achieve predetermined Go/No Go decision points or technical milestones and deliverables.
- During award negotiations, ARPA-E Program Directors and Prime Recipients mutually establish an aggressive schedule of quantitative milestones and deliverables that must be met every quarter. In addition, ARPA-E will negotiate and establish “Go/No-Go” milestones for each project. If the Prime Recipient fails to achieve any of the “Go/No-Go” milestones or technical milestones and deliverables as determined by the ARPA-E Contracting Officer, ARPA-E may – at its discretion - renegotiate the statement of project objectives or schedule of technical milestones and deliverables for the project. In the alternative, ARPA-E may suspend or terminate the award in accordance with 2 C.F.R. §§ 200.339 – 200.343.
- ARPA-E may provide guidance and/or assistance to the Prime Recipient to accelerate the commercialization of ARPA-E-funded technologies. Guidance and assistance provided by ARPA-E may include coordination with other Government agencies and nonprofits³⁶ to provide mentoring and networking opportunities for Prime Recipients. ARPA-E may also organize and sponsor events to educate Prime Recipients about key barriers to the commercialization of their ARPA-E-funded technologies. In addition, ARPA-E may establish collaborations with private and public entities to provide continued support for the development and commercialization of ARPA-E-funded technologies.

III. ELIGIBILITY INFORMATION

A. ELIGIBLE APPLICANTS

This FOA is open to U.S. universities, national laboratories, industry and individuals.

1. INDIVIDUALS

U.S. citizens or permanent residents may apply for funding in their individual capacity as a Standalone Applicant,³⁷ as the lead for a Project Team,³⁸ or as a member of a Project Team. However, ARPA-E will only award funding to an entity formed by the Applicant.

2. DOMESTIC ENTITIES

For-profit entities (which includes large businesses and small businesses), educational institutions³⁹, and nonprofits⁴⁰ that are incorporated in the United States, including U.S. territories, are eligible to apply for funding as a Standalone Applicant, as the lead organization for a Project Team, or as a member of a Project Team.

FFRDCs/DOE Labs are eligible to apply for funding as the lead organization for a Project Team or as a member of a Project Team that includes institutions of higher education, companies, research foundations, or trade and industry research collaborations, but not as a Standalone Applicant.

State, local, and tribal government entities are eligible to apply for funding as a member of a Project Team, but not as a Standalone Applicant or as the lead organization for a Project Team.

Federal agencies and instrumentalities (other than DOE) are eligible to apply for funding as a member of a Project Team, but not as a Standalone Applicant or as the lead organization for a Project Team.

3. FOREIGN ENTITIES

Foreign entities, whether for-profit or otherwise, are eligible to apply for funding as Standalone Applicants, as the lead organization for a Project Team, or as a member of a Project Team. Foreign entities must designate in the Full Application a subsidiary or affiliate incorporated (or

otherwise formed or to be formed) under the laws of a State or territory of the United States to receive funding. The Full Application must state the nature of the corporate relationship between the foreign entity and domestic subsidiary or affiliate. All work under the ARPA-E award must be performed in the United States. The Applicant may request a waiver of this requirement in the Business Assurances & Disclosures Form, which is submitted with the Full Application and can be found at <https://arpa-e-foa.energy.gov/> (see “View Template Application Documents”). Refer to the Business Assurances & Disclosures Form for guidance on the content and form of the request.

4. CONSORTIUM ENTITIES

Consortia, which may include domestic and foreign entities, must designate one member of the consortium as the consortium representative to the Project Team. The consortium representative must be incorporated in the United States. The eligibility of the consortium will be determined by reference to the eligibility of the consortium representative under Section III.A of the FOA. Each consortium must have an internal governance structure and a written set of internal rules. Upon request, the consortium entity must provide a written description of its internal governance structure and its internal rules to the Contracting Officer (ARPA-E-CO@hq.doe.gov).

Unincorporated consortia must provide the Contracting Officer with a collaboration agreement, commonly referred to as the articles of collaboration, which sets out the rights and responsibilities of each consortium member. This collaboration agreement binds the individual consortium members together and shall include the consortium's:

- Management structure;
- Method of making payments to consortium members;
- Means of ensuring and overseeing members' efforts on the project;
- Provisions for members' cost sharing contributions; and
- Provisions for ownership and rights in intellectual property developed previously or under the agreement.

B. COST SHARING⁴¹

Applicants are bound by the cost share proposed in their Full Applications.

1. BASE COST SHARE REQUIREMENT

ARPA-E generally uses Cooperative Agreements to provide financial and other support to Prime Recipients (see Section II.C.1 of the FOA). Under a Cooperative Agreement or Grant, the Prime Recipient must provide at least 20% of the Total Project Cost⁴² as cost share, except as provided

in Sections III.B2 or III.B.3 below.⁴³

2. INCREASED COST SHARE REQUIREMENT

Large businesses⁴⁴ are strongly encouraged to provide more than 20% of the Total Project Cost as cost share. ARPA-E may consider the amount of cost share proposed when selecting applications for award negotiations (see Section V.B.1 of the FOA).

Under an “other transaction” agreement, the Prime Recipient is normally expected to provide at least 50% of the Total Project Cost as cost share. ARPA-E may reduce this cost share requirement, as appropriate.

3. REDUCED COST SHARE REQUIREMENT

ARPA-E has reduced the base cost share requirement for the following types of projects:

- A domestic educational institution or domestic nonprofit applying as a Standalone Applicant is required to provide at least 5% of the Total Project Cost as cost share.
- Project Teams composed exclusively of domestic educational institutions, domestic nonprofits, and/or FFRDCs/DOE Labs/Federal agencies and instrumentalities (other than DOE) are required to provide at least 5% of the Total Project Cost as cost share. Small businesses – or consortia of small businesses – may provide 0% cost share from the outset of the project through the first 12 months of the project (hereinafter the “Cost Share Grace Period”).⁴⁵ If the project is continued beyond the Cost Share Grace Period, then at least 10% of the Total Project Cost (including the costs incurred during the Cost Share Grace Period) will be required as cost share over the remaining period of performance.
- Project Teams where a small business is the lead organization and small businesses perform greater than or equal to 80% of the total work under the funding agreement (as measured by the Total Project Cost) are entitled to the same cost share reduction and Cost Share Grace Period as provided above to Standalone small businesses or consortia of small businesses.
- Project Teams where domestic educational institutions, domestic nonprofits, small businesses, and/or FFRDCs perform greater than or equal to 80% of the total work under the funding agreement (as measured by the Total Project Cost) are required to provide at least 10% of the Total Project Cost as cost share. However, any entity

(such as a large business) receiving patent rights under a class waiver, or other patent waiver, that is part of a Project Team receiving this reduction must continue to meet the statutory minimum cost share requirement (20%) for its portion of the Total Project Cost.

- Projects that do not meet any of the above criteria are subject to the base cost share requirements described in Sections III.B.1 and III.B.2 of the FOA.

4. LEGAL RESPONSIBILITY

Although the cost share requirement applies to the Project Team as a whole, the funding agreement makes the Prime Recipient legally responsible for paying or ensuring payment of the entire cost share. The Prime Recipient's cost share obligation is expressed in the funding agreement as a static amount in U.S. dollars (cost share amount) and as a percentage of the Total Project Cost (cost share percentage). If the funding agreement is terminated prior to the end of the period of performance, the Prime Recipient is required to contribute at least the cost share percentage of total expenditures incurred through the date of termination.

The Prime Recipient is solely responsible for managing cost share contributions by the Project Team and enforcing cost share obligations assumed by Project Team members in subawards or related agreements.

5. COST SHARE ALLOCATION

Each Project Team is free to determine how much each Project Team member will contribute towards the cost share requirement. The amount contributed by individual Project Team members may vary, as long as the cost share requirement for the project as a whole is met.

6. COST SHARE TYPES AND ALLOWABILITY

Every cost share contribution must be allowable under the applicable Federal cost principles, as described in Section IV.G of the FOA.

Project Teams may provide cost share in the form of cash or in-kind contributions. Cash contributions may be provided by the Prime Recipient or Subrecipients. Allowable in-kind contributions include but are not limited to personnel costs, indirect costs, facilities and administrative costs, rental value of buildings or equipment, and the value of a service, other resource, or third-party in-kind contribution. Project Teams may use funding or property received from state or local governments to meet the cost share requirement, so long as the funding or property was not provided to the state or local government by the Federal Government.

The Prime Recipient may not use the following sources to meet its cost share obligations:

- Revenues or royalties from the prospective operation of an activity beyond the period of performance;
- Proceeds from the prospective sale of an asset of an activity;
- Appropriated Federal funding or property (e.g., Federal grants, equipment owned by the Federal Government); or
- Expenditures that were reimbursed under a separate Federal program.

In addition, Project Teams may not use independent research and development (IR&D) funds⁴⁶ to meet their cost share obligations under Cooperative Agreements. However, Project Teams may use IR&D funds to meet their cost share obligations under “other transaction” agreements.

Project Teams may not use the same cash or in-kind contributions to meet cost share requirements for more than one project or program.

Cost share contributions must be specified in the project budget, verifiable from the Prime Recipient’s records, and necessary and reasonable for proper and efficient accomplishment of the project. Every cost share contribution must be reviewed and approved in advance by the Contracting Officer and incorporated into the project budget before the expenditures are incurred.

Applicants may wish to refer to 2 C.F.R. Parts 200 and 910, and 10 C.F.R Part 603⁴⁷ for additional guidance on cost sharing, specifically 2 C.F.R. §§ 200.306 and 910.130, and 10 C.F.R. §§ 603.525-555.

7. COST SHARE CONTRIBUTIONS BY FFRDCs AND GOGOs

Because FFRDCs are funded by the Federal Government, costs incurred by FFRDCs generally may not be used to meet the cost share requirement. FFRDCs may contribute cost share only if the contributions are paid directly from the contractor’s Management Fee or a non-Federal source.

Because GOGOs/Federal Agencies are funded by the Federal Government, GOGOs/Federal Agencies may not provide cost share for the proposed project. However, the GOGO/Agency costs would be included in Total Project Costs for purposes of calculating the cost-sharing requirements of the applicant.

8. COST SHARE VERIFICATION

Upon selection for award negotiations, Applicants are required to provide information and documentation regarding their cost share contributions. Please refer to Section VI.B.3 of the FOA for guidance on the requisite cost share information and documentation.

C. OTHER

A Concept Paper is incomplete if it does not include required information. ARPA-E will not extend the submission deadline for Applicants that fail to submit required information and documents due to server/connection congestion.

Full Applications are deemed compliant if:

ARPA-E performs a preliminary technical review of Concept Papers and Full Applications. The following types of submissions may be deemed nonresponsive and may not be reviewed or considered:

- Submissions that fall outside the technical parameters specified in this FOA.
- Submissions that have been submitted in response to currently issued ARPA-E FOAs.
- Submissions that are not scientifically distinct from applications submitted in response to currently issued ARPA-E FOAs.
- Submissions for basic research aimed solely at discovery and/or fundamental knowledge generation.
- Submissions for large-scale demonstration projects of existing technologies.
- Submissions for proposed technologies that represent incremental improvements to existing technologies.
- Submissions for proposed technologies that are not based on sound scientific principles (e.g., violates a law of thermodynamics).
- Submissions for proposed technologies that are not transformational, as described in Section I.A of the FOA.
- Submissions for proposed technologies that do not have the potential to become disruptive in nature, as described in Section I.A of the FOA. Technologies must be scalable such that they could be disruptive with sufficient technical progress.
- Submissions that are not distinct in scientific approach or objective from activities currently supported by or actively under consideration for funding by any other office within Department of Energy.
- Submissions that are not distinct in scientific approach or objective from activities currently supported by or actively under consideration for funding by other government agencies or the private sector.
- Submissions that do not propose a R&D plan that allows ARPA-E to evaluate the submission under the applicable merit review criteria provided in Section V.A of the FOA.
- Submissions that propose using funding for construction, alteration, maintenance, or repair of public infrastructure in the United States.

For example, materials with greater than 50% of nickel, copper, zinc, zirconium, niobium, molybdenum, ruthenium, palladium, silver, iridium, rhenium, cerium, samarium, terbium, dysprosium, holmium, erbium, thorium, or uranium will likely result in an unacceptably high contact dose for more than 1,000 years, making them unsuitable for fusion applications.⁴⁸
- Fundamental scientific research on materials that does not produce a material product or specification.

4. LIMITATION ON NUMBER OF SUBMISSIONS

ARPA-E is not limiting the number of submissions from Applicants. Applicants may submit more than one application to this FOA, provided that each application is scientifically distinct.

Concept Papers found to be noncompliant or nonresponsive may not be merit reviewed or considered for award. ARPA-E makes an independent assessment of each compliant and responsive Concept Paper based on the criteria and program policy factors in Sections V.A.1 and V.B.1 of the FOA.

ARPA-E will encourage a subset of Applicants to submit Full Applications. Other Applicants will be discouraged from submitting a Full Application in order to save them the time and expense of preparing an application submission that is unlikely to be selected for award negotiations. By discouraging the submission of a Full Application, ARPA-E intends to convey its lack of programmatic interest in the proposed project. Such assessments do not necessarily reflect judgments on the merits of the proposed project. Unsuccessful Applicants should continue to submit innovative ideas and concepts to future FOAs.

3. FULL APPLICATIONS

Applicants must submit a Full Application by the deadline stated in the FOA. Applicants will have approximately 45 days from receipt of the Encourage/Discourage notification to prepare and submit a Full Application. Section IV.D of the FOA provides instructions on submitting a Full Application.

ARPA-E will review and consider each compliant and responsive Full Application, even if no Reply is submitted or if the Reply is found to be non-compliant.

5. PRE-SELECTION CLARIFICATIONS AND “DOWN-SELECT” PROCESS

Once ARPA-E completes its review of Full Applications and Replies to Reviewer Comments, it may, at the Contracting Officer’s discretion, conduct a pre-selection clarification process and/or perform a “down-select” of Full Applications. Through the pre-selection clarification process or down-select process, ARPA-E may obtain additional information from select Applicants through pre-selection meetings, webinars, videoconferences, conference calls, written correspondence, or site visits that can be used to make a final selection determination. ARPA-E will not reimburse Applicants for travel and other expenses relating to pre-selection meetings or site visits, nor will these costs be eligible for reimbursement as pre-award costs.

ARPA-E may select applications for award negotiations and make awards without pre-selection meetings and site visits. Participation in a pre-selection meeting or site visit with ARPA-E does not signify that Applicants have been selected for award negotiations.

6. SELECTION FOR AWARD NEGOTIATIONS

ARPA-E carefully considers all of the information obtained through the application process and makes an independent assessment of each compliant and responsive Full Application based on the criteria and program policy factors in Sections V.A.2 and V.B.1 and the risk analysis in Section VI.B.10 of the FOA. The Selection Official may select all or part of a Full Application for award negotiations. The Selection Official may also postpone a final selection determination on one or more Full Applications until a later date, subject to availability of funds and other factors. ARPA-E will enter into award negotiations only with selected Applicants.

- The Concept Paper must not exceed 5 pages in length including graphics, figures, and/or tables.
- The Concept Paper must be submitted in Adobe PDF format.
- The Concept Paper must be written in English.
- All pages must be formatted to fit on 8-1/2 by 11-inch paper with margins not less than one inch on every side. Single space all text and use Times New Roman typeface, a black font color, and a font size of 12 point or larger (except in figures and tables).
- The ARPA-E assigned Control Number, the Lead Organization Name, and the Principal Investigator's Last Name must be prominently displayed on the upper right corner of the header of every page. Page numbers must be included in the footer of every page.
- The first paragraph must include the Lead Organization's Name and Location, Principal Investigator's Name, Technical Category, Proposed Funding Requested (Federal and Cost Share), and Project Duration.

Concept Papers found to be noncompliant or nonresponsive may not be merit reviewed or considered for award (see Section III.C of the FOA).

Each Concept Paper must be limited to a single concept or technology. Unrelated concepts and technologies must not be consolidated into a single Concept Paper.

- To the extent possible, provide quantitative metrics in a table that compares the proposed technology concept to current and emerging technologies and to the Technical Performance Targets in Section I.E of the FOA for the appropriate Technology Category in Section I.D of the FOA.

c. PROPOSED WORK

- Describe the final deliverable(s) for the project and the overall technical approach used to achieve project objectives.
- Discuss alternative approaches considered, if any, and why the proposed approach is most appropriate for the project objectives.
- Describe the background, theory, simulation, modeling, experimental data, or other sound engineering and scientific practices or principles that support the proposed approach. Provide specific examples of supporting data and/or appropriate citations to the scientific and technical literature.
- Describe why the proposed effort is a significant technical challenge and the key technical risks to the project. Does the approach require one or more entirely new technical developments to succeed? How will technical risk be mitigated?
- Identify techno-economic challenges to be overcome for the proposed technology to be commercially relevant.
- Estimated federal funds requested; total project cost including cost sharing.

1. ALLOWABLE COSTS

All expenditures must be allowable, allocable, and reasonable in accordance with the applicable Federal cost principles. Pursuant to 2 C.F.R. § 910.352, the cost principles in the Federal Acquisition Regulations (48 C.F.R. Part 31.2) apply to for-profit entities (small businesses and large businesses). The cost principles contained in 2 C.F.R. Part 200; Subpart E apply to all entities other than for-profits.

2. PRE-AWARD COSTS

ARPA-E will not reimburse any pre-award costs incurred by Applicants before they are selected for award negotiations. Please refer to Section VI.A of the FOA for guidance on award notices.

Upon selection for award negotiations, Applicants may incur pre-award costs at their own risk, consistent with the requirements in 2 C.F.R. Part 200, as modified by 2 C.F.R. for a lesser amount than the Applicant expected, or if the costs incurred are not allowable, allocable, or reasonable.

3. PATENT COSTS

For Subject Inventions disclosed to DOE under an award, ARPA-E will reimburse the Prime Recipient – in addition to allowable costs associated with Subject Invention disclosures - up to \$30,000 of expenditures for filing and prosecution of United States patent applications, including international applications (PCT application) submitted to the United States Patent and Trademark Office (USPTO).

The Prime Recipient may request a waiver of the \$30,000 cap. Note that, patent costs are considered to be Technology Transfer & Outreach (TT&O) costs (see Section IV.G.8 of the FOA below) and should be requested as such.

4. CONSTRUCTION

ARPA-E generally does not fund projects that involve major construction. Recipients are required to obtain written authorization from the Contracting Officer before incurring any major construction costs.

5. FOREIGN TRAVEL

ARPA-E generally does not fund projects that involve foreign travel. Recipients are required to obtain written authorization from the ARPA-E Program Director before incurring any foreign travel costs and provide trip reports with their reimbursement requests.

6. PERFORMANCE OF WORK IN THE UNITED STATES

ARPA-E strongly encourages interdisciplinary and cross-sectoral collaboration spanning organizational boundaries. Such collaboration enables the achievement of scientific and technological outcomes that were previously viewed as extremely difficult, if not impossible.

ARPA-E requires all work under ARPA-E funding agreements to be performed in the United States. However, Applicants may request a waiver of this requirement where their project would materially benefit from, or otherwise requires, certain work to be performed overseas.

Applicants seeking a waiver of this requirement are required to include an explicit request in the Business Assurances & Disclosures Form, which is part of the Full Application submitted to ARPA-E. Such waivers are granted where there is a demonstrated need, as determined by ARPA-E.

7. PURCHASE OF NEW EQUIPMENT

The ARPA-E Contracting Officer will provide consent to purchase or reject within 30 calendar days of receipt of the Recipient's notification.

8. TECHNOLOGY TRANSFER AND OUTREACH

ARPA-E is required to contribute a percentage of appropriated funds to Technology Transfer and Outreach (TT&O) activities. In order to meet this mandate, every Project Team must spend at least 5% of the Federal funding (i.e., the portion of the award that does not include the recipient's cost share) provided by ARPA-E on TT&O activities to promote and further the development and eventual deployment of ARPA-E-funded technologies. Project Teams must also seek a waiver from ARPA-E to spend less than the minimum 5% TT&O expenditure requirement.

10. CONFERENCE SPENDING

Prime Recipients and Subrecipients may not use any Federal funds to:

- Defray the cost to the United States Government of a conference held by any Executive branch department, agency, board, commission, or office which is not directly and programmatically related to the purpose for which their ARPA-E award is made and for which the cost to the United States Government is more than \$20,000; or

includes cost of effort that is not sponsored by an assistance agreement or required in performance of a contract, and that consists of projects falling within the four following areas: (i) basic research, (ii) applied research, (iii) development, and (iv) systems and other concept formulation studies.

ARPA-E's goals are to enhance the economic and energy security of the United States through the development of energy technologies and ensure that the United States maintains a technological lead in developing and deploying advanced energy technologies. ARPA-E accomplishes these goals by providing financial assistance for energy technology projects and has well recognized and established procedures for supporting research through competitive financial assistance awards based on merit review of proposed projects. Reimbursement for independent research and development costs through the indirect cost mechanism could circumvent this competitive process.

To ensure that all projects receive similar and equal consideration, eligible organizations may compete for direct funding of independent research projects they consider worthy of support by submitting proposals for those projects to ARPA-E. Since proposals for these projects may be submitted for direct funding, costs for independent research and development projects are not allowable as indirect costs under ARPA-E awards. - Sufficiency of technical approach to accomplish the proposed R&D objectives, including why the proposed concept is more appropriate than alternative approaches and how technical risk will be mitigated;
- Clearly defined project outcomes and final deliverables; and
- The demonstrated capabilities of the individuals performing the project, the key capabilities of the organizations comprising the Project Team, the roles and responsibilities of each organization and (if applicable) previous collaborations among team members supporting the proposed project.

By discouraging the submission of a Full Application, ARPA-E intends to convey its lack of programmatic interest in the proposed project. Such assessments do not necessarily reflect judgments on the merits of the proposed project. The purpose of the Concept Paper phase is to save Applicants the considerable time and expense of preparing a Full Application that is unlikely to be selected for award negotiations.

The Contractor and any successor assignee will convey to DOE, upon written request from DOE, title to any subject invention, upon a breach of this paragraph. The Contractor will include this paragraph in all subawards/contracts, regardless of tier, for experimental, developmental or research work.

It includes both for-profit and non-profit organizations.

In addition, every line and paragraph containing proprietary, privileged, or trade secret information must be clearly marked with double brackets or highlighting.

J. EXPORT CONTROL INFORMATION

Do not include information subject to export controls in any submissions, including Concept Papers, Full Applications, and Replies to Reviewer Comments – whether marked as subject to US export control laws/regulations or otherwise. Such information may not be accepted by ARPA-E and may result in a determination that the application is non-compliant, and therefore not eligible for selection. This prohibition includes any submission containing a general, non-determinative statement such as "The information on this page [or pages _ to_] may be subject to US export control laws/regulations", or similar. Under the terms of their award, awardees shall be responsible for compliance with all export control laws/regulations.

K. COMPLIANCE AUDIT REQUIREMENT

A prime recipient organized as a for-profit entity expending \$750,000 or more of DOE funds in the entity's fiscal year (including funds expended as a Subrecipient) must have an annual compliance audit performed at the completion of its fiscal year. For additional information, refer to Subpart F of: (i) 2 C.F.R. Part 200, and (ii) 2 C.F.R. Part 910.

If an educational institution, non-profit organization, or state/local government is either a Prime Recipient or a Subrecipient and has expended \$750,000 or more of Federal funds in the entity's fiscal year, the entity must have an annual compliance audit performed at the completion of its fiscal year. For additional information refer to Subpart F of 2 C.F.R. Part 200.

IX. GLOSSARY

Applicant: The entity that submits the application to ARPA-E. In the case of a Project Team, the Applicant is the lead organization listed on the application.

Application: The entire submission received by ARPA-E, including the Preliminary Application, Full Application, Reply to Reviewer Comments, and Small Business Grant Application (if applicable).

ARPA-E: is the Advanced Research Projects Agency – Energy, an agency of the U.S. Department of Energy.

Cost Sharing: Is the portion of project costs from non-Federal sources that are borne by the Prime Recipient (or non-Federal third parties on behalf of the Prime Recipient), rather than by the Federal Government.

Covered Individual: an individual who contributes in a substantive, meaningful way to the scientific development or execution of an R&D project proposed to be carried out with an award from ARPA-E. This includes, but is not limited to, the PI, Co-PI, Key Personnel, and technical staff (e.g., postdoctoral fellows/researchers and graduate students). ARPA-E may further designate covered individuals during award negotiations or the award period of performance.

Deliverable: A deliverable is the quantifiable goods or services that will be provided upon the successful completion of a project task or sub-task.

DOE: U.S. Department of Energy

DOE/NNSA: U.S. Department of Energy/National Nuclear Security Administration.

FFRDCs: Federally Funded Research and Development Centers

FOA: Funding Opportunity Announcement

Foreign Affiliation: a funded or unfunded academic, professional, or institutional appointment or position with a foreign government or government-owned entity, whether full-time, part-time, or voluntary (including adjunct, visiting, or honorary).

Foreign Countries of Concern: the People's Republic of China, the Democratic People's Republic of Korea, the Russian Federation, the Islamic Republic of Iran, Burma, Eritrea, Pakistan, Saudi Arabia, Tajikistan, and Turkmenistan.

For-Profit Organizations (or For-Profit Entities): Entities organized for-profit that are Large Businesses or Small Businesses as those terms are defined elsewhere in this Glossary.

GOCOs: U.S. Government Owned, Contractor Operated laboratories.

GOGOs: U.S. Government Owned, Government Operated laboratories.

Institutions of Higher Education (or *educational institutions*): Has the meaning set forth at 20 U.S.C. 1001.

Large Business: Large businesses are entities organized for-profit other than small businesses as defined elsewhere in this Glossary.

Malign Foreign Talent Recruitment Program: the meaning given such term in section 10638 of the Research and Development, Competition, and Innovation Act (division B of Public Law 117–167) or 42 USC 19237, as of October 20, 2022.

Milestone: A milestone is the tangible, observable measurement that will be provided upon the successful completion of a project task or sub-task.

Nonprofit Organizations (or *nonprofits*): Has the meaning set forth at 2 C.F.R. § 200.70.

Prime Recipient: The signatory to the funding agreement with ARPA-E.

PI: Principal Investigator.

Project Team: A Project Team consists of the Prime Recipient, Subrecipients, and others performing or otherwise supporting work under an ARPA-E funding agreement.

Small Business: Small businesses are domestically incorporated entities that meet the criteria established by the U.S. Small Business Administration’s (SBA) “Table of Small Business Size Standards Matched to North American Industry Classification System Codes” (NAICS) (<http://www.sba.gov/content/small-business-size-standards>).

Standalone Applicant: An Applicant that applies for funding on its own, not as part of a Project Team.

Subject Invention: Any invention conceived or first actually reduced to practice under an ARPA-E funding agreement.

Subrecipient: An entity (not an individual) that receives a subaward from the Prime Recipient to carry out part of the ARPA-E award.

Task: A task is an operation or segment of the work plan that requires both effort and resources. Each task (or sub-task) is connected to the overall objective of the project, via the achievement of a milestone or a deliverable.

Total Project Cost: The sum of the Prime Recipient share and the Federal Government share of total allowable costs. The Federal Government share generally includes costs incurred by GOGOs, FFRDCs, and GOCOs.

TT&O: Technology Transfer and Outreach. (See Section IV.G.8 of the FOA for more information).
