To date, TNC has completed the full removal of the Remnant Dam, scour and fish passage work at the Brugler Road bridge and the Warrington Road bridge, partial dewatering of the Columbia impoundment, and partial breach of the Columbia Dam. TNC is operating within the projected completion schedule for all tasks, and has proved to be uniquely qualified and capable of overseeing and managing this project.
