USAID received the following question regarding the RFA and provides the following response:

A. Submissions and Related Question

1. Can we directly support government associated NGOs such as the Myanmar Health Assistants Association and the Myanmar Midwives and Nurses Association?

USAID: Support may not be provided to Government of Burma-associated NGOs (GONGOs). The Agreement Officer or AOTR should be consulted as to whether a specific NGO is considered to be a GONGO.
