Sample Response: The purpose of this award is to complete an underwater archeological survey of Geneva Lake located in Walworth County, Wisconsin. The project will generate data that will be used to complete a National Register nomination.

The project will include: contracted services for LiDAR survey of approximately 2 square miles of previously identified submerged archeological resources; contracted services for drafting a National Register nomination; and administrative costs.

Project milestones are: completion of survey by June 2025; completion of 80% draft National Register nomination by July 2025; and completion of final National Register nomination by December 2025. The expected project outcomes are one complete intensive survey of 2 square miles of Geneva Lake and one complete National Register nomination submitted to the Wisconsin state review board.

The beneficiaries of this project are the residents of Walworth County and the State of Wisconsin whose historic resources will be surveyed and recorded.
