Award shall be limited to States, local governments, Indian tribes, non-governmental organizations, and individuals, pursuant to the authority of 16 U.S.C. 670c-1(a)", and
 - Section V Application Review Information, "In accordance with Title 2 of the Code of Federal Regulations, non-Federal entities may not earn or keep any profit (or comparable fees) resulting from Federal Financial Assistance actions. Therefore, any applications that contain profit and/or fees will be excluded from consideration because the government cannot compensate for profit or fees on Federal Financial Assistance awards (i.e., Grants and Cooperative Agreements)." This opportunity is open to all that meet the criteria of this announcement.
- 9. Does this job fall under the Bacon/Davis payroll requirement for employees and/or subcontractor?
