ATTACHMENT A:

BACKGROUND:

USAID has been working to empower the Haiti Ministry of Health (MOH) to build a comprehensive and sustainable health management information system and utilize data in decision-making. In 2012, the “System d’Information Sanitaire Nationale Unique (SISNU)” was developed as an overarching, comprehensive health management information system. It tracks multiple indicators across a broad range of health-related issues from health institutions nationwide. The Government of Haiti has now taken on management of SISNU, and it is intended to be the overarching national health management information system to be used for collecting and tracking health data throughout Haiti. An additional pilot mobile program (mSante) that relies on data from community health workers also feeds into this system.

However, a number of other health information systems that have arisen out of previous initiatives are not interoperable with SISNU, which inhibits their ability to feed into the more comprehensive system. The successful operation of SISNU also depends on timely and accurate input of data from health facilities and community health workers, which remains a challenge. Although they have received training, there is a high turnover of MOH staff and staff at health facilities, which necessitates constant training at multiple levels to ensure accurate and consistent data collection, and proper use and management of the system. The institutional capacity within the MOH to utilize the collected data in decision-making also requires additional support. Another critical gap is the absence of an e-health policy governing the multiple intervention in the digital health sector in Haiti.

USAID is seeking information on local Haitian organizations that have experience with:

- a) Build staff and institutional capacity to manage, oversee, and maintain cross-sector information systems.
- b) Data analysis and capacity building on improved use of data in decision-making.
- c) Put in place and reinforce governance of the digital services for Government of Haiti entities.

In their responses to this notice, Haitian organizations should describe their firm’s capability and experience in executing similar interventions to those described above.
