Overview

The [U.S. Department of Justice](#) (DOJ), [Office of Justice Programs](#) (OJP), [Office for Victims of Crime](#) (OVC) is seeking applications for funding for the implementation of the 2022 National Crime Victims' Rights Week (NCVRW) Community Awareness Projects (CAP). This program furthers the Department's mission by supporting public awareness, community outreach, and education activities for crime victims' rights and services.

This solicitation incorporates the [OJP Grant Application Resource Guide](#) by reference. The OJP Grant Application Resource Guide provides guidance to applicants on how to prepare and submit applications for funding to OJP. **If this solicitation expressly modifies any provision in the OJP Grant Application Resource Guide, the applicant is to follow the guidelines in this solicitation as to that provision.**

Solicitation Categories

This solicitation does not include Solicitation Categories.

Eligible Applicants:

City or township governments, County governments, Native American tribal governments (Federally recognized), Native American tribal organizations (other than Federally recognized tribal governments), Nonprofits having a 501(c)(3) status with the IRS, other than institutions of higher education, Nonprofits that do not have a 501(c)(3) status with the IRS, other than institutions of higher education, Private institutions of higher education, Public and State controlled institutions of higher education, Public housing authorities/Indian housing authorities, State governments

For purposes of this solicitation, "state" means any state of the United States, the District of Columbia, the Commonwealth of Puerto Rico, the Virgin Islands, Guam, American Samoa, and the Commonwealth of the Northern Mariana Islands.

To advance Executive Order 13929 Safe Policing for Safe Communities, as of October 28, 2020, the Attorney General determined that all state, local, and university or college law enforcement agencies must be certified by an approved independent credentialing body or have started the certification process to be allocated FY 2021 DOJ discretionary grant funding, as either a recipient or a subrecipient. All recipients and subrecipients (including any for-profit organization) must forgo any profit or management fee.

OVC may elect to fund applications submitted under this FY 2021 solicitation in future fiscal years, dependent on, among other considerations, the merit of the applications and on the availability of appropriations.

Program Description

Overview

The Department of Justice is committed to advancing work that promotes civil rights, increases access to justice, supports crime victims, protects the public from crime and evolving threats, and builds trust between law enforcement and the community.

This cooperative agreement will enable an organization to provide financial and technical assistance to approximately 50 communities nationwide to conduct public education and awareness activities on crime victims' rights and services in their jurisdictions during the 2022 National Crime Victims' Rights Week (NCVRW). All final decisions as to which communities will be funded by the intermediary will be made by the OVC Director.

Statutory Authority

34 USC § 20103(c)(1)(A)

Specific Information

To further assist victim service providers in their efforts to conduct public awareness activities during NCVRW, OVC will select an applicant to pass-through funds and serve as the technical assistance provider to competitively selected subgrantees. The recipient will work cooperatively with OVC in the application review and selection process for community awareness projects.

Subrecipient Eligibility: Public agencies, nonprofit organizations, community-based victim service organizations, faith-based organizations, tribal organizations, and community coalitions committed to ensuring the rights of and services for crime victims will be eligible to apply for the reimbursable contract funding for the CAPs held during 2022 NCVRW. A nonprofit organization that serves crime victims does not need to have 501(c)(3) status to apply. VOCA-funded organizations are also eligible to apply. Applicants selected for funding will be required to submit an after-action report on their NCVRW activities, including data on performance measures and financial outlays.

Subrecipient Information: CAP subrecipients may be approved for up to \$5,000 in reimbursement under this funding for the following activities:

- Purchase print media, radio, television, or outdoor advertising to promote NCVRW events and victims' rights and services.
- Design and print promotional or educational materials.
- Reimburse NCVRW event speakers' fees (NOT to exceed \$650 per day for each speaker). Supplemental funding from other sources cannot be used to exceed this daily limitation.
- Rent space to conduct NCVRW activities and events.
- Purchase supplies, materials, and equipment used in public awareness events and activities.

The following reimbursements will NOT be approved for subrecipients:

- Salaries.
- Organizational overhead or operational costs.
- Refreshment costs not associated with public awareness events or programs.
- Entertainment (such as bands).
- Costs associated with a fundraising activity or event.
- Bar charges or alcoholic beverages.
- Food and beverage costs associated with award events or ceremonies.
- Construction costs.
- Cash prizes, including gift cards, associated with contests, raffles, or drawings.
- Costs associated with promotional and educational materials that are not directly tied to the 2022 NCVRW theme.

Goals, Objectives, Deliverables, and Timeline

Goals

The goals of this project are to increase public awareness of crime victims' rights and services nationwide during the 2022 National Crime Victims' Rights Week, and strengthen the capacity of victim assistance agencies to develop a broad, collaborative approach to community awareness that highlights services for all types of crime victims.

Objectives

Objective 1: Financially, programmatically, and administratively support approximately 50 subgrants of up to \$5,000 each for communities and victim assistance organizations nationwide.

Objective 2: Provide technical assistance for the recipient organizations to promote 2022 NCVRW in communities across the Nation.

Objective 3: Market the project so that it meets the goal of funding a project in every state.

Objective 4: Assemble a group of expert reviewers who are familiar with NCVRW and the victim assistance field, and who are willing to volunteer their services to review every application received and be a part of the selection process.

Deliverables

Project activities and deliverables include the following:

- Develop and administer the community awareness project outreach and application processes (final recommendations require the approval of the OVC Director).
- Advertise and publicize the application period through OVC and other public venues.
- Establish a Review Committee to review, grade, and comment on each application submitted. The Review Committee should meet, either in-person or virtually, after all applications are scored to determine which applications will move forward for final approval.
- Establish an NCVRW CAP website to advertise the funding opportunity, provide FAQs for first-time applicants, and link to the main OVC NCVRW website.
- Funding recommendations from the Review Committee for the OVC Director.
- Reimbursement to selected subrecipients.
- Provide technical assistance to each selected subrecipient.
- Send Certificates of Appreciation to all of the successful CAP applicants.
- Receive, review, and summarize after-action reports, including documentation and verification of expenses and requests for reimbursement.
- Prepare a final report for OVC on the overall project, including recommendations for improvement and a list of innovative practices for inclusion in future NCVRW Resource Guides.

The Goals, Objectives, and Deliverables are directly related to the performance measures that demonstrate the results of the work completed, as discussed under Application and Submission Information.

Proposal Abstract

A proposal abstract (no more than 400 words) summarizing the proposed project including primary activities, products and deliverables, the service area, and who will benefit from the proposed project, will be completed in the JustGrants Web-based form.

Proposal Narrative

The proposal narrative should be submitted as an attachment in JustGrants. The attached document should be double-spaced, using a standard 12-point Times New Roman font; have no less than 1-inch margins; and should not exceed 25 pages. Pages should be numbered and submitted as an attachment. If the proposal narrative fails to comply with these length restrictions, OVC may negatively consider such noncompliance in peer review and in final award decisions.

The following sections must be included as part of the proposal narrative:

a. Description of the Issue

The description of the issue must describe the need for the project and provide a clear statement of how funding will support the project's value to the victims' field by meeting a stated goal.

b. Project Design and Implementation

The Project Design and Implementation plan must describe the project strategy and discuss how the strategy will address the identified problems and support the goals and objectives. The applicant's strategy or design must include a description of project phases, tasks, activities, and staff responsibilities, and clear descriptions of interim deliverables and final products. It must include a time-task plan that clearly identifies objectives, major activities, and products for the duration of the project period. The applicant must describe the strategy, tasks, and time-task plan for developing the services and products.

As a separate attachment, the time-task plan is not subject to the page limitations of the proposal narrative. This plan must include the designation of organization responsibility, a schedule for the completion of the activities, and the submission of finished products.

In preparing the time-task plan, the applicants should make certain that all project activities will occur within the proposed project period. The plan also must provide for the submission of financial and progress reports.

c. Capabilities and Competencies

The application must include a clear description of the applicant's management structure. Applicants must include a description of the current and proposed professional staff members' unique qualifications that will enable them to fulfill their grant responsibilities.

The applicant must describe how the program will be managed and include an organizational chart or information describing the roles and responsibilities of key organization and functional components and personnel. The applicant must also include a list of personnel responsible for managing and implementing the major stages of the project. If additional staff will be hired to complete the project, the applicant should identify the selection criteria. Applicants should also provide detailed information about staff committed to working on the project contingent upon receipt of funding.

d. Plan for Collecting the Data Required for this Solicitation's Performance Measures

This section must include the following information:

1. A plan for collecting all of the performance measures data required by this solicitation.
2. A description of the qualifications of the key staff who will be responsible for collecting data and reporting performance measures in JustGrants.

OJP will require each successful applicant to submit annual performance data that demonstrate the results of the work carried out under the award. The performance data directly relate to the goals, objectives, and deliverables identified under "Goals, Objectives, and Deliverables."

A list of performance measure questions are available under Performance Measures.

Note: Applicants are **not** required to submit performance data with the application. Rather, performance measures information is included as an alert that successful applicants will be required to submit performance data as part of the reporting requirements under an award.

Award recipients will be required to submit performance measure data and performance reports in JustGrants. Further guidance on the post-award submission process will be provided, if selected for award.

Application Review Information

Review Criteria

a. Merit Review Criteria

Applications that meet basic minimum requirements will be evaluated by peer reviewers. Applications will be evaluated on how the proposed project/program addresses the following criteria:

1. Description of the Issue (20%) - evaluate the applicant's understanding of the program/issue to be addressed.

2. Project Design and Implementation (40%)- evaluate the adequacy of the proposal, including the goals, objectives, timelines, milestones, and deliverables.
3. Capabilities and Competencies (20%) - evaluate administrative and technical capacity of the applicant to successfully accomplish the goals and objectives.
4. Plan for Collecting the Data Required for this Solicitation's Performance Measures (5%) - evaluate the applicant's understanding of the performance data reporting requirements and the plan for collecting the required data.
5. Budget (10%) - evaluate for completeness, cost effectiveness, and allowability (e.g., reasonable, allocable, and necessary for project activities).
6. Other: Resumes of Key Personnel and Time-Task Plan (5%) - evaluate how the resumes and time-task plan fulfill the described administrative, technical, and programmatic capacity of the applicant to successfully accomplish the goal and objectives.

b. Other Review Criteria/Factors

Other important considerations for OVC include geographic diversity, strategic priorities, available funding, past performance, and the extent to which the Budget Worksheet and Budget Narrative (Web-based form) accurately explain project costs that are reasonable, necessary, and otherwise allowable under federal law and applicable federal cost principles.

Review Process

Applications submitted under this solicitation that meet basic minimum requirements, will be evaluated for technical merit by a peer review panel(s) in accordance with OJP peer review policy and procedures using the stated review criteria above.

OJP screens applications to ensure they meet the basic minimum requirements prior to conducting peer review. Although specific requirements may vary, the following are common requirements applicable to all solicitations for funding under OJP programs:

- The application must be submitted by an eligible type of applicant.
- The application must request funding within programmatic funding constraints (if applicable).
- The application must be responsive to the scope of the solicitation.
- The application must include all items necessary to meet the basic minimum requirements.

Pursuant to the Part 200 Uniform Requirements, before award decisions are made, OJP also reviews information related to the degree of risk posed by the applicant. Among other things to help assess whether an applicant that has one or more prior federal awards has a satisfactory record with respect to performance, integrity, and business ethics, OJP checks whether the applicant is listed in SAM as excluded from receiving a federal award.
