A. PROGRAM DESCRIPTION

The Department of State's Bureau of International Security and Nonproliferation, Office of Cooperative Threat Reduction (ISN/CTR) is pleased to announce an open competition for assistance awards through this Notice of Funding Opportunity (NOFO). ISN/CTR sponsors foreign assistance activities funded by the Nonproliferation, Antiterrorism, Demining and Related Programs (NADR) and other accounts, and focuses on mitigating weapons of mass destruction (WMD) and WMD-related delivery systems proliferation and security threats from non-state actors and proliferator states. An underlying aim of all ISN/CTR's efforts is long-term sustainability to maximize programmatic impact while minimizing the need for foreign partners to rely on outside financial or technical assistance.

The Russian Federation has a well-documented history of using chemical and radiological agents to target adversaries. This includes attempts to assassinate opposition politicians in Russia, dissidents and defectors abroad, and even citizens of other countries whose actions Russia disagrees with. The entire world witnessed the images of the Russian Federation's attempts at assassinating Sergei Skripal and Aleksey Navalny using chemical weapons. The assassination attempt against Skripal in Salisbury, U.K. in 2018 was particularly notable because it involved the first known use of a Novichok nerve agent, developed by the Soviet Union. In fact, a 2020 chemical analysis by Germany, France, and Sweden, and the Organization for the Prohibition of Chemical Weapons, confirmed that Russia had specifically used a Novichok agent again in the assassination attempt of Aleksey Navalny. Russia's brazen use of these deadly agents to target adversaries is a notable feature of Russian statecraft that spans across multiple countries.

In an attempt to confuse the world about the Russian Federation's well-documented use of chemical weapons, the Russian government is deliberately attacking nonproliferation programs, activities, and facilities that are designed to protect the global community from chemical and biological threats. A critical step to deterring and confirming the Russian Federation's potential further use of chemical weapons (or other Weapons of Mass Destruction) is the trusted and

authoritative detection of such weapons by the international nonproliferation community. The goal of Russia's malign influence campaigns is to undermine this longstanding international unity and cooperation that for decades has sought to prevent the use of weapons of mass destruction.

Program Objectives:

ISN/CTR Program to Build Partner Capabilities to Counter Russian Malign Influence (RMI) in the nonproliferation space seeks proposals that strengthen partner capacities to identify and respond to Russian active measures by:

- Enhancing international awareness of Russian active measures in the nonproliferation, security, and public health arenas;
- Enhancing technical detection capabilities of international nonproliferation stakeholders, in line with standards set out by the OPCW and international community;
- Building partner resilience in the nonproliferation, security, and public health arenas against hostile information environments, to include development of sustainable and strategic communication and inter-ministerial coordination plans;
- Strengthening foreign partners in the nonproliferation arena's resilience through enhancing cybersecurity and cyberhygiene capabilities;
- Developing and strengthening regional and local networks of experts that seek to cooperatively and proactively deter, identify, and counter malign influence campaigns;
- Leveraging open-source information to help identify the Russian Federation's networks involved in facilitating and carrying out its Chemical, Biological, and Radiological (CBR)-assassination plots;
- Increasing partner countries' awareness of, and ability to identify and respond to, Russian malign influence - including Russian CBR assassination plots;
- Enhancing the ability of the government of Ukraine to defend itself against Russia's continued invasion through providing Chemical, Biological, Radiological, and Nuclear (CBRN) response training, personal protective equipment, medical countermeasures, and critical infrastructure support.

ISN/CTR Areas of Focus Related to RMI:

Russian CBR Assassination Response: ISN/CTR will continue to build partner government capacity to identify and respond to the Russian Federation's use of CBR materials in assassination attempts – especially in a hostile information environment. To do so, ISN/CTR will develop new, open-source information that seek to highlight GRU and FSB networks that carry out malign activities in partner countries.

ISN/CTR will also raise the technical and tactical abilities of local law enforcement, scientific community, medical first responders, and national security stakeholders to identify and respond to suspected cases involving Russian CBR material. ISN/CTR will support efforts to develop and strengthen law enforcement and medical first responder standard operating

procedures (SOPs) ranging from symptoms identification and medical countermeasures, to biomedical and environmental sample collection, evidence preservation, and chain of custody. ISN/CTR will support field and table-top training exercises (FTX and TTX) that address the full spectrum of the small-scale CBR-assassination attack cycle, to include operating in a hostile information environment, and addressing state-sponsored cyberattacks. These interactive exercises will be aimed at strategic decision-makers, as well as law enforcement, security services, emergency management, and scientists. ISN/CTR's FY24 projects will:

- For new partner countries, raise awareness for first responder, public health, security, and policy stakeholders to the signs and symptoms of further Russian use of hard-to-detect CBR agents in targeted assassinations;
- Provide technical capabilities through TTXs and FTXs to first responders, law enforcement, and security officials to identify and respond safely and securely to a potential CBR assassination incident. This includes secure sampling, field screening, and relevant decontamination best-practices – all in a hostile CBR and information environment;
- For partners already active in this space, assist in developing, implementing, and institutionalizing strategic communication and response standard operating procedures for law enforcement, security, and medical professionals;
- Developing tailored and specific training curriculum for local partner institutions, and supporting regional networks of collaboration and information sharing on these issues;
- Promote strategic, sustainable, multi-disciplinary, and inter-ministerial planning efforts to respond to a Russian CBR assassination attempt, including developing response and strategic communication plans in a hostile information environment;
- Sensitize policymakers, law enforcement, defense, and private and public sector cyber security specialists on potential pre-attack indicators to include movement of persons, and cyber incursions to access or disrupt key systems;
- Train foreign partners to identify and respond effectively to malign influence campaigns and cyberattacks seeking to undermine partner response efforts after a CBR attack;
- Promote regional and international coordination to ensure authoritative and robust response to future Russian CBR attacks;
- Train foreign partners to develop Strategic Communications (STRATCOM) plans and improve inter-ministerial messaging amidst a potentially hostile information environment; and
- Help partner countries develop international outreach and coordination plans in the event of a suspected CBR attack.

Laboratory Capacity Building and Hardening: ISN/CTR will build and strengthen partner institutional capacity to follow accepted international standards to enhance technical Chemical, Biological, Radiological, and Nuclear (CBRN) detection and reporting capabilities. ISN/CTR's FY24 efforts will:

- Raise awareness for nonproliferation facilities and relevant governments on Russian active measures and seek to adopt best practices and improve their physical, procedural, personnel, and cyber security;
- Develop and enhance scientific and partner government capabilities in developing sustainable and robust strategic messaging plans, and operating in a hostile information environment;
- Work with key facilities and oversight officials in health, scientific, law enforcement, and security sectors to develop strong cyber incident response and strategic communication plans to deter and counter state-backed malign influence campaigns;
- Enhance technical capabilities of nonproliferation facilities seeking OPCW certification, and other national scientific and investigative infrastructure, and to increase detection capabilities in environmental and biomedical samples;
- Strengthen partner capabilities to request international assistance and understand the processes involved in such assistance - to include training on methods to ensure sample preparation, preservation, and transfer to an OPCW technical assistance team;
- Provide material support to frontline Ukrainian partners in the realm of CBRN training, equipment, medical countermeasures and other assistance to harden and enhance Ukraine's ability to defend against use of CBRN.

Strengthening Nonproliferation Norms: ISN/CTR seeks to strengthen foreign government and private sector support for longstanding nonproliferation norms, facilities, institutions, and programs. Previous projects engaged government, academia, and other civil society stakeholders on countering malign influence campaigns that seek to undermine international nonproliferation objectives.

ISN/CTR's FY24 efforts will:

- Raise awareness for partner governments, think tanks, journalists, and professional societies on Russian active measures campaigns seeking to undermine longstanding nonproliferation norms and institutions;
- Train partners to proactively deter, recognize, and respond to malign influence campaigns, including malign cyber activities, that undermine nonproliferation norms;
- Support local partners to engage international audiences through micro grants, academic conferences, and remote engagements for activities to strengthen nonproliferation norms and related cooperation;

- Partner with local, in-country organizations to raise partner awareness of the negative impacts of Russian Federation's robust efforts to roll back decades of progress in strengthening nonproliferation norms, institutions, facilities, and collaboration;
- Engage key global audiences with timely, factual, and accurate scientific information on proliferation challenges.

C. ELIGIBILITY INFORMATION

1. Eligible Applicants

The following organizations are eligible to apply:

- Not-for-profit organizations, including think tanks and civil society/non-governmental organizations
- Public and private educational institutions
- Federally funded research and development centers (FFRDCs)

- For-profit organizations Public International Organizations and Governmental institutions

2. Cost Sharing or Matching

Cost sharing is not required and will play no role in when the project is being evaluated.

3. Other Eligibility Requirements

In order to be eligible to receive an award, all organizations must have a Unique Entity Identifier (UEI) number issued via www.SAM.gov as well as a valid registration on www.SAM.gov. Please see Section D.3 for more information.

Applicants are only allowed to submit one proposal package per organization. If more than one proposal package is submitted from an organization, all proposals from that institution may be considered ineligible for funding.

3. Unique Entity Identifier and System for Award Management (SAM.gov)
(NOTE: This section is required and not optional.)

Required Registrations:

All organizations, whether based in the United States or in another country, must have a Unique Entity Identifier (UEI) and an active registration with the SAM.gov. A UEI is one of the data elements mandated by Public Law 109-282, the Federal Funding Accountability and Transparency Act (FFATA), for all Federal awards.

Note: As of April 2022, a DUNS number is no longer required for federal assistance applications.

The 2 CFR 200 requires that sub-grantees obtain a UEI number. Please note the UEI for sub-grantees is not required at the time of application but will be required before an award is processed and/or directed to a sub-grantee.

Note: The process of obtaining or renewing a SAM.gov registration may take anywhere from 4-8 weeks. Please begin your registration as early as possible.

Exemptions

An exemption from the UEI and sam.gov registration requirements may be permitted on a case-by-case basis if:

- An applicant's identity must be protected due to potential endangerment of their mission, their organization's status, their employees, or individuals being served by the applicant.
- For an applicant, if the Federal awarding agency makes a determination that there are exigent circumstances that prohibit the applicant from receiving a unique entity identifier and completing SAM registration prior to receiving a Federal award. In these instances, Federal awarding agencies must require the recipient to obtain a unique entity identifier and complete SAM registration within 30 days of the Federal award date.

Organizations requesting exemption from UEI or SAM.gov requirements must email the point of contact listed in the NOFO at least two weeks prior to the deadline in the NOFO providing a justification of their request. Approval for a SAM.gov exemption must come from the warranted Grants Officer before the application can be deemed eligible for review.

4. Submission Dates and Times

Applications are due no later than **31 January 2024 at 11:59pm (EDT)**.

5. Funding Restrictions

Legal restrictions prevent ISN/CTR from providing assistance to Burma, China, Cuba, Iran, North Korea, South Sudan, Sudan, and Syria.

Under Section 635b of the Foreign Assistance Act, CTR is able to provide awards to for-profit corporations, so long as the for profit does not benefit in profit from the implementation of the award.

6. Other Submission Requirements

All application materials must be submitted through www.Grants.gov unless you are a U.S. Government entity applying for Inter-Agency Agreement (IAA) funding. If you are applying for an IAA please submit proposals to the relevant program team and ISN-CTR-BUDGET@state.gov.

E. APPLICATION REVIEW INFORMATION

1. Criteria

Applicants should note that the following criteria serve as a standard against which all project proposals will be evaluated and identify significant considerations that should be addressed in all proposals. ISN/CTR will award a cooperative agreement to the applicant(s) whose offer represents the best overall value to the government from both a technical and cost perspective.

ISN/CTR will evaluate proposals against the stated criteria. Criteria are listed in descending order of importance.

- **Proposed Activity or Activities:** Applicants should clearly describe what they propose to do and how they will do it. The proposed project(s) must directly relate to meeting the specified objectives and applicants should include specific information on how they will systematically meet ISN/CTR's global threat reduction mission. ISN/CTR will evaluate the project proposal in terms of how well it addresses the issues at hand, relevance and feasibility of the proposed activities, the timeline for completion, and the extent to which the impact of the project will continue beyond the conclusion of the period of performance.
- **Organizational Capability:** Applicants must demonstrate how their resources, capabilities, and experience will enable them to achieve the stated goals and objectives in an international technical context. The proposal(s) must identify all key partners and organizations that will be involved in implementation of this project.
- **Budget:** Proposed costs will be evaluated for feasibility, fiscal control practices, and efficiency. ISN/CTR must be able to determine that proposed costs are reasonable, allowable, and allocable to the proposed project activities. ISN/CTR will evaluate the budget to determine if the overall costs are realistic for the work to be performed, if the costs reflect the applicant's understanding of the allowable cost principles established by 2CFR200, and if the costs are consistent with the program narrative.
- **Impactful and Measurable Engagements:** Although complex nonproliferation objectives demand persistent engagement with partner countries, discrete projects should individually advance progress toward a particular objective. Proposals should describe the end-state the project aims to achieve, along with specific, measurable, and realistic benchmarks by which to gauge progress toward that end state. Compelling project proposals will establish milestones to be met during the implementation period, and describe observable progress in meeting the program goals described above.

- **Diversity and Inclusion:** ISN/CTR values collaboration and promotes diversity, equity, and inclusion with all stakeholders by creating an environment that is open to equal opportunities without regard to race, color, religion, sex, sexual orientation, gender identity, national origin, protected veteran or disabled status. Implementers are welcome but not required to submit with their proposal a plan for how the implementer intends to further ISN/CTR's diversity, equity, inclusion, and accessibility (DEIA) objectives through their programming. Submitted plans will be evaluated separate to the overall evaluation of projects and

- **Cyber Security:** Implementer shall be required to establish and follow policy and procedures for an effective implementation of security controls using NIST 800-53 (Rev. 5 or higher)), System and Information Integrity Policy (SI-1) as follows:

- a. Identification and Authentication: Implement multifactor authentication for network access and local access.
- b. Access Controls: Implement security controls for information sharing, remote access and wireless access including: Monitoring, controlling, and protecting remote and wireless access to information by auditing information systems components (e.g., workstations, notebook computers, smartphones, and tablets).
- c. Incident Handling: Monitor and report any and all security incidents including breaches to ISN/CTR directly within 48 hours of the incident and include a risk assessment of the security access controls.

2. Review and Selection Process

A review committee will evaluate all eligible applications, final funding decision will be made by ISN/CTR Office Director and Deputy Director.

3. Responsibility/Qualification Information in SAM.gov (formerly, FAPIIS)

- i. The Federal awarding agency, prior to making a Federal award with a total amount of Federal share greater than the simplified acquisition threshold, is required to review and consider any information about the applicant that is in the U.S. government designated integrity and performance system accessible through SAM.gov (see 41 U.S.C. 2313);
- ii. An applicant, at its option, may review and comment on any information about itself that a Federal awarding agency previously entered. Currently, federal agencies create integrity records in the integrity module of the Contractor Performance Assessment and Reporting System (CPARS) and these records are visible as responsibility/qualification records in SAM.gov;

iii. The Federal awarding agency will consider any comments by the applicant, in addition to the other information in the designated integrity and performance system, in making a judgment about the applicant's integrity, business ethics, and record of performance under Federal awards when completing the review of risk posed by applicants as described in §200.206 Federal awarding agency review of risk posed by applicants.

F. FEDERAL AWARD ADMINISTRATION INFORMATION

1. Federal Award Notices

The grant award or cooperative agreement will be written, signed, awarded, and administered by the Grants Officer. The assistance award agreement is the authorizing document and it will be provided to the recipient for review and signature by email. The recipient may only start incurring program expenses beginning on the start date shown on the grant award document signed by the Grants Officer.

If a proposal is selected for funding, the Department of State has no obligation to provide any additional future funding. Renewal of an award to increase funding or extend the period of performance is at the discretion of the Department of State.

Issuance of this NOFO does not constitute an award commitment on the part of the U.S. government, nor does it commit the U.S. government to pay for costs incurred in the preparation and submission of proposals. Further, the U.S. government reserves the right to reject any or all proposals received.

Payment Method: Payment Management System or SF-270 on a monthly basis.

In accordance with the [Executive Order on Advancing Racial Equity and Underserved Communities](#), proposals should demonstrate how the program advances equity with respect to race, ethnicity, religion, income, geography, gender identity, sexual orientation, and disability. The proposal should also demonstrate how the program will further engagement in underserved communities and with individuals from underserved communities. Proposals should demonstrate how addressing racial equity and underserved communities will enhance the program's goals and objectives, as well as the experience of participants.

The support of underserved communities will be part of the review criteria for this opportunity. Therefore, proposals should clearly demonstrate how the program will support and advance equity and engage underserved communities in program administration, design, and implementation.

3. Reporting

Reporting Requirements: Recipients will be required to submit financial reports and program reports. The award document will specify how often these reports must be submitted.

Foreign Assistance Data Review: As required by Congress, the Department of State must make progress in its efforts to improve tracking and reporting of foreign assistance data through the Foreign Assistance Data Review (FADR). The FADR requires tracking of foreign assistance activity data from budgeting, planning, and allocation through obligation and disbursement. Successful applicants will be required to report and draw down federal funding based on the appropriate FADR Data Elements, indicated within their award documentation. In cases of more than one FADR Data Element, typically program or sector and/or regions or country, the successful applicant will be required to maintain separate accounting records.

Applicants should be aware of the post award reporting requirements reflected in [2 CFR 200 Appendix XII—Award Term and Condition for Recipient Integrity and Performance Matters](#).

H. OTHER INFORMATION

Guidelines for Budget Justification

Personnel and Fringe Benefits: Describe the wages, salaries, and benefits of temporary or permanent staff who will be working directly for the applicant on the program, and the percentage of their time that will be spent on the program.

Travel: Estimate the costs of travel and per diem for this program, for program staff, consultants or speakers, and participants/beneficiaries. If the program involves international travel, include a brief statement of justification for that travel.

Equipment: Describe any machinery, furniture, or other personal property that is required for the program, which has a useful life of more than one year (or a life longer than the duration of the program), and costs at least \$5,000 per unit.

Supplies: List and describe all the items and materials, including any computer devices, that are needed for the program. If an item costs more than \$5,000 per unit, then put it in the budget under Equipment.

Contractual: Describe goods and services that the applicant plans to acquire through a contract with a vendor. Also describe any sub-awards to non-profit partners that will help carry out the program activities.

Other Direct Costs: Describe other costs directly associated with the program, which do not fit in the other categories. For example, shipping costs for materials and equipment or applicable taxes. All “Other” or “Miscellaneous” expenses must be itemized and explained.

Indirect Costs: These are costs that cannot be linked directly to the program activities, such as overhead costs needed to help keep the organization operating. If your organization has a Negotiated Indirect Cost Rate (NICRA) and includes NICRA charges in the budget, attach a copy of your latest NICRA. Organizations that have never had a NICRA may request indirect costs of 10% of modified total direct costs as defined in 2 CFR 200.68.

“Cost Sharing” refers to contributions from the organization or other entities other than the U.S. Embassy. It also includes in-kind contributions such as volunteers’ time and donated venues.

Alcoholic Beverages: Please note that award funds cannot be used for alcoholic beverages.
