OVERVIEW

This project will consider 10 species that are considered vulnerable by both states and the Federal government, identify locations of climate refugia for each species, and map how well each location of refugia is connected to other refugia locations. The project team will map the locations that are most critical to connect habitat that is important for the species today to future climate refugia. This project will aim to ensure that stakeholders can identify and prioritize land that will be accessible and effective to those species.

RECIPIENT INVOLVEMENT

This project leverages existing stakeholder partnerships and ongoing research efforts related to climate refugia in the Northeast region. The project will build on the project team's ongoing adaptation research to identify locations of climate refugia for focal species and then map how

well each location of refugia is connected to other refugia locations. The University of Massachusetts will produce the following:

- Landscape capability for 2020 and climate refugia 2080;
- Maps representing conservation cores in 2020;
- Maps representing refugia cores in 2080 including refugia importance, refugia resilience, and legacy connectivity attributes for each core;
- For each species, maps of conductance and connectors among 2080 refugia;
- For each species, maps of conductance and connectors between the lost 2020 conservation cores and the refugia cores.

USGS INVOLVEMENT

Substantial involvement on the part USGS is anticipated for the successful completion of the objectives to be funded by this award. USGS, in particular the Northeast CASC, will be responsible for the following:

- Assuring that climate research projects are conducted in proper locations in the Northeast Region.
- Identifying collaborators to contribute to project efforts.
- Providing guidance on outreach and engagement activities.
- Reviewing and approving proposed modifications and review award balances.
- Directing and/or redirecting the work because of interrelationships with other related northeastern region climate research projects.

SINGLE-SOURCE JUSTIFICATION

DEPARTMENT OF THE INTERIOR SINGLE SOURCE POLICY REQUIREMENTS
Department of the Interior Policy (505 DM 2) requires a written justification which explains why competition is not practicable for each single-source award. - (5) Emergencies – Program/award where there is insufficient time available (due to a compelling and unusual urgency, or substantial danger to health or safety) for adequate competitive procedures to be followed.
- (6) Cooperative Agreements - USGS Unique Authority cited at 43 U.S.C. 36d (Federal, State, and academic partners) or DOI Authority cited at 43 U.S.C. 1457b (not-for-profit organizations).

USGS did not solicit full and open competition for this award based on the following criteria:

Single Source Justification Description:

(4) UNIQUE QUALIFICATIONS – The applicant is uniquely qualified to perform the activity based upon a variety of demonstrable factors such as location, property ownership, voluntary support capacity, cost-sharing ability if applicable, technical expertise, or other such unique qualifications.

The recipient possesses a unique approach to landscape analysis to inform management options that are important for ecologists and natural resource managers in the Northeast CASC domain. The key to this work is working with stakeholders to identify priorities and developing maps of refugia and connectivity to identify priorities for conservation. The applicant is uniquely qualified to perform the activity based upon pre-existing relationships with key stakeholders in the ecological research and natural resource management communities, support capacity, and technical expertise.

§36d.
