Overview of the Research Opportunity

The Department of War (DoW) announces the Fiscal Year 2027 Defense University Research Instrumentation Program (DURIP). The DoW DURIP, one element of the University Research Initiatives (URI), is sponsored by the DoW research offices. Those offices include the Office of Naval Research (ONR), the Army Research Office (ARO), and the Air Force Office of Scientific Research (AFOSR) (hereinafter collectively referred to as "DoW agencies" or "DoW").

This publication constitutes a Notice of Funding Opportunity (NOFO) as contemplated in the Department of Defense Grants and Agreements regulations (DoDGARS) 32 CFR 22.315(a). The DoW agencies reserve the right to fund all, some, or none of the proposals received under this NOFO. The DoW agencies provide no funding for direct reimbursement of proposal development costs. Technical and budget proposals (or any other material) submitted in response to this NOFO will not be returned. It is the policy of the DoW agencies to treat all proposals submitted under this NOFO as sensitive competitive information and to disclose their contents only for the purposes of evaluation.

DURIP is designed to improve the capabilities of accredited United States (U.S.) [institutions of higher education](#) to conduct research and to educate scientists and engineers in areas important to national defense, by providing funds for the acquisition of research equipment or instrumentation. For-profit organizations are not eligible for DURIP funding. We refer to eligible [institutions of higher education](#) as universities in the rest of this Announcement.

AFOSR/ONR awards will take the form of grants. FOR ARO SUBMISSIONS ONLY, awards will take the form of grants and/or cooperative agreements. Any assistance instrument awarded under this Announcement will be governed by the award terms and conditions that conform to DoW's implementation of the Office of Management and Budget (OMB) circulars applicable to financial assistance. Terms and conditions will reflect DoW implementation of OMB guidance in 2 CFR Part 200, "Uniform Administrative Requirements, Cost Principles, and Audit Requirements for Federal Awards."

(6) Funding Details

Funded Amount and Period of Performance

The total amount of funding for the 12 months available for grants resulting from this DURIP NOFO is estimated to be approximately \$28 million dollars pending appropriations. DURIP awards are contingent on availability of funds and the scope of the proposed acquisition and intended research and education. Typical funding per grant is \$50,000 to \$3,000,000. The amount of the award should generally not exceed the specified limit. Awardees have the option to request a no-cost extension for up to an additional 12-months with sufficient justification. **It is expected that DURIP awards will be completed within the initial 12-month period of performance.**

It is strongly recommended that Applicants communicate with the technical program officers at the respective component agencies they are submitting to. Depending on the results of the proposal evaluation, there is no guarantee that any of the proposals submitted will be recommended for funding.

Each administering component agency will make grant awards to fund the purchase of research equipment or instrumentation costing \$50,000 to \$3,000,000 that cannot typically be purchased within the budgets of single-investigator awards. We refer to this as major equipment or instrumentation for the remainder of the announcement. We generally cannot make any individual award that exceeds more than \$3,000,000 in DoW funding unless your proposal qualifies for one of the two exceptions listed in section [b.3.ii, Amount of Requested DoW Funding](#).

NOTE: AFOSR will not consider any request for exception above \$7,000,000.

We can make awards to universities conducting, or demonstrably capable of conducting, research in areas of interest to the DoW with the new equipment or instrumentation proposed.

(7) Key Dates

Pre-proposal inquiries and questions must be submitted not later than **Friday, 16 October 2026, at 11:59 PM Eastern Time.**

Proposals must be received electronically through Grants.gov by **Friday, 06 November 2026, at 5:00 PM Eastern Time.**

(8) Executive Summary

Since its inception, DURIP has provided equipment and instrumentation to enhance basic research capability and research-related education in areas of interest and priority to the DoW.

DoW interests include the areas of research supported by the Army Research Office (ARO), the Office of Naval Research (ONR), and the Air Force Office of Scientific Research (AFOSR), hereafter generally referred to collectively as “we,” “our,” “us,” or “administering agency.” We use “administering agency” to provide a generic reference to any of the administering DoW component agencies.

The DURIP is executed with the hope that these awards facilitate the growth of the U.S. base of STEM professionals as well as enable U.S. institutions of higher education to address the Department’s unique problem sets. It is imperative that proposals address the impact of the equipment and instrumentation on the institution’s ability to educate students through research in disciplines important to DoW missions.

(10) Gold Standard Science (GSS):

- (i) In Accordance with Executive Order (EO) 14303, Gold Standard Science (GSS) is defined as science conducted in a manner that is:
 - A. reproducible;
 - B. transparent;
 - C. communicative of error and uncertainty;
 - D. collaborative and interdisciplinary;
 - E. skeptical of its findings and assumptions;
 - F. structured for falsifiability of hypotheses;
 - G. subject to unbiased peer review;
 - H. accepting negative results as positive outcomes; and,
 - I. without conflicts of interest.
- (ii) Expectations of Adherence to Gold Standard Science and EO 14332: The DoW expects the highest standards of scientific rigor, integrity, and adherence to appropriate tenets of GSS. For more on these standards and DoW expectations, see <https://www.cto.mil/gold-standard-science-implementation-plan/>.
- (iii) To meet the EO 14332 requirement with regards to GSS, applications/proposals shall include a commitment to complying with administration policies, procedures, and guidance respecting GSS. By responding to this NOFO you explicitly agree to the following statements:
 - A. Our institution understands the definition of Gold Standard Science as outlined above.
 - B. Our institution and all personnel involved in the proposed project will adhere to all administration policies, procedures, and guidance respecting Gold Standard Science in the execution of this project if funded.
- (iv) By responding to this NOFO you explicitly agree to the following statements:
 - A. Our institution understands the definition of Gold Standard Science as outlined above.
 - B. Our institution commits to achieving Gold Standard Science, and all personnel involved in the proposed project will adhere to all administration policies, procedures, and guidance respecting Gold Standard Science in the execution of this project if funded.

(b) Eligibility

(1) Eligible Applicants

This competition is open to accredited U.S. institutions of higher education with degree granting programs in science, mathematics, and/or engineering except for-profit educational institutions.

University Affiliated Research Centers (UARCs) are eligible to participate in this competition.

Federally Funded Research and Development Centers are not eligible to participate.

To assess risk posed by Applicants, we review your application, proposal, and Office of Management and Budget (OMB) designated repositories of government-wide public and non-public data, including comments you have made, as required by [41 U.S.C. § 2313](#) and described in 2 CFR § 200.206 and 32 CFR § 22.415 to confirm you are qualified, responsible, and eligible to receive an award. Under national security directives, Department components conduct risk-based security reviews on proposals to prevent conflicts of interest and foreign influence. *See* Section (f)(4) below.

You may submit a single DURIP proposal to more than one administering agency; however, only one administering agency will fund it, if selected. There is no limit on the total number of different proposals you can submit.

There is no limit to the number of awards a single Applicant organization can receive under this competition. Selections are based on our criteria.

(2) Cost Sharing or Matching

We do not require cost sharing or matching for proposals under this Announcement. You are not prohibited from including voluntary committed cost sharing or matching in your proposal. Cost sharing or matching is not an evaluation factor. Letters of support/commitment are not required.

(3) Other

(i) Eligible Equipment and Instrumentation

DURIP funds must be used for the acquisition of major equipment or instrumentation to augment current, or develop new, research capabilities to support research in the technical areas of interest to the DoW. Your proposal may request funding for more than one item if the requested items comprise a “system” that is used for a common research purpose. Requests for computing equipment for DoW-relevant research programs are appropriate and eligible for funding. Proposals for purely instructional equipment or general-purpose computing facilities are not eligible for DURIP funding.

(4) Funding Restrictions

(i) Section 889 of the National Defense Authorization Act (NDAA) for Fiscal Year (FY) 2019 (Public Law 115-232) prohibits the head of an executive agency from obligating or expending loan or grant funds to procure or obtain; extend, or renew a contract to procure or obtain; or, enter into a contract (or extend or renew a contract) to procure or obtain the equipment, services, or systems prohibited systems as identified in section 889 of the NDAA for FY 2019.

A. In accordance with 2 CFR §§ 200.216 and 200.471, recipients and subrecipients of all awards that are issued on or after August 13, 2020 are prohibited from obligating or expending loan or grant funds to:

- (1) Procure or obtain;
- (2) Extend or renew a contract to procure or obtain; or,
- (3) Enter into a contract (or extend or renew a contract) to procure or obtain equipment, services, or systems that uses covered telecommunications equipment or services as a substantial or essential component of any system, or as critical technology as part of any system. As described in Public Law 115-232, section 889, covered telecommunications equipment is telecommunications equipment produced by Huawei Technologies Company or ZTE Corporation (or any subsidiary or affiliate of such entities).

- (i) For the purpose of public safety, security of government facilities, physical security surveillance of critical infrastructure, and other national security purposes, video surveillance and telecommunications equipment produced by Hytera Communications Corporation, Hangzhou Hikvision Digital Technology Company, or Dahua Technology Company (or any subsidiary or affiliate of such entities).
 - (ii) Telecommunications or video surveillance services provided by such entities or using such equipment.
 - (iii) Telecommunications or video surveillance equipment or services produced or provided by an entity that the Secretary of War, in consultation with the Director of the National Intelligence or the Director of the Federal Bureau of Investigation, reasonably believes to be an entity owned or controlled by, or otherwise connected to, the government of a covered foreign country.
- B. In implementing the prohibition under Public Law 115-232, section 889, subsection (b), paragraph (2), heads of executive agencies administering loan, grant, or subsidy programs shall prioritize available funding and technical support to assist affected businesses, institutions and organizations as is reasonably necessary for those affected entities to transition from covered communications equipment and services, to procure replacement equipment and services, and to ensure that communications service to users and customers is sustained.
- C. *See* Public Law 115-232, section 889 (f) for additional information. “Covered Foreign Country” means the People’s Republic of China.
- (ii) With few exceptions, a DURIP award provides between \$50,000 and \$3,000,000 in DoW funding for the purchase of major equipment or instrumentation.

You may submit a proposal to purchase major equipment or instrumentation costing more than \$3,000,000 under either of the following two (2) conditions:

(1) Your proposal contains a firm commitment from your institution to provide voluntary committed cost sharing or matching so the cost to DoW remains \$3,000,000 or less; or, (2) your proposal requests the administering agency that receives your proposal to grant an exception to the \$3,000,000 maximum amount of DoW funding. At the administering agency’s discretion, your proposal may be considered if it is warranted by priority defense research need or needs.

Exceptions to the \$3,000,000 limit are expected to be rare.

We strongly recommend you communicate with the administering agency before you submit any formal proposal.

NOTE: AFOSR will not consider any request for exception above \$7,000,000, cost-sharing included.

We reserve the right to select and fund for award, all, some, part, or none of the proposals received. There is no guarantee of award.

(iii) DURIP-Specific Funding Restrictions

(c) Program Description

In accordance with EO 14332, Improving Oversight of Federal Grantmaking, dated 7 August 2025, and EO 14303, Restoring Gold Standard Science, dated 23 May 2025, this Announcement seeks

proposals from universities to purchase equipment and instrumentation in support of research in areas of interest to the DoW, reflecting the basic research priorities for the Department of War and advancing the administration and agency priorities (c.f., [OMB memo M-25-34](#) “Fiscal Year 2027 Administration Research and Development Budget Priorities and Cross-Cutting Actions”).

DoW interests include the areas of research supported by the Army Research Office (ARO), the Office of Naval Research (ONR), and the Air Force Office of Scientific Research (AFOSR).

A central purpose of the DURIP is to provide equipment and instrumentation to enhance research related education in areas of interest and priority to the DoW. Therefore, your proposal must address the impact of the equipment or instrumentation on your institution’s ability to educate students through research in disciplines important to DoW missions.

Basic research is systematic study directed toward greater knowledge or understanding of the fundamental aspects of phenomena and of observable facts without specific applications towards processes or products in mind. It includes all scientific study and experimentation directed toward increasing fundamental knowledge and understanding in those fields of the physical, engineering, environmental, and life sciences related to long-term national security needs. It is farsighted high payoff research that provides the basis for technological progress (DoD 7000.14-R, vol. 2B, Chapter5, Section 1.51.)

IAW Executive Order 14332, all technical program descriptions contained in the respective Administering Agency’s Broad Agency Announcements reflect the basic research priorities for the respective departments and are defined to advance the administration and agency priorities (c.f., OMB memo M-25-34 “Fiscal Year 2027 Administration Research and Development Budget Priorities and Cross-Cutting Actions”).

(1) Instrument Type

The authority for DURIP awards is 10 U.S.C. § 4001 in accordance with 31 U.S.C. § 6301 et seq. The applicable regulations are 2 CFR § 200, “Uniform Administrative Requirements, Cost Principles, and Audit Requirements for Federal Awards,” as implemented by 2 CFR, Subtitle B, Chapter XI, Subchapter A and DoDGARs at 32 CFR, Subchapter C.

- (i) Grant: A legal instrument consistent with 31 U.S.C. § 6304, is used to enter into a relationship:
 - A. The principal purpose of which is to transfer a thing of value to the recipient to carry out a public purpose of support or stimulation authorized by a law or the United States, rather than to acquire property or services for the Federal Government’s direct benefit or use.
 - B. Substantial involvement is not expected between the Federal Government and the recipient when carrying out the activity contemplated by the grant.
 - C. No fee or profit is allowed.
- (ii) Cooperative Agreement (ARO only): A legal instrument which, consistent with 31 U.S.C. § 6305, is used to enter into the same kind of relationship as a grant, except:
 - A. Substantial involvement is expected between the Federal Government and the recipient when carrying out the activity contemplated by the cooperative agreement. No fee or profit is allowed. (For information on the substantial involvement DoW expects to have in cooperative agreements, prospective Applicants should contact the Technical Point of Contact identified in the research area of interest.)
 - B. No fee or profit is allowed.
 - C. In accordance with 10 U.S.C. § 4021(i), as amended, the following information submitted during the solicitation and award process of Cooperative Agreement for performance of basic, applied, or advanced research authorized by section 4001 are exempt from disclosure requirements of 5 U.S.C. § 552, the Freedom of Information Act (FOIA), for a period of five years from the date the Department receives the information. Offeror’s should mark the following documents with a legend asserting that they are submitted on a confidential basis:
 - (1) A proposal, proposal abstract, and supporting documents;
 - (2) A business plan submitted on a business proprietary basis; and,
 - (3) Technical information submitted on a controlled basis, as outlined in DoDI 5230.24, Distribution Statements on Technical Documents.

(d) Application Contents and Format

(1) Content and Form of Application Submission

(i) General Information

All submissions will be protected from unauthorized disclosure in accordance with applicable law and DoW regulations. Applicants are expected to appropriately mark each page of their submission that contains proprietary information. Titles given to the submissions should be descriptive of the work they cover and not be merely a copy of the title of this Announcement.

Prospective awardees are encouraged to contact technical PO/PMs prior to submitting a proposal to minimize the labor and cost associated with the production of detailed proposals that have very little chance of being selected for funding. The technical PO/PMs may provide informal feedback to the prospective awardees to encourage or discourage submission of proposals. The technical PO/PM may also, on occasion, provide feedback encouraging further strengthening of a proposal.

(ii) Distribution Markings

The proposals submitted under this NOFO are expected to address acquisition of equipment or instrumentation for unclassified basic research.

For proposals containing data that the Applicant does not want disclosed to the public for any reason, or used by the Government except for evaluation purposes, the Applicant shall mark the title page with the following legend:

“This proposal includes data that shall not be disclosed outside the Government and shall not be duplicated, used, or disclosed--in whole or in part--for any purpose other than to evaluate the proposal or for program coordination. If, however, a grant is awarded to this Applicant as a result of, or in connection with, the submission of this data, the Government shall have the right to duplicate, use, or disclose the data to the extent provided in the resulting award. This restriction does not limit the Government’s right to use information contained in this data if it is obtained from another source without restriction. The data subject to this restriction is contained in

(insert numbers or other identification of sheets).”

Also, mark each sheet of data that the Applicant wishes to restrict with the following legend: “Use or disclosure of data contained on this sheet is subject to the restriction on the title page of this proposal.”

(iii) Full Proposals

The administering agencies require Applicants to submit their applications online through Grants.gov. Prospective Applicants must complete the mandatory forms in accordance with the instructions provided on the forms and the additional instructions below. Files that are attached to the forms must be in Adobe Portable Document Format (.PDF); cannot contain macros; and cannot be password protected. **If any attachment is not a PDF, contains macros or is password protected, they will not pass the automated acceptance check and will need to be resubmitted prior to the submission deadline.**

NOTE: The electronic file name for all documents submitted under this NOFO must not exceed 68 characters in length, including the file name extension.

Grants.gov provides Applicants 24/7 support via the toll-free number 1-800-518-4726 and email at support@grants.gov. For questions related to the specific grant opportunity, contact the number listed on the application package of the grant you are applying for.

If you are experiencing difficulties with your submission, it is best to call the Grants.gov Support Center and get a ticket number. The Support Center ticket number will assist the administering agency with tracking your issue and understanding background information on the issue.

(f) Application Review Information

(1) Timely Receipt Requirements and Proof of Timely Submission

(i) Online Submissions

All applications must be received by **5:00 PM Eastern Time on 06 November 2026**. Proof of timely submission is automatically recorded by Grants.gov. An electronic date/time stamp is generated within the system when the application is successfully received by Grants.gov. The Applicant AOR will receive an acknowledgement of receipt and a tracking number (GRANTXXXXXXXX) from Grants.gov with the successful transmission of their application. Applicant AORs will also receive the official date/time stamp and Grants.gov Tracking number in an email serving as proof of their timely submission.

When the DoW agency successfully retrieves the application from Grants.gov, and acknowledges the download of submissions, Grants.gov will provide an electronic acknowledgment of receipt of the application to the email address of the Applicant with the AOR role. Again, proof of timely submission shall be the official date and time that Grants.gov receives your application. Applications received by Grants.gov after the established due date for the program will be considered late and will not be considered for funding by the DoW agency.

Applicants using unreliable internet connections should be aware that the process of completing the Workspace can take some time. Therefore, Applicants should allow enough time to prepare and submit the application before the package closing date. Grants.gov will provide either an error or a successfully received transmission in the form of an email sent to the Applicant with the AOR role attempting to submit the application. The Grants.gov Support Center reports that some Applicants end the transmission because they think that nothing is occurring during the transmission process. Please be patient and give the system time to process the application.

DoW strongly recommends submitting applications no later than two (2) business days ahead of submission deadline to ensure sufficient time for any corrections that may be required.

(ii) Proposal Receipt Notice

After a proposal is submitted through Grants.gov, the Authorized Organization Representative (AOR) will receive a series of three emails. It is extremely important that the AOR watch for and save each of the emails. You will know that your proposal has reached the DoW agency when the AOR receives email Number 3. You will need the Submission Receipt Number (email Number 1) to track a submission. The three emails are:

- A. Email Number 1 – The Applicant will receive a confirmation page upon completing the submission to Grants.gov. This confirmation page is a record of the time and date stamp that is used to determine whether the proposal was submitted.
- B. Email Number 2 – The Applicant will receive an email indicating that the proposal has been validated by Grants.gov within two days of submission (This means that all of the required fields have been completed). After an institution submits an application, Grants.gov generates a submission receipt via email and also sets the application status to "Received." This receipt verifies the application has been successfully delivered to the Grants.gov system. Next, Grants.gov verifies the submission is valid by ensuring it does not contain viruses, the opportunity is still open, and the Applicant login and Applicant UEI number match. If the submission is valid, Grants.gov generates a submission validation receipt via email and sets the application status to "Validated." If the application is not validated, the application status is set to "Rejected." The system sends a rejection email notification to the institution, and the institution must resubmit the application package. Applicants can track the status of their application by logging in to Grants.gov.
- C. Email Number 3 – The third notice is an acknowledgment of receipt via email from DoW within ten days from the proposal due date, if applicable. The email is sent to the authorized representative for the institution. The email notes that the proposal has been received and provides the assigned tracking number.

(2) Specific Review Criteria

- (i) We have three (3) evaluation criteria for this competition. The criteria are of equal importance to each other. Proposal evaluation will encompass the full evaluation consistent with DODGARS 22.315.
 - A. The impact of your proposed equipment or instrumentation on research DoW funds, or plans to fund, and/or the likelihood your proposed equipment or instrumentation will enhance current research capabilities or establish new research capabilities relevant to DoW areas of interest; and,
 - B. The importance and priority to DoW missions of research your proposed equipment or instrumentation will support; and,
 - C. The potential your proposed equipment or instrumentation offers to enhance your institution's ability to educate future scientists and engineers through research conducted with the proposed equipment in disciplines important to DoW missions.

You should show strength in as many of the evaluation areas as practicable to demonstrate maximum competitiveness.

(3) Review and Selection Process

(i) General Information

The ultimate recommendation for award of proposals is made by the DoW's scientific/technical community. Recommended proposals will then be forwarded to ONR, AFOSR, or ARO Contracts and Grant Awards Management Office. Any notification received from the DoW agency that indicates that the Applicant's proposal has been recommended does not guarantee an award will ultimately be made. This notice indicates that the proposal has been selected in accordance with the evaluation criteria stated above and has been sent to the Grants Department to conduct cost analysis, determine the Applicant's responsibility, to confirm whether funds are available, and to take other relevant steps necessary prior to commencing negotiations with the Applicant.

(ii) Evaluation

Proposals will undergo a multi-stage evaluation procedure. Cost proposals will be evaluated by Government business professionals. Restrictive notices notwithstanding, one or more support contractors or advisors external to the US Government may be utilized as subject-matter-expert technical consultants. However, proposal selection and award decisions are solely the responsibility of Government personnel. Support contractor employees and peers external to the US Government having access to technical and cost proposals submitted in response to this NOFO will be required to sign a non-disclosure and a conflict of interest statement prior to receipt of any proposal submission. Findings will be forwarded to senior DoW officials who will make funding recommendations to the Awarding officials.

Due to the nature of the DURIP program, the reviewing official(s) may on occasion recommend that less than an entire DURIP proposal be selected for funding. This may be due to several causes, including but not limited to, insufficient funds or overlap among proposals received. In such cases, proposal adjustments will be agreed to by the Principal Investigator and the Government prior to final award.

(4) Risk Review

- (i) The Grants Officer is responsible for determining a recipient's qualification prior to award. In general, a Grants Officer will award grant and cooperative agreements only to qualified recipients that meet the standards at 32 CFR § 22.415. To be qualified, a potential recipient must:
- A. Have the management capability and adequate financial and technical resources, given those that would be made available through the grant or cooperative agreement, to execute the program of activities envisioned under the grant or cooperative agreement;
 - B. Have a satisfactory record of executing such programs or activities (if a prior recipient of an award);
 - C. Have a satisfactory record of integrity and business ethics; and,
 - D. Be otherwise qualified and eligible to receive a grant or cooperative agreement under applicable laws and regulations. Applicants are requested to provide information with proposal submissions to assist the Grants Officer's evaluation of recipient qualification.

(ii) Risk-based Security Review Process

All Covered Individuals proposed under all grants and cooperative agreements are subject to the DoW Fundamental Research Risk-Based Security Review Process. In accordance with applicable laws and regulations and as designated by DoW policy, Covered Individuals are

individuals who contribute in a substantive, meaningful way to the scientific development or execution of a research and development project, including the principal investigator (PI) and co-PI(s).

This risk-based security review process provides consistency in policy and procedures across all DoW Components. Risk-based security reviews will be conducted for all fundamental research proposals that are identified as “selected for award based on technical merit.” The risk-based security reviews will be conducted by reviewing the Standard Form (SF) 424, “Senior/Key Person Profile (Expanded),” its accompanying or referenced documents, Common Disclosure Forms, and the Research Performance Progress Reports (when applicable), in concert with a risk decision matrix consistent with DoW’s Decision Matrix to Inform Fundamental Research Proposal Mitigation Decisions.

University or non-profit research institution performance under this solicitation will be efforts categorized as fundamental research. In addition to Government support for free and open scientific exchanges and dissemination of research results in a broad and unrestricted manner, the academic or non-profit research performer or recipient, regardless of tier, acknowledges that such research may have implications that are important to U.S. national interests and must be protected against foreign influence and exploitation. As such, the academic or non-profit research performer or recipient agrees to comply with the following requirements:

- A. On June 8, 2023, the Undersecretary of War for Research and Engineering (OUSW (R&E)) released a memorandum, “[Policy on Risk-Based Security Reviews on Fundamental Research](#),” directing Components to establish a risk-based security review program to identify and mitigate undue foreign influence in fundamental research consistent with the requirements mandated by National Security Presidential Memorandum (NSPM)-33. In accordance with these requirements, all Covered Individuals proposed under all fundamental research proposals that are selected for award will be assessed for potential undue foreign influence risk factors relating to professional and financial activities. This will be done by evaluating information provided via the SF- 424 and any accompanying or referenced documents, as well as the Common Disclosure Forms and Research Performance Progress Reports, as applicable, to identify and assess any associations or affiliations the Covered Individuals may have with foreign countries of concern (FCOC) (i.e., The Peoples Republic of China, the Russian Federation, the Islamic Republic of Iran, and the Democratic People’s Republic of North Korea) or FCOC connected entities.
- B. The University or non-profit research institution, performer, or recipient agrees to provide information on potential conflicts of interest and conflicts of commitment associated with foreign influence in their biographical sketch and current and pending support.
 - (1) The above-described information will be provided to the Government as part of the proposal response to the solicitation and will be reviewed and assessed utilizing a risk-based security review process prior to award. Generally, this information will be included in the Research and Related Senior/Key Personnel Profile (Expanded) form (SF-424) and Common Disclosure Forms required as part of the proposer’s submission through Grants.gov.
 - (i) Instructions regarding how to fill out the SF-424 and its Biographical Sketch and Current and Pending Support can be found through Grants.gov.
 - (2) The risk-based security review process takes into consideration the entirety of the Covered Individual’s SF-424, Senior/Key Personnel Expanded Form, Current and Pending Support, and Biographical Sketch. Any identified potential risk factors, along with publicly or commercially available validation information, are then compared to the “2026 DoW Component Decision Risk Matrix to Inform

Fundamental Research Proposal Mitigation Decisions” to determine the level of mitigation that may be required to proceed, if possible.

- (3) The risk-based security review process will leverage, among other things, publicly available lists or reports published by the U.S. federal government and cited in the “ 2026 Decision Matrix to Inform Fundamental Research Proposal Mitigation Decisions”:

- (4) Congress has explicitly stated that there are foreign influence risks that are not able to be mitigated and thus would require denial of award. They are:
 - (i) Beginning 1 October 2023, no U.S. institution of higher education that hosts a Confucius Institute* may receive DoW funding. Institutions hosting a Confucius Institute are automatically classified as “prohibited” under OUSW (R&E)’s “Policy on Risk Based Security Reviews on Fundamental Research,” as required by law.
 - (ii) Beginning 9 August 2024, the DoW is prohibited from funding or making an award of a fundamental research project proposal in which a covered individual is actively participating in a malign foreign talent recruitment program, pursuant to section 10632 of the CHIPS and Science Act of 2022. Individuals participating in such a program are automatically classified as “prohibited” under OUSW(R&E)’s “Policy on Risk Based Security Reviews on Fundamental Research,” as required by law.

* The term “Confucius Institute” means a cultural institute directly or indirectly funded by the Government of the People's Republic of China.
- (5) Any changes to Covered Individuals will require submission of an SF 424 and its attachments, Common Disclosure Forms, a security-based risk assessment, and approval by the contracting officer and program manager.
- (6) Security-based risk assessments will also be conducted if changes to Covered Individuals reporting criteria are reflected in the Research Performance Progress Reports.
- (7) To the greatest extent practicable, the DoW will work with the proposing institution to ensure that if the risk is able to be mitigated, it will make every effort to do so. If the proposing institution refuses to, or is unable to mitigate the identified risks, it may result in a denial of award.
- (8) Proposing institutions who have their technically acceptable fundamental research proposal rejected due to the risk-based security review process may challenge the risk-based security review decision. In that instance, the OUSW(R&E) will reconsider the project proposal as well as any additional documentation provided by the proposing institution to ensure that the risk-based security review was performed consistent with OUSW(R&E) policy.
- (9) This process, to include negotiation of risk mitigation measures, is not to be considered as part of the time-to-award.

C. Involvement of Covered Individuals in Malign Foreign Talent Recruitment Programs.

- (1) If, at any time during performance of this research award, the academic or non- profit

research performer or recipient should learn that it, its Covered Individuals, or applicable team members or subtier performers on this award are, or are believed to be, participants in a malign foreign government talent program or exhibiting behaviors/actions identified in the DoW Component Decision Matrix to Inform Fundamental Research Proposal Mitigation Decisions (i.e., funding from a Foreign Country Of Concern (FCOC) or FCOC-connected entity, patents resulting from U.S. government funded research that were filed with a FCOC or on behalf of a FCOC-connected entity, and associations or affiliations with foreign government connected entities), the performer or recipient will notify the Government Contracting Officer or Agreements Officer within 5 business days.

- (i) This disclosure must include specific information as to the personnel involved and the nature of the situation and relationship. The Government will have 30 business days to review this information and conduct any necessary fact-finding or discussion with the performer or recipient.
- (ii) Such disclosure could result in a termination of award at the government's discretion.
- (iii) If the University receives no response from the Government to its disclosure within 30 business days, it may presume that the Government has determined the disclosure does not represent a threat.

- (2) The performer or recipient must flow down this provision to any subtier contracts or agreements involving direct participation in the performance of the research.

D. All analysis and assessment of affiliations and associations of Covered Individuals are compliant with Title VI of the Civil Rights Act of 1964. Information regarding race, color, or national origin is not collected and does not have bearing in the risk assessment. University or non-profit research institutions with proposals selected for negotiation that have been assessed as having potential undue foreign influence risk factors, as defined by the DoW Decision Matrix to Inform Fundamental Research Proposal Mitigation Decisions, will be given an opportunity during the negotiation process to mitigate the risk. The DoW reserves the right to request any follow-up information needed to assess potential risk factors or proposed risk mitigation strategies.

E. Definitions: Definitions can be found in the June 08, 2023 USD(R&E) memorandum, "Policy for Risk Based Security Reviews of Fundamental Research," or as it is amended.

(iii) AFOSR – Specific Fundamental Research Security Review (FRSR) Information

- A. Security Risk Review. Each proposal submission will be subject to a Risk-based Security Review prior to selection for award. The Risk-based Security Review is applied to federally funded research designed to help protect Department of the Air Force Science and Technology (S&T) by identifying possible vectors of undue foreign influence. AFRL will follow all policy and procedures outlined in Air Force Research Laboratory (AFRL) Instruction AFRLI 61-113, Science and Technology Protection for the Air Force Research Laboratory and Department of the Air Force Instruction DAFI 63-101/20-101, Integrated Lifecycle Management. The Risk-based Security Review will be conducted in accordance with OUSD(R&E)'s "Policy for Risk Based Security Reviews of Fundamental Research" memo, as amended, and related DoW and Department of the Air Force policy.
- B. Security risk review for these subject proposals will be developed for all proposed Senior/Key personnel and "Covered Individuals." These risk reviews will be based on information disclosed in a Research and Related Senior and Key Person Profile. In

addition, any accompanying or referenced documents, and publicly available information will be utilized in risk reviews. Nationality or citizenship is not a factor in the security risk reviews.

- C. External Engagements. When considering all external engagements, AFRL incorporates a holistic decision-making process that encompasses technical and security factors. The security review method implemented by AFOSR measures risk factors to identify the appropriate Risk Acceptance Authority (RAA) within the organization. The objective analysis of the security risk factors is conducted to empower AFRL's S&T leaders to make risk-informed decisions. The review process looks at the risk factors indicated in the [DoW Component Decision Matrix to Inform Fundamental Research Proposal Mitigation Decisions](#).

D. Actions Required by Applicants/Recipients at Proposal Submission

In accordance with AFRLI 61-113, S&T Protection, Applicants/Recipients are required to submit the following documentation with their proposal:

- (1) Standard Form 424, "Research and Related Senior and Key Person Profile (Expanded), which includes Current and Pending Support and Biosketch Forms (Included in Application Package);
- (2) Collaborators and Other Affiliations. AFOSR accepts the template format required by NSF applicants, [https://nsf.gov-resources/nsf.gov/files/coa_template.xlsx?VersionId=uaz022di3.2KKDC7uauIadw7yeI3Xf.1](https://nsf.gov/resources/nsf.gov/files/coa_template.xlsx?VersionId=uaz022di3.2KKDC7uauIadw7yeI3Xf.1), for identifying this information. AFOSR uses Collaborators and Other Affiliations information during the merit review process to help manage reviewer selection. To expedite identification of potential reviewers, having a standard, searchable format for this information is essential. If you are using a Microsoft Excel document, you must submit it as a PDF document through Grants.gov;
- (3) "Privacy Act Statement" consent form for each Covered Individual that is also signed by the Applicants/Recipients as the Individual's Sponsors (See "Covered Individual" section below and Attachment 1);
- (4) Certification(s) of Covered Individual's Research Security Training. AFOSR accepts and recommends the Research Security Training module on National Science Foundation (NSF) SECURE website; however, Universities may submit certifications from substantially similar training(s). AFOSR requires all Covered Individuals listed on the application for a research and development award to take the training in the 12 months prior to proposal submission. Upon acceptance of proposal, Covered Individuals must submit and maintain annual certifications showing this course was taken yearly;
- (5) Compliance Attestation. You must certify your institution's compliance with OUSW's Research Protection policies as articulated in the most up to date OUSW DoD Component Decision Matrix to Inform Research Proposal Mitigation Decisions on official university letterhead, and attest for the duration of the grant that the recipient confirms that the Covered Individuals participating in the grant are:

In the event a security risk is identified, and the Government has determined the security risk exceeds the acceptable threshold and cannot be mitigated, the Applicant/Recipient will be notified and informed of the decline of award. The Government will provide an unclassified rationale for any rejection of a proposal due to security risks.

By submission of the Research and Related Senior Key Person Profile, the Applicant/Recipient agrees to comply with the following:

E. Actions Required by Covered Individuals

- (1) Covered Individual. An individual who contributes to a substantive, meaningful way to the scientific development or execution of a research and development project proposed to be carried out with a research and development award from a federal research agency; and is designated as a covered individual by the federal research agency concerned. AFOSR further defines that all research oriented positions identified in the proposal are Covered Individuals and thereby subject to disclosure requirements and should have a corresponding Standard Disclosure Form for Senior/Key Personnel Expanded Form, Collaborations and Other Affiliations, Privacy Act Statement, Security Program Questionnaire (if applicable), Certification(s) of Covered Individual's Research Security Training, and Compliance Certification. . *See* 42 U.S.C. § 6605, Definitions. (Note: For purposes of a Notice of Funding Opportunity (NOFO) solicitation, "covered individuals" are Senior/Key Personnel.)
- (2) Federal law requires that all current and pending research support, as defined by 42 U.S.C. § 6605, must be disclosed at the time of proposal submission, for all covered individuals. The Government may require an updated disclosure during the performance of any research project selected for funding. The Government will require an updated disclosure whenever covered individuals are added or identified as

performing under the funded project.

- (3) Covered Individuals are also required to sign the “Privacy Act Statement” and provide such signed statement to the Applicant/Recipient for submission with the proposal. (See Attachment 1).

F. Actions Required by Applicants/Recipients During Period of Performance

- (1) Applicant/Recipient will utilize a section of the Research Progress Performance Report (RPPR) to provide disclosure updates for all Covered Individuals. In addition, whenever a new Covered Individual(s) is to be added or identified as performing under the funded project, a new Research and Related Senior and Key Person Profile Expanded Form, Collaborations and Other Affiliations, Privacy Act Statement, Security Program Questionnaire (if applicable), Certification(s) of Covered Individual’s Research Security Training, and Compliance Certification will be required prior to continued performance.
- (2) If, at any time, during performance of this award, the Applicant/Recipient learns that its Covered Individual (including any sub awardee personnel who receive this designation) are or are believed to be participants in a Foreign Government Talent Program or have Foreign Components with a strategic competitor or country with a history of targeting U.S. technology for unauthorized transfer, the Applicant/Recipient will notify the Contracting/Grants/Agreements Officer within five (5) business days of awareness. Foreign Component is defined as performing any significant scientific aspect of a project outside the United States. This applies whether the activity is conducted by the recipient or a researcher at a foreign organization, regardless of whether grant funds are used.
- (3) This disclosure must include specific information as to the personnel involved and the nature of the situation and relationship. The Government will review this information and conduct any necessary fact-finding or discussion with the Applicant/Recipient. The Government’s determination on disclosure may include: acceptance, mitigation, or termination of the award.
- (4) The Applicant/Recipient will be required to flow down this provision to all sub awardees who have personnel designated as Senior/Key Research Personnel or Covered Individuals as a result of their involvement in the performance of the research.

G. No Guaranteed Award

- (1) AFOSR does not guarantee that any award will be made under this competition

H. Disclosure of Administrative Processing by Contractor Personnel

- (1) AFOSR use support contractor personnel to help it with administrative proposal processing. The contractor personnel are employees of commercial firms that have a contract with AFOSR. AFOSR makes sure all of its support contracts include nondisclosure agreements that prohibit disclosure of any information you submit to other parties.

- A. The Federal awarding agency will consider any comments by the Applicant, in addition to the other information in the designated integrity and performance system (SAM.gov), in making a judgment about the Applicant's integrity, business ethics, and record of performance under Federal awards when completing the review of risk posed by Applicants as described in 2 CFR § 200.205 Federal awarding agency review of risk posed by Applicants.

(g) Federal Award Notices

All Applicants will receive a notification email advising if their proposal has been selected or not selected for award.

Applicants whose proposals are recommended for award may be contacted by a Grant Specialist to discuss additional information required for award. This may include representations and certifications, revised budgets or budget explanations, and/or other information as applicable to the proposed award.

The notification e-mail must not be regarded as an authorization to commit or expend funds. The Government is not obligated to provide any funding until a Government Grants Officer, as applicable, signs the award document.

The award document signed by the Contracting Officer or Grants Officer is the official and authorizing award instrument.

- For ARO: ARO emails their awards/modification documents to the awardees.
- For AFOSR: AFOSR emails their awards/modification documents to the awardees.

Unpaid Delinquent Tax Liability or a Felony Conviction under Any Federal Law – DoW Appropriations

- B. Exception. A Cyber ETP is not required when the research is supported via a grant award and it is unclassified and funded with either basic research funds (i.e., 6.1) or applied research funds (i.e., 6.2) and performed on campus by a university. For all other grants and assistance agreements, a Cyber ETP must be obtained prior to purchase and/or flight operations.
- C. Notwithstanding (B) above, a Cyber ETP is required for all efforts (regardless of award or funding type) that involve interactions with military personnel, DoW property, or DoW facilities; work conducted by US Government laboratories, UARCs, or FFRDCs; or are Public Aircraft Operation (PAO), classified, or explore specific military utility. (xi) Research Integrity
