The U.S. Fish and Wildlife Service (Service) plans to enter into a new grant agreement with the National Fish and Wildlife Foundation (NFWF) to provide financial support for the administration of the Sustain Our Great Lakes grant program. The agreement is part of the Great Lakes Restoration Initiative (GLRI) and is supported by GLRI FY 2016 funding allocated to the Service by the U.S. Environmental Protection Agency - Great Lakes National Program Office. Due to a congressionally formalized relationship between the Service and NFWF, region-specific grant-making expertise, and prior leadership with the Sustain Our Great Lakes program for the past six years, NFWF is the one uniquely qualified partner able to administer the grants associated with this project.

The National Fish and Wildlife Foundation (NFWF) is a non-profit 501(c)(3) organization that was established by Congress in 1984. One of its primary purposes set forth in its establishing legislation (16 USCS 3701-3710) is to assist the U.S. Fish and Wildlife Service (Service) in its efforts to further the conservation and management of fish, wildlife, plants and other natural resources. NFWF's administration of the grants associated with this project would match the intent of Congress outlined in this legislation. NFWF has unparalleled experience in conservation grant-making nationwide, and also specifically within the Great Lakes region. NFWF has administered the Sustain Our Great Lakes grant program for the past nine years, with federal funding support that was initially awarded through a competitive process managed by the U.S. Environmental Protection Agency. With this unique program knowledge, experience and expertise, NFWF is in the position to manage Sustain Our Great Lakes grants efficiently and effectively.
