Overview

The [U.S. Department of Justice](#) (DOJ), [Office of Justice Programs](#) (OJP), [Office for Victims of Crime](#) (OVC) is seeking applications for continuing and expanding on a mass violence needs assessment project that conducts and analyzes assessments in select communities impacted by criminal mass violence. This program furthers the Department's mission and the AG's priorities to reduce violent crime and provide vital services to crime victims. Violent crime can take a physical, psychological, emotional, and financial toll on victims and first responders, which requires effective and appropriate evidence-based responses.

This solicitation incorporates the [OJP Grant Application Resource Guide](#) by reference. The OJP Grant Application Resource Guide provides guidance to applicants to prepare and submit applications for funding. **If this solicitation expressly modifies any provision in the OJP Grant Application Resource Guide, the applicant is to follow the guidelines in this solicitation as to that provision.**

To advance Executive Order 13929 Safe Policing for Safe Communities, the Attorney General determined that all state, local, and university or college law enforcement agencies must be certified by an approved independent credentialing body or have started the certification process to be eligible for FY 2022 DOJ discretionary grant funding. To become certified, the law enforcement agency must meet two mandatory conditions: (1) the agency's use-of-force policies adhere to all applicable federal, state, and local laws and (2) the agency's use-of-force policies prohibit chokeholds except in situations where use of deadly force is allowed by law. The certification requirement also applies to law enforcement agencies receiving DOJ discretionary grant funding through a subaward. Program Description

Overview

OJP is committed to advancing work that promotes civil rights and racial equity, increases access to justice, supports crime victims and individuals impacted by the justice system, strengthens community safety and protects the public from crime and evolving threats, and builds trust between law enforcement and the community. In general, victim-related information pertaining to mass violence and terrorism is largely anecdotal and inadequate to properly identify strengths, weaknesses, and opportunities for improvement in serving victims of these incidents. This project will assess the incidents' impacts on victims and their families, first responders, and the larger community.

Statutory Authority: 34 U.S.C. §§ 20101(d)(5) and 20105(b)

Specific Information

Under an FY 2017 OVC cooperative agreement, the National Mass Violence Victimization Resource Center (Mass Violence Center) at the Medical University of South Carolina (MUSC) began conducting needs assessment surveys under the broader award. The assessments addressed, in part, analyses of mass violence incidents' (MVIs) effects on various populations of victims/survivors, families, first responders, and communities to improve responses to MVIs, treatment of MVI victims by the criminal justice system, and other services to MVI victims. The Mass Violence Center used this approach with an understanding that those who have experienced these events are the best source of information about what happened to them and what they need. This project will continue that effort and the applicant will determine the best method to achieve the project goals.

Goals, Objectives, Deliverables, and Timeline

Goals

The overall goal of this project is to collect and use victim-related data from domestic criminal mass violence and terrorism incidents to better inform OVC's mass violence program and the field about the effects of these events. Ideally, this project will be able to provide actionable information and pathways leading to better support for these victims.

Objectives

The primary objective of this project is to determine whether there are community or individual factors that impact a victim's experience during and after a mass violence incident and, if so, to provide actionable information to better support victims.

Examining select communities where mass violence incidents occurred, the objective would be to analyze information from the communities, select victims, and key stakeholders.

Another objective is to provide information to OVC, victim service and mental health providers, public health entities, and other relevant organizations about the study that will lead to better outcomes for victims.

Deliverables

- Analyze and produce reports on existing data from surveys completed by nearly 6,000 adults in 6 communities impacted by MVIs and over 2,100 adults in Flint, MI who were affected by a large-scale environmental crime.
- Further examine the "ripple effects" of MVIs on communities and produce necessary reports or tip sheets.
- Collect and analyze new data from needs assessments or surveys of 1,500 MVI direct victims/survivors and interviews with 100 key stakeholders in communities and provide appropriate reports, including recommendations.
- Prepare tip sheets, reports, and possible screening tools and other products that provide actionable information to OVC, victim service providers, medical/mental health providers, first responders, and others.

The overall goal of this project is to collect and use victim-related data from domestic criminal mass violence and terrorism incidents to better inform OVC's mass violence program and the field about the effects of these events. Ideally, this project will be able to provide actionable information and pathways leading to better support for these victims. The applicant should describe how they will address this issue by listing the proposed project activities. They should also describe how activities relate to the goals and objectives. The applicant should provide a description of the method(s) to be used in carrying out each activity and provide a timetable indicating approximately when milestones will be accomplished. Small incentives will be considered with strong justification, including an explanation for the amount of the incentive requested.

c. Capabilities and Competencies

This section should demonstrate the applicant's knowledge of the topic and describe the capabilities and competencies to accomplish the project goals and objectives. It should detail staff expertise and responsibilities and include a description of the infrastructure to carry out the tasks, manage contracts/subawards, and produce and disseminate high-quality products. The applicant may provide an organization and management plan in narrative and/or chart form with any charts included as a separate attachment.

d. Plan for Collecting the Data Required for this Solicitation's Performance Measures
