Overview

The [U.S. Department of Justice](#) (DOJ), [Office of Justice Programs](#) (OJP), [Office for Victims of Crime](#) (OVC) seeks applications for funding to support an entity that will (1) competitively select and fund subawards to recruit, train, and deploy paid peer recovery coaches who will assist a family member or caregiver's recovery from substance misuse in order to support the well-being of youth who have experienced victimization as a result of the drug use; (2) provide technical assistance to the selected subawardees; and (3) assist in the development of a peer recovery coach paraprofessional program. This solicitation furthers the DOJ's mission by enhancing the fields response to victims of crime affected by the drug crisis and by ensuring rights, access to services, and equity for all victims of crime.

This solicitation incorporates guidance provided in the [OJP Grant Application Resource Guide](#) which provides additional information for applicants to prepare and submit applications to OJP for funding. **If this solicitation expressly modifies any provision in the OJP Grant Application Resource Guide, the applicant is to follow the guidelines in this solicitation as to that provision.**

Submission Information

Registration and renewal can take up to 10 business days to complete.

Submission: Applications must be submitted to DOJ electronically through a two-step process via Grants.gov and JustGrants.

Program Description

Overview

OJP is committed to advancing work that promotes civil rights and racial equity, increases access to justice, supports crime victims and individuals impacted by the justice system, strengthens community safety and protects the public from crime and evolving threats, and builds trust between law enforcement and the community.

With this solicitation, OVC seeks to fund one lead organization that will (1) competitively select and fund subawards to recruit, train, and deploy paid peer recovery coaches who will assist a family member or caregiver's recovery from substance misuse in order to support the well-being of youth who have experienced victimization as a result of the drug use; (2) provide technical assistance to the selected subawardees; and (3) assist in the development of a peer recovery coach paraprofessional program. By promoting recovery through a peer recovery coaching model, this program will support children, youth, and families, including [kinship families and grandfamilies](#), who have been victimized by neglect, abuse, or violence because of a family member or caregiver's drug use.

For this program, the following definitions apply:

- Drug or substance use or misuse refers to a person misusing a legal substance in a way other than intended or prescribed or using an illegal or controlled substance.
- Peer recovery coach refers to a person who brings the lived experience of recovery, combined with training and supervision, to assist others in initiating and maintaining recovery, helping to enhance the quality of personal and family life in long-term recovery and reducing the amount of abuse and neglect on children, youth, and families affected by the drug crisis. Peer recovery coaches provide many different types of support, including emotional, informational, instrumental, and affiliational (connections to recovery community supports, activities, and events) support. Statutory Authority

OVC anticipates that any funds awarded under this solicitation would be made under statutory authority that provides funding for comprehensive opioid misuse reduction activities, including as authorized by the Comprehensive Addiction and Recovery Act (CARA), and to address opioid, stimulant, and substance use disorders, as provided by the Consolidated Appropriations Act, 2023 (Public Law No: 117-328), Div. B., Title II; 136

Specific Information

OVC is committed to enhancing our Nation's capacity and intentional efforts to provide crime victim services. It provides federal leadership in changing attitudes, policies, and practices to promote justice and comprehensive healing for all victims of crime. Since FY 2018, OVC has advanced innovations and knowledge sharing that have been transformative in supporting children and youth who experience victimization as a result of their exposure to substance use. OVC has supported the implementation of 76 projects across the country including projects serving small, large, urban, rural, and Tribal communities.

Data from the combined 2009 to 2014 National Survey on Drug Use and Health reveal that about 8.7 million (1 in 8) children in the United States live with a parent who has a substance use disorder (SUD).^[i] SUDs often adversely affect the way parents or caregivers interact with and care for their children, contributing to an elevated risk of maltreatment. National data indicate that the prevalence of parental alcohol or other drug use as an identified condition of placement of children in out-of-home care has increased from 18.5 percent in 2000 to 38.9 percent in 2019.^[ii] Studies show that there is substantial overlap between parents involved in the child welfare system and substance use treatment systems.^[iii] Further, children removed from their homes due to parental substance use are less likely to reunify and more likely to have repeated victimizations. Approximately 1 in 5 child fatalities have been associated with parental substance use,^[iv] and children living with a mother with a substance use disorder are twice as likely to have child maltreatment allegations substantiated.^[v] Children who are exposed to a parent with SUDs are also more likely to develop SUD symptoms themselves.^[vi]

Substance use impacts everyone, regardless of age, race, ethnicity, and background. However, research continues to demonstrate that people of color are more likely to experience disparities in accessing care. These disparities are influenced by racial bias, inadequate financial resources, stigma in communities of color, and disproportionate criminalization of drug and alcohol use in Black and brown communities. In addition, Native American communities experience some of the highest rates of drug and alcohol use despite making up a small portion of the population.^[vii]

The Biden-Harris Administration's 2022 National Drug Control Strategy (NDCS) is the first to specifically highlight "Building a Recovery-Ready Nation" as one of its key elements.^[viii] In alignment with the NDCS, achieving a recovery-ready Nation is dependent on recruiting, training, and deploying paid peer recovery coaches who have lived experience with recovery, child welfare, and other systems.

Peer recovery coaches walk side-by-side with individuals seeking recovery from substance use disorders.^[ix] They help people to create their own recovery plan and develop their own recovery pathway. Peer recovery coaches—individuals who have themselves experienced substance use and who have successfully gone through the recovery process—are uniquely appropriate to address the barriers faced by low-income individuals and racial/ethnic minorities, such as stigma, lack of insurance, housing

instability, and challenges navigating services.^[x] Peer recovery plans are customized and build on each individuals' strengths, needs, and recovery goals.^[xi] One study found that parents with a substance use disorder who were involved in the child welfare system and received recovery coaching were significantly more likely to achieve and maintain stable reunification with their children when compared to the parents who received usual services.^[xii] Stable reunification then promotes a safer environment for the children and youth.

Under this program, OVC expects to make a 3-year cooperative agreement award of up to \$4 million to one lead entity to develop and manage a subaward program. In partnership with OVC, the lead entity will competitively select service providers (sites) specializing in recovery from substance use to recruit individuals with lived experience to become trained, certified peer recovery coaches. The lead entity will also provide training and technical assistance (TTA) to the sites and coaches, support collaboration among the sites selected, and support an external program evaluation. The peer recovery coaches will provide coaching to family members or caregivers who have SUDs with the goal of supporting positive outcomes for children, youth, and the entire family, including grandparents, in order to reduce the cycles of abuse, neglect, and violence that can affect those impacted by substance use and misuse.

Goals, Objectives, and Deliverables

Goals

The goal of this initiative is to support children, youth, and families who have suffered victimizations as a result of a family member's or caregiver's substance use disorder by recruiting, training, and certifying peer recovery coaches who have lived experience. The program will result in a peer recovery coach paraprofessional program.

Objectives

- Develop a peer recovery coach-oriented workforce/paraprofessional program that successfully integrates recovery support services and supports individuals' efforts to initiate and sustain their recovery.
- Ensure culturally responsive service provision, equity, and justice. Specific efforts should be made to reach out to and serve marginalized and historically underserved populations.^[xiii]
- Enhance knowledge and build the capacity of peer recovery coaches to serve this population more effectively.
- Use the [key dimensions](#) of recovery-oriented services (health, home, purpose, and community),^[xiv] as well as any new federal model standards for youth, family, and adult peer support.

- Build collaborative arrangements with other organizations or partners to guarantee program success.
- Provide services in non-treatment settings where appropriate.

An applicant should address all the objectives listed above in the Goals, Objectives, Deliverables and Timeline web-based form. The applicant may also add their own goals, objectives, and deliverables.

Deliverables

These are the minimum requirements. Applicants may include additional deliverables in their project design.

- Create and disseminate a national request for applications, in coordination with OVC, to competitively select service providers for subawards. Subawardees will be selected based on their expertise in providing peer recovery support services for individuals experiencing substance use disorders and their capacity to provide quality supervision to peer recovery coaches. The subaward process should be designed to begin subaward activities within 6 months of the release of the request for applications.
- Execute, manage, and monitor subawards.
- Identify options for a robust training and certification curriculum for individuals with lived experience to become peer recovery coaches in a paraprofessional workforce. Training may include evidence-based frameworks or tools to support individuals in their recovery journey.
- Establish an advisory council/steering committee/peer advisory council with diverse expertise, including members in recovery from substance use, to assist with establishing a paraprofessional program of peer recovery coaches.
- Develop strategies that are sustainable and that achieve all intended outcomes that demonstrate progress. Identify guidance for communities to start peer recovery coach programs that benefit families, including kinship families and grandfamilies, and children victimized by neglect, abuse, or violence related to a family member or caregiver's drug use.
- Partner with an external evaluator to support evaluation activities and assessment of subawardees' performance data to determine if the programs are meeting the stated goals and objectives. The evaluation should examine the outcomes associated with a recovery experience led by a peer recovery coach versus without a coach and the impact on children, youth, and families who have suffered victimizations as a result of a substance use disorder.
- Provide technical assistance to the subrecipients with establishing their

Memorandum of Understanding (MOU) between the subawardees and the behavioral health, child welfare, and juvenile justice systems, and others (for example, substance use treatment providers, community-based organizations, recovery community organizations, local mental health and behavioral health authorities, and any other community social service agencies that may provide support services to participants). Ensure MOUs are signed by all participants within 60 days of award funding.

- Produce an annual brief to educate and inform the field on key lessons learned, including project snapshots, replicable strategies, and implementation challenges. An interim and final report should also be produced.
- Facilitate calls, webinars, or other meetings among sites and coaches to support discussion, information exchange, networking opportunities, and peer-to-peer learning.
- Budget for outreach and participation in relevant national conferences and training events to be determined in collaboration with OVC. Develop strategies to expand awareness and build skills and knowledge within the peer recovery support and victim services fields.
- Conduct a minimum of two site visits to each site over the 3-year period and provide TTA on topics such as strategic planning, workforce development, data collection, analysis strategies, etc. The TTA provider should submit a report to OVC after each site visit that summarizes findings and recommended next steps.
- Coordinate with TTA providers from other OJP components, particularly the TTA providers supporting the Bureau of Justice Assistance's Comprehensive, Opioid, Stimulant, and Substance Use Program (COSSUP).
- Work with the subawardees to develop the paraprofessional peer recovery coach program including a sustainability plan to involve ongoing new relationships with behavioral health providers, among others. Develop and document a model of practice that is effective, sustainable, and replicable.
 - Assist with transforming respondent organizations from a traditional setting to a recovery-oriented setting, if applicable. Assist with developing recovery capital and peer recovery infrastructure.
 - Work with organizations to increase collaboration between SUD treatment staff, mental health providers, and peer recovery coaches to improve participant outcomes. Ensure relationships are mutually respectful and supportive.
 - Ensure the organizations' policies and procedures are consistent with recovery processes.
 - Ensure peer recovery coaches have access to transportation, funds, flexible work schedules, organization-purchased cell phones, and other resources to

work with participants outside of the organizational setting and in local communities.

The goals, objectives, and deliverables are directly related to the performance measures that show the completed work's results, as discussed in the "Application and Submission Information" section.

following: budgeted project planning and/or implementation meetings with community stakeholders representing historically underserved and marginalized communities; outreach and/or public awareness campaigns specifically tailored to historically underserved and marginalized communities to encourage participation in the proposed project(s); budgeted incorporation of members representing historically underserved and marginalized communities in program evaluation, surveys, or other means of project feedback; and partnership with organizations that primarily serve communities that have been historically underserved, marginalized, and adversely affected by inequality.

B. Applicants that demonstrate that their capabilities and competencies for implementing their proposed project(s) are enhanced because they (or at least one proposed subrecipient that will receive **at least 40%** of the requested award funding, as demonstrated in the Budget Web-Based Form) identify as a *culturally specific organization*.

To receive this additional priority consideration, applicants must describe how being a culturally specific organization (or funding the culturally specific subrecipient organization(s)) will enhance their ability to implement the proposed project(s) and should also specify which populations are intended or expected to be served or to have their needs addressed under the proposed project(s).

Culturally specific organizations are defined for the purposes of this solicitation as private nonprofit or tribal organizations whose primary purpose as a whole is to provide culturally specific services to racial and ethnic groups, including, among others, Black people, Hispanic and Latino people, Native American and other Indigenous peoples of North America (including Alaska Native, Eskimo, and Aleut), Asian Americans, Native Hawaiians, and/or Pacific Islanders.

All recipients and subrecipients (including any for-profit organization) must forgo any profit or management fee.

1. Describe the strategy to address the needs identified in the statement of the problem.
2. Describe your project design, activities, and actions to be undertaken to fulfill the programs objectives and reach the program goals.
3. Provide a detailed description of the methods to be used to carry out each activity.
4. Provide a timetable indicating roughly when the activities or program milestones are to be accomplished.

If the applicant is seeking priority consideration for Priority 1(A), it should address

in this section how the proposed project(s) will promote racial equity and the removal of barriers to access and opportunity for communities that have been historically underserved, marginalized, and adversely affected by inequality, and identify how the project design and implementation will specifically incorporate the input or participation of these communities.

c. Capabilities and Competencies

1. Describe the organization and its capacity to successfully undertake this work, lead this project, and manage the subawards.
2. Determine a staffing plan that includes a project coordinator who will serve as the lead on this project.
3. Identify any anticipated challenges with system barriers, training gaps, resources, etc.
4. Identify key organizations and individuals that will help implement the project and describe the role of each. Please include resumes as attachments.

If the applicant is seeking priority consideration under Priority 1(B), it should describe within this section how being a culturally specific organization (or funding a culturally specific subrecipient organization at a minimum of 40% of the project budget) will enhance its ability to implement the proposed project(s), should also specify which populations are intended or expected to be served or have their needs addressed under the proposed project(s), and should include the website address (if applicable) and formal or informal mission statement or principles of the culturally specific organization.

d. Plan for Collecting the Data Required for this Solicitation's Performance Measures

Capabilities and Competencies (20%) - evaluate the applicant's administrative and technical capacity to successfully accomplish the goals and objectives.

Plan for Collecting the Data Required for this Solicitation's Performance Measures (10%) - evaluate the applicant's understanding of the performance data reporting requirements and the plan for collecting the required data.

Budget (10%) - evaluate for completeness, cost effectiveness, and allowability (e.g., reasonable, allocable, and necessary for project activities).

Other Review Criteria/Factors
