The [U.S. Department of Justice](#) (DOJ), [Office of Justice Programs](#) (OJP), Office for Victims of Crime (OVC) is seeking to provide training and technical assistance to enhance the organizational and programmatic capacity of organizations in American Indian and Alaska Native (AI/AN) communities to support victims of crime through a broad range of services. The program's purpose is aligned with both the DOJ strategic goal number three, to ensure the fair and efficient administration of justice, and OVC's mission, to enhance the Nation's capacity to assist crime victims by providing leadership in changing policies and practices to promote justice and healing for all victims of crime.

Under this solicitation, invited applicants will continue to assist communities with developing comprehensive victim services in AI/AN communities through the goals, objectives, and activities listed in the FY 2018 Tribal Set-Aside TTA Program solicitation. OVC may expand the scope of activities. Please refer to the OJP Invitation Letter for information about expanded activities.

Invited applicants should possess the capacity to deliver national-scope, high quality technical assistance and capacity building across tribes in the lower 48 and in Alaska. At a minimum, technical assistance should include:

1. Evaluating individual grantee needs and creating customized TTA and capacity building plans in coordination with individual grantees or OVC grant managers;
2. Preparing consistent and comprehensive technical assistance plans to address the capacity building and technical assistance needs of tribes and tribal-serving entities;
3. Delivering technical assistance and capacity building support to support tribal grantees' success in administering their OVC-funded victim services programs.
4. Supporting individual grantees in identifying and adopting program process evaluation measurements, goals, and collection methods, as requested by grantees; and
5. Creating resources and tools to support grantees in adapting and sustaining services for crime victims in response to a public crisis or emergency.

Pages should be numbered and submitted as an attachment. If the proposal narrative fails to comply with these length restrictions, OVC may negatively consider such noncompliance in final award decisions.

The following sections must be included as part of the proposal narrative:

- a. Description of the Issue OR Statement of the problem if research is involved
- b. Project Design and Implementation

Describe the detailed tasks and activities that will be completed during the 12-month award period that align with the project goals and objectives, including, where applicable, the enhancement of existing, or development of new, tasks and activities to meet the needs of rural and frontier tribal communities.

- c. Capabilities and Competencies

In addition to providing information about experience in delivering TTA and program support on crime victim's issues, applicants must demonstrate that they have the appropriate experience, knowledge, and credibility working with AI/AN communities; documented evidence of working with AI/AN communities; and letters of support from AI/AN communities.

- d. Plan for Collecting the Data Required for this Solicitation's Performance Measures

Note: applicants are **not** required to submit performance data with the application. Rather, performance measures information is included as an alert that successful applicants will be required to submit performance data as part of the reporting requirements under an award.
