Executive Summary

The U.S. Mission to the UAE invites proposals for initiatives in three program areas: (1) Celebrating the 250th anniversary of American independence in 2026, showcasing American excellence and the importance and breadth of the U.S.-UAE partnership through activities, events, collaborative projects, workshops, conferences, and/or performances across all seven emirates. (2) Expanding partnerships and cooperation in space exploration via space camps (in the United States and/or UAE), virtual hackathons, and joint research initiatives. (3) Leveraging the network of alumni from USG-funded entrepreneurship

programs such as Academy for Women Entrepreneurs (AWE) and Junior Achievement INJAZ UAE, to boost trade and investment opportunities with the United States. Possible activities include workshops, networking events, mentorship programs, pitch competitions, and/or an entrepreneurship summit. All proposals should include budgets covering travel, event costs, and engagement expenses, and outline a comprehensive monitoring and evaluation framework with regular reviews and data analysis.

B. Eligibility

1. Eligible Applicants

The following organizations are eligible to apply:

- *Not-for-profit organizations, including think tanks and civil society/non-governmental organizations*
- *Public and private educational institutions*

2. Cost Sharing or Matching

Permitted but not required. Applications that include cost sharing will not receive preferential consideration during the merit review process.

3. Other Eligibility Requirements

All organizations must have a Unique Entity Identifier (UEI) issued via SAM.gov as well as a valid registration on SAM.gov. Please see Section D.3 for more information.

Please note: Applicants are only allowed to submit one proposal per organization per program area. If more than one proposal per program area is submitted from an organization, all the proposals in that program area from that institution will be considered ineligible for funding.

C. Program Description

This Annual Program Statement outlines our funding priorities and the procedures for submitting requests for funding. Proposals must focus on the below program areas and clearly demonstrate how the proposed activities and engagements will help make America safer, stronger, and more prosperous.

1. Priority Program Areas:

○ **Celebrating the 250th Anniversary of American Independence in 2026**

Host events in 2026 showcasing American excellence, innovation, technology, dynamism, and/or unique and compelling aspects of American culture, as well as the importance and breadth of the U.S.-UAE partnership, at different locations across all seven emirates to celebrate America's 250th birthday. Key areas of focus

include frontier technologies (AI, space, cybersecurity), commercial partnerships (U.S. companies, UAE investment opportunities in the United States), and regional security initiatives. Proposals could include activities, events, collaborative projects, workshops, conferences, speaker series, and/or performances, either standalone or tied to appropriate UAE tradeshows, festivals, or public events. We would seek to ensure programming across all seven emirates over the course of the year. We are open to considering small proposals that focus on one or two specific emirates.

- **U.S. Leadership in Space Exploration and Collaboration**

Expand partnerships and cooperation in space exploration projects while showcasing U.S. leadership, technological advancements, and innovation. Possible activities or programming components include the following: space camps (in the United States and/or UAE), virtual hackathons focused on AI and sector-specific applications of space research/exploration, private sector engagement, workshops/seminars on space sciences and other relevant topics, and joint research initiatives between U.S. and UAE universities/entities. *Participants would be university students or young professionals from the United States and the UAE.*

- **Expanding Prosperity – Expanding USG-funded entrepreneurship programs to U.S. markets**

Leverage the network of alumni from USG-funded entrepreneurship programs, such as the Academy for Women Entrepreneurs (AWE) and Junior Achievement INJAZ UAE, to develop their trade acumen and create linkages to U.S. markets to boost trade and investment opportunities with the United States. Possible activities include workshops, networking events, mentorship programs, pitch competitions, and/or an entrepreneurship summit. *Participants include alumni from USG-funded entrepreneurship programs in the UAE and the region, as well as emerging entrepreneurs from the United States.*

Please note: All programs must include an American component, conveying an element of U.S. culture, history, excellence, innovation, and/or scientific and technological expertise. This must be a concrete element that establishes or strengthens ties between people in the UAE and the United States.

- Scientific research;
- Programs intended primarily for the growth or institutional development of the organization; or
- Programs that duplicate existing programs.

4. *Substantial Involvement*

These awards will be cooperative agreements with substantial involvement as pointed out below:

- Active collaboration with the recipient in the implementation of the award.
- Review and approval of one stage of work before another can begin.
- Involvement in the selection of participants or program venues.
- Specific programmatic oversight in the award, beyond normal monitoring.

D. Application Contents and Format

2. Summary Page (optional)

3. Proposal (10 pages maximum)

The proposal should contain sufficient information that anyone not familiar with it would understand exactly what the applicant wants to do. You may use your own proposal format, but it must include all the items below.

- Proposal Summary:** Short narrative that outlines the proposed project, including project objectives and anticipated impact.
- Introduction to the Organization or Individual applying:** A description of past and present operations, showing ability to carry out the program, including information on all previous grants from the U.S. Embassy and/or U.S. government agencies.
- Problem Statement:** Clear, concise and well-supported statement of the problem to be addressed and why the proposed program is needed
- Program Goals and Objectives:** The “goals” describe what the program is intended to achieve. The “objectives” refer to the intermediate accomplishments on the way to the goals. These should be achievable and measurable.

- v. **Project Activities:** Describe the program activities and how they will help achieve the objectives.
- vi. **Project Methods and Design:** A description of how the program is expected to work to solve the stated problem and achieve the goal. Include a logic model as appropriate.
- vii. **Proposed Project Schedule and Timeline:** The proposed timeline for the program activities. Include the dates, times, and locations of planned activities and events.
- viii. **Key Personnel:** Names, titles, roles and experience/qualifications of key personnel involved in the program. What proportion of their time will be used in support of this program?
- ix. **Project Partners:** List the names and type of involvement of key partner organizations and sub-awardees.
- x. **Project Monitoring and Evaluation Plan:** This is an important part of successful grants. Throughout the time-frame of the grant, how will the activities be monitored to ensure they are happening in a timely manner, and how will the program be evaluated to make sure it is meeting the goals of the grant?
- xi. **Future Funding or Sustainability:** Applicant's plan for continuing the program beyond the grant period, or the availability of other resources, if applicable.

1. Unique entity identifier and System for Award Management (SAM.gov)

Required Registrations

All organizations, whether based in the United States or in another country, must have a Unique Entity Identifier (UEI) and an active registration with the SAM.gov. A UEI is one of the data elements mandated by Public Law 109-282, the Federal Funding Accountability and Transparency Act (FFATA), for all Federal awards. An applicant must maintain an active registration while it has a proposal under review by the Department and must continue to keep the registration active for the entire duration of the period of performance of any Federal award that results from the NOFO.

The 2 CFR 200 requires that subrecipients obtain a UEI. Please note the UEI for subrecipients is not required at the time of application but will be required before an award is processed and/or directed to a subrecipient.

Note: The process of obtaining or renewing a SAM.gov registration may take anywhere from 4-8 weeks. Please begin your registration as early as possible.

- Organizations **based in the United States** or that pay employees within the United States will need an Employer Identification Number (EIN) from the Internal Revenue Service (IRS) and a UEI prior to registering in SAM.gov.
- Organizations **based outside of the United States** and that do not pay employees within the United States do not need an EIN from the IRS but do need a UEI prior to registering in SAM.gov.

Exemptions

An exemption from the UEI and SAM.gov registration requirements may be permitted on a case-by-case basis. See 2 CFR 25.110 for a full list of exemptions.

Organizations requesting exemption from UEI or SAM.gov requirements must email the point of contact listed in the NOFO at least two weeks prior to the deadline in the NOFO providing a justification of their request. Approval for a SAM.gov exemption must come from the warranted Grants Officer before the application can be deemed eligible for review.

2. Submission Dates and Times

Proposals will be accepted through **August 18, 2025, 5:00 P.M. UAE time.**

Applications may be submitted for consideration at any time before the closing date. No applications will be accepted after that date.

3. Funding Restrictions

- i. Funding Restrictions for the United Nations Relief and Works Agency (UNRWA)

None of the funds awarded resulting from this Notice of Funding Opportunity may be made available for subawards, direct financial support, or otherwise used to provide any payment or transfer to United Nations Relief and Works Agency (UNRWA).

- ii. Certification Regarding Compliance with applicable Federal anti-discrimination laws

None of the funds awarded under this agreement may be used for any initiatives or programs, or any activities that do not comply with Executive Order 14173 titled Ending Illegal Discrimination and Restoring Merit-Based Opportunity.

F. Application Review Information

1. Review Criteria

Each application will be evaluated and rated based on the evaluation criteria outlined below.

Quality and Feasibility of the Program Idea – 30 points: The program idea is well developed, with detail about how program activities will be carried out. The proposal includes a reasonable implementation timeline.

Organizational Capacity and Record on Previous Grants – 20 points: The organization has expertise in its stated field and has the internal controls in place to manage federal funds. This includes a financial management system and a bank account.

Program Planning/Ability to Achieve Objectives – 15 points: Goals and objectives are clearly stated and program approach is likely to provide maximum impact in achieving the proposed results.

Budget – 10 points: The budget justification is detailed. Costs are reasonable in relation to the proposed activities and anticipated results. The budget is realistic, accounting for all necessary expenses to achieve proposed activities.

Monitoring and evaluation plan – 15 points: Applicant demonstrates it is able to measure program success against key indicators and provides milestones to indicate progress toward goals outlined in the proposal. The program includes output and outcome indicators and shows how and when those will be measured.

Sustainability – 10 points: Program activities will continue to have positive impact after the end of the program.

2. Review and Selection Process

A review committee will evaluate all eligible applications

3. Risk Review

i. Risk factors

Under the merit review as required by 2 CFR § 200.206, prior to making a Federal Award the Department will review and consider the following risk factors:

- a. Financial stability
- b. Management systems and standards
- c. History of performance
- d. Audit reports and findings
- e. Ability to effectively implement requirements

G. Award Notices

The award or cooperative agreement will be written, signed, awarded, and administered by the Grants Officer. The award agreement is the authorizing document and it will be

provided to the recipient for review and signature by email. The recipient may only start incurring program expenses beginning on the start date shown on the grant award document signed by the Grants Officer.

If a proposal is selected for funding, the Department of State has no obligation to provide any additional future funding. Renewal of an award to increase funding or extend the period of performance is at the discretion of the Department of State.

Issuance of this NOFO does not constitute an award commitment on the part of the U.S. government, nor does it commit the U.S. government to pay for costs incurred in the preparation and submission of proposals. Further, the U.S. government reserves the right to reject any or all proposals received.

2. Reporting

Reporting Requirements: Recipients will be required to submit financial reports and program reports. The award document will specify what reports are required and how often these reports must be submitted.

Foreign Assistance Data Review: As required by Congress, the Department of State must make progress in its efforts to improve tracking and reporting of foreign assistance data through the Foreign Assistance Data Review (FADR). The FADR requires tracking of foreign assistance activity data from budgeting, planning, and allocation through obligation and disbursement. Successful applicants will be required to report and draw down federal funding based on the appropriate FADR Data Elements, indicated within their award documentation. In cases of more than one FADR Data Element, typically program or sector and/or regions or country, the successful applicant will be required to maintain separate accounting records.

Guidelines for Budget Justification

Personnel and Fringe Benefits: Describe the wages, salaries, and benefits of temporary or permanent staff who will be working directly for the applicant on the program, and the percentage of their time that will be spent on the program.

Travel: Estimate the costs of travel and per diem for this program, for program staff, consultants or speakers, and participants/beneficiaries. If the program involves international travel, include a brief statement of justification for that travel.

Equipment: Describe any machinery, furniture, or other personal property that is required for the program, which has a useful life of more than one year (or a life longer than the duration of the program), and costs at least \$10,000 per unit.

Supplies: List and describe all the items and materials, including any computer devices, that are needed for the program. If an item costs more than \$10,000 per unit, then put it in the budget under Equipment.

Contractual: Describe goods and services that the applicant plans to acquire through a contract with a vendor. Also describe any sub-awards to non-profit partners that will help carry out the program activities.

Other Direct Costs: Describe other costs directly associated with the program, which do not fit in the other categories. For example, shipping costs for materials and equipment or applicable taxes. All “Other” or “Miscellaneous” expenses must be itemized and explained.

Indirect Costs: These are costs that cannot be linked directly to the program activities, such as overhead costs needed to help keep the organization operating. If your organization has a Negotiated Indirect Cost Rate (NICRA) and includes NICRA charges in the budget, attach a copy of your latest NICRA. Organizations that have never had a NICRA may request indirect costs of 15% of Modified Total Direct Costs as defined in 2 CFR 200.1.

“Cost Sharing” refers to contributions from the organization or other entities other than the U.S. Embassy. It also includes in-kind contributions such as volunteers’ time and donated venues.

Alcoholic Beverages: Please note that award funds cannot be used for alcoholic beverages.
